# MANIFESTATION AND MOTION TO RESET INITIAL HEARING

Applicant ENERGY DEVELOPMENT CORPORATION ("EDC"), by and through the undersigned counsel, for and in behalf of Applicant DON ORESTES ROMUALDEZ ELECTRIC COOPERATIVE ("DORELCO"), unto this Honorable Commission, most respectfully states that:

1. On 22 February 2024, Applicant EDC received the Order and Notice of Virtual Hearing dated 14 February 2024 setting the instant *Joint Application* for hearing on the determination of compliance with the jurisdictional requirements and expository presentation on 14 March 2024 at nine o'clock in the morning (9:00 A.M.) and the pre-trial conference and presentation of evidence on 21 March 2024 at nine o'clock in the morning (9:00 A.M.)

2. In the said Order dated 14 February 2024, the Honorable Commission directed both EDC and DORELCO, among others, to cause the publication of the attached Notice of Virtual Hearing, to wit:

Unfortunately, based on the time needed to arrange for the publication as well as the internal approvals for the same, Applicants EDC and DORELCO would be unable to publish the Notice of Virtual Hearing: a) within two (2) successive weeks with the said publication not being less than seven (7) days apart; and b) the date of the last publication to be at least ten (10) days before the date of the initial hearing on 14 March 2024 as required by this Honorable Commission.
- 4. As such, Applicant EDC would be unable to faithfully comply with jurisdictional requirements as set forth in the Order dated 14 February 2024.
- 5. In view of the foregoing, Applicant EDC respectfully requests that the initial hearing on 14 March 2024 as well as the hearing on 21 March 2024 be cancelled and rescheduled on a later date at the soonest possible time.

#### **PRAYER**

WHEREFORE, Applicant EDC respectfully prays that the hearing on 14 March 2024 and 21 March 2024 be cancelled and the hearings be reset at the Honorable Commission's discretion.
