Respectfully returned to the Sangguniang Panlalawigan of Leyte, through the SP Secretary, the attached Ordinance No. 2023-19 of the Sangguniang of Bayan of Calubian, Leyte, with the following comments/recommendations;

- 1. That the ordinance seeks to rename the Villanueva Dalumpines Municipal Road into Vicente Mauricio Veloso Sr. Municipal Road in the Municipality of Calubian, Leyte;
- 2. That pursuant to Section 13 (c) of the Local Government Code;
 - (c) The sanggunians of component cities and municipalities may, in consultation with the Philippine Historical Commission, change the name of the following within its territorial jurisdiction:
 - (1) City and municipal barangays, upon recommendation of the sangguniang barangay concerned;
 - (2) City, municipal and barangay roads, avenues, boulevards, thoroughfares, and bridges;
 - (3) City and municipal public elementary, secondary and vocational or technical schools, post- secondary and other tertiary schools;
 - (4) City and municipal hospitals, health centers and other health facilities; and
 - (5) Any other public place or building owned by the municipal government.
- 3. Additionally, Section 13 (d) and (h) provides;

(d) None of the foregoing local government units, institutions, places, or buildings shall be named after a living person, nor may a change of name be made unless for a justifiable reason and, in any case, not oftener than once every ten (10) years. The name of a local government unit or a public place, street or structure with historical, cultural, or ethnic significance shall not be changed, unless by a unanimous vote of the sanggunian concerned and in consultation with the PHC.

(h) In any change of name, the Office of the President, the representative of the legislative district concerned, and the Bureau of Posts shall be notified.

4. Considering the foregoing, it is the opinion of this office that the consultation and recommendation of the NHCP (formerly PHC), be complied with in accordance with Section 13(c) and (d). In any case, the requisite provided for by Section 13 (h) should also be observed.

Furthermore, the opinions rendered herein are without prejudice to opinions rendered by higher authorities.

RENAMING THE " VILLANUEVA- DALUMPINES MUNICIPAL ROAD " INTO " VICENTE MAURICIO VELOSO, SR. MUNICIPAL ROAD " IN THE MUNICIPALITY OF CALUBIAN, LEYTE, IN RECOGNITION TO ONE DISTINGUISHED PERSON & A PUBLIC SERVANT OF THE PROVINCE OF LEYTE.

WHEREAS, the late Vicente Mauricio Veloso, Sr. was the father of the two Former Congressmen of the 3rd District of Leyte, namely: Alberto E. Veloso and Vicente Sofronio E. Veloso, III and likewise, the grandfather of the incumbent Congresswoman of 3^{rd} District of Leyte, Anna Victoria Veloso- Tuazon and Board Member Marie Kathryn Veloso- Kabigting & Former Vice Governor Edgar T. Veloso of the Province of Leyte;

WHEREAS, the Renaming of the "Villanueva- Dalumpines Mun. Road Network" is just one token of recognition of a famous person of the Province of Leyte, the Former Vice Governor Vicente Mauricio Veloso;

WHEREAS, Section 13 (c) of R.A. 7160 provides that xxx The Sanggunians of component cities and municipalities may, in consultation with the Philippine Historical Commission, change the name of the following, within its territorial jurisdiction: xxx (2) city, municipal and Barangay roads, avenues, boulevards, thorough fares, and bridges xxx:

NOW THEREFORE

BE IT ORDAINED, by the Sangguniang Bayan of Calubian, Leyte, in a session assembled that:

SECTION 1. Short Title. This Ordinance shall be entitled as "AN ORDINANCE RENAMING THE " VILLANUEVA- DALUMPINES MUNICIPAL ROAD " INTO " VICENTE MAURICIO VELOSO, SR. MUNICIPAL ROAD " IN THE MUNICIPALITY OF CALUBIAN, LEYTE, IN RECOGNITION TO ONE DISTINGUISHED PERSON & A PUBLIC SERVANT OF THE PROVINCE OF LEYTE".

SECTION 2. Rationale. A. Section 13 (c) of R.A. 7160 provides that xxx The Sanggunians of component cities and municipalities may, in consultation with the Philippine Historical Commission, change the name of the following, within its territorial jurisdiction: xxx (2) city, municipal and Barangay roads, avenues, boulevards, thorough fares, and bridges xxx;

- B. The Renaming of the "Villanueva-Dalumpines Municipal Road network is just one token of recognition of a famous person in the Province of Leyte, the late Vicente Mauricio Veloso, Sr. .
- C. Vicente Mauricio Veloso, Sr. who happened to be a native of Carmen, Cebu, became a Public Servant in the Province of Leyte, by serving as the Provincial Vice Governor of Leyte during the period_;
- D. The National Historical Commission of the Philippines (NHCP), formerly the Philippine Historical Commission, is responsible for the conservation and preservation of the country's historical legacies. NHCP is the primary government agency responsible for history and has the authority to determine all factual matters relating to official Philippine history.
- E. Public places under the jurisdiction of the local governments with the exception of barangays may be named or renamed by the local government unit concerned (e.g. a provincial road cannot be renamed by a municipal or city government).

SECTION 3. DEFINITION OF TERMS: For purposes of this ordinance, the following terms are defined as follows:

- A. Street name is an identifying name given to a street or road. In toponymic terminology, names of streets and roads are referred to odonyms or hodonyms. The street name usually forms part of the address.
- B. Road- an open way for vehicles, persons, and animals especially: one lying outside of an urban district. It is synonymous with HIGHWAY;
- C. Municipal Roads- roads built and established within the municipality or town. It means also as the roads which are under the control of the Municipality. It is defined likewise as roads or streets within the poblacion area of the municipality to be designated as such by the Sangguniang Bayan;
- D. Barangay Roads- are rural roads located either outside the urban area of a municipality or outside the industrial, commercial or residential subdivisions which act as feeder or farm to market roads, and which are not otherwise classified as national, provincial, city or municipal roads. Roads located outside the poblacion area of a municipality and those roads located outside the urban area of a city to be designated as such by the Sangguniang Barangay concerned.
- E. National Roads are those roads that form part of the main trunkline system continuous in extent; all roads leading to national airports, national seaports. National parks or coast to coast roads;
- F. Provincial Roads are those roads connecting one municipality to another; normally terminating at public paces; all roads extending from a municipality or from a provincial or national road to a public wharf or railway station; and any roads to be designated as such by the Sangguniang Panlalawigan.
- G. "Villanueva- Dalumpines Municipal Road" is a municipal road network connecting the coastal barangays of the municipality, starting from Brgy. Villanueva reaching until the coastal barangay of Brgy. Dalumpines. It is previously named as "Calubian-Jubay Municipal Road", as a part thereof.

SECTION 4. A. TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF CALUBIAN, LEYTE. A. The municipality of Calubian, Leyte, a 4^{th} class municipality is comprised for fifty-three (53) barangays (sub political units), namely:





SECTION 5. Renaming of the "Villanueva- Dalumpines Municipal Road" into "Vicente M. Veloso, Sr. Municipal Road".

SECTION 6. Posting & Announcement of the Renaming of the Municipal Road. The Municipal Engineer is hereby directed to post the corresponding renaming of municipal road and to effect the necessary change of such new roads name in the map of the Municipality of Calubian, Leyte.

SECTION 7. Submission of the copy of the ordinance to the National Historical Institute (NHI). A copy of this Ordinance shall be furnished to the National Historical Institute (NHI), Manila to form part of the historical records of the National Government.

SECTION 8. Separability Clause - If any provision of this Ordinance is declared invalid or unconstitutional, the remaining provision not affected thereby, shall continue to be in full force & effect.

SECTION 9. Repealing Clause. All ordinances or resolutions, local issuances or rules inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

SECTION 10 . Effectivity Clause . This ordinance shall take effect immediately upon review & approval of the Honorable Sangguniang Panlalawigan of Leyte & the National Historical Institute(NHI), Manila..
