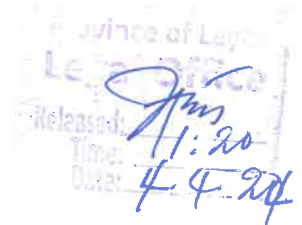

Respectfully returned to the Sangguniang Panlalawigan of Leyte, through the SP Secretary, the attached Ordinance No. 4, S.2024-2025 of the Sangguniang of Bayan of Villaba, Leyte, recommending for the declaration of its validity, pursuant to its power under Section 56 (C) of R.A. 7160, to the opinion of the Provincial Legal Office (PLO), an exercise of the power under Section 443 (c)(3)ⁱ and Section 76ⁱⁱ of the Local Government Code. Provided, that the budgeting limitations of Section 325 (b) and (c)ⁱⁱⁱ be followed.

Furthermore, the opinions rendered herein are without prejudice to opinions rendered by higher authorities.

ⁱ (c) The sangguniang bayan may:

(3) Consolidate the functions of any office with those of another in the interest of efficiency and economy.

ⁱⁱ **Section 76. Organizational Structure and Staffing Pattern.** - Every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission.

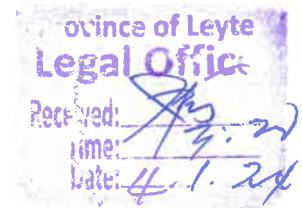
ⁱⁱⁱ (b) No official or employee shall be entitled to a salary rate higher than the maximum fixed for his position or other positions of equivalent rank by applicable laws or rules and regulations issued thereunder;

(c) No local fund shall be appropriated to increase or adjust salaries or wages of officials and employees of the national government, except as may be expressly authorized by law;

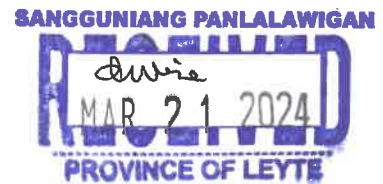

A RESOLUTION CRAFTING MUNICIPAL ORDINANCE NO. 04, S. 2024-2025

WHEREAS, Section 447, (a) (5) of the Local Government Code of 1991 (R.A. 7160) provides that the Sangguniang bayan shall approve ordinances that ensure the efficient and effective delivery of basis services and facilities as provided for in Section 17 of this code;

WHEREAS, Section 444, (b), (1) of the same code states that for x x x economical governance the purpose of which is the general welfare of the municipality and its inhabitants, the municipal mayor shall exercise thorough supervision and control over all programs, projects, services and activities of the municipal government;

WHEREAS, the Municipal Mayor, in this his letter dated February 7, 2024 addressed to the Sangguniang Bayan, requested the August Body to pass an ordinance for the transfer of Position Titles of employees specified therein from the Office of the Municipal Mayor to the office of the Municipal Social Welfare and Development,

NOW, THEREFORE, on the motion by the Hon. Rogelio J.Baay, chairman, SB Committee on Employment, duly seconded en masse, Be it,

RESOLVED, as it is hereby resolved, that the sanggunian shall craft a measure, as follows:













Be it ordained by the Sangguniang Bayan in regular session assembled, that:

Section 1. TITLE.- This enactment shall be known as “ An Ordinance Transferring the Position Titles of the following employees:

from the office of the Municipal Mayor to the office of the Municipal Social Welfare and Development in the LGU Plantilla of Personnel.

Section 2. LEGAL BASES.- The underlying principles for this ordinance are Section 444, (b), (1), Local Government Code of 1991 and CSC Memorandum Circular No. 5, Series of 2022.

Section 3. SOURCE OF FUND.- Funds are already available for these positions. These are merely transferred to the appropriate department where they belong for the exigency of their services.

Section 4. SEPARABILITY CLAUSE.- If for any reason or reasons, any part or provision of this ordinance shall be held unconstitutional or invalid, other parts hereof which are not affected thereby shall continue to be in full force and in effect.

Section 5. REPEALING CLAUSE.- Any ordinances, rules and regulations, executive orders and other issuances found inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.


Section 6. EFFECTIVITY.- This ordinance shall take effect upon approval and after this shall have been posted in three (3) conspicuous places in accordance with the posting requirement of the Local Government Code.

This Ordinance was approved by the Sangguniang Bayan in its Regular Session on February 19, 2024.
