### RESOLUTION NO. 2023-148

A RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR, ENGR. REINBERT C. COSTELO TO DONATE A PARCEL OF LAND OWNED BY THE LOCAL GOVERNMENT UNIT OF TUNGA, LOT NO. 460 WITH AN AREA OF 17,448 SQUARE METERS LOCATED AT BARANGAY BALIRE, TUNGA, LEYTE, TO THE PHILIPPINE NATIONAL POLICE TO BE UTILIZED AS THEIR REGIONAL TRAINING CENTER.

WHEREAS, the Sangguniang Bayan received a letter dated December 7, 2023 from the Honorable Mayor Reinbert C. Costelo requesting a resolution authorizing him to donate a parcel of land owned by the Local Government Unit of Tunga to the Philippine National Police to be utilized as a Regional Training Center;

WHEREAS, the LGU Tunga previously purchased a parcel of land, Lot No. 460 containing an area of 17,448 square meters located at Barangay Balire, Tunga, Leyte;

WHEREAS, the said lot will be donated to the Philippine National Police as the proposed site of the PNP Regional Training Center;

WHEREAS, this august body interposed no objection to the said donation, thus, authorizing the Municipal Mayor Reinbert C. Costelo to donate a parcel of land to the
