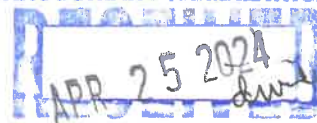

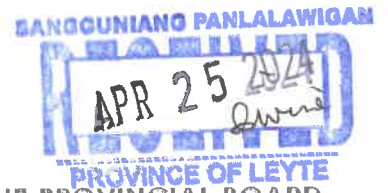

**WHEREAS**, the fishing industry plays a pivotal role in the economic and social fabric of our nation, contributing significantly to employment, commerce, and food security;
