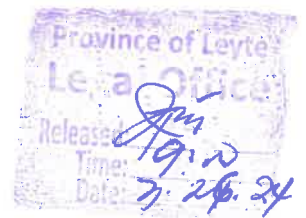


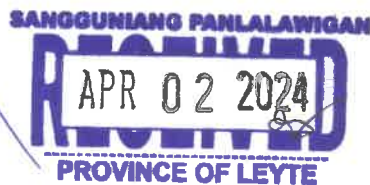

Furthermore, the opinions rendered herein are without prejudice to opinions rendered by higher authorities.

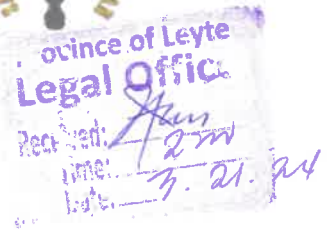

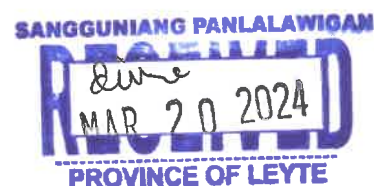

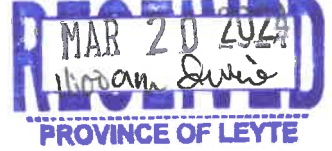

AN ORDINANCE AMENDING SECTION 2, ARTICLE 2 OF THE CITY ORDINANCE NO. 19, SERIES 2017 "AN ORDINANCE FIXING THE VIEWING FEES OF 16K BLOSSOMS IN LINTAON PEAK AND REGULATING ITS USE/VIEW AND OTHER PURPOSES."

BE IT ORDAINED, by the 6th Sangguniang Panlungsod, City of Baybay in its 10th Regular Session assembled on March 7, 2024, as hereby adopted, to wit;

Article I. Title

AN ORDINANCE AMENDING SECTION 2, ARTICLE II OF CITY ORDINANCE NO. 19, SERIES 2017 "AN ORDINANCE FIXING AND USE THE VIEWING FEES OF 16K BLOSSOMS IN LINTAON PEAK AND REGULATING ITS USE/VIEW AND OTHER PURPOSES."

Article II. Fees is hereby amended as follows:

There shall be collected from the viewing public who shall personally view and see the "16K Blossoms" at the provided area for viewing the following fees:

Exempted from the aforementioned fees are PWD's and Senior Citizens who are bona fide residents of Baybay. However, companions of the latter should pay the aforementioned entrance fee.

4. Additional payment for electricity when using the venue up to nighttime (6 pm-5 am) shall be charged.

The City Tourism Office shall formulate guidelines as to the number of people and minutes per viewing which shall be announced to the viewing public.

Article III. Separability Clause

The provisions of this Ordinance are hereby declared separable and if any provision shall be held invalid, or unconstitutional, the remaining provisions hereof are not affected and shall remain valid effective.

Article III. Repealing Clause

An ordinances, resolutions, rules and regulations inconsistent with or contrary to the provisions of this ordinance are hereby repealed, amended or modified accordingly.


Article IV. Effectivity Clause

This Ordinance shall take effect 15 days upon its publication or after due compliance with all the requirements provided under R.A. 7160, otherwise known as the Local Government Code of 1991.

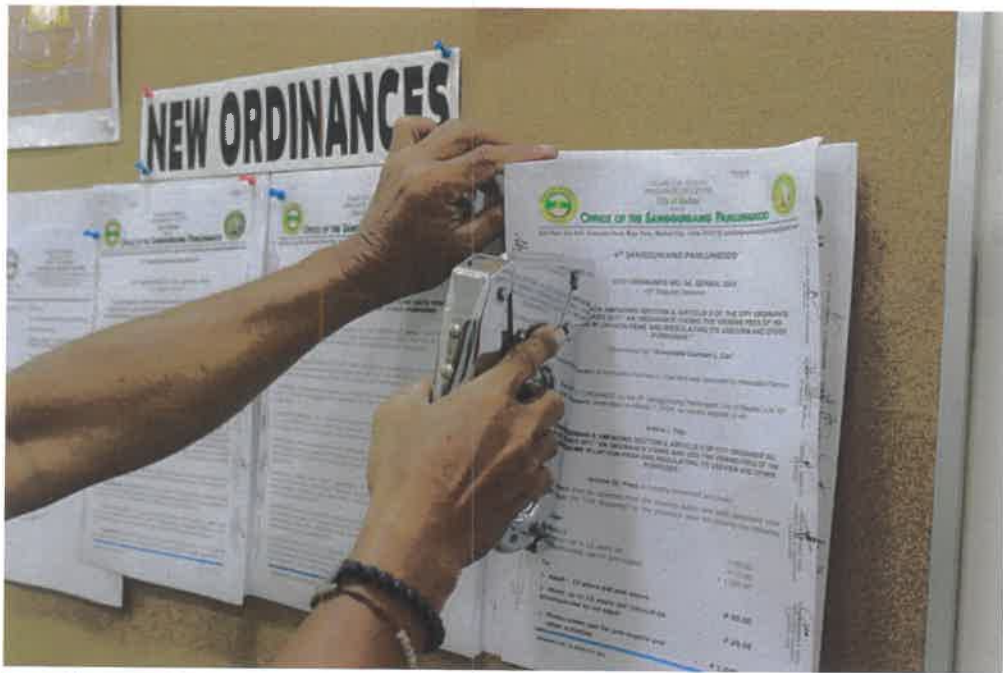

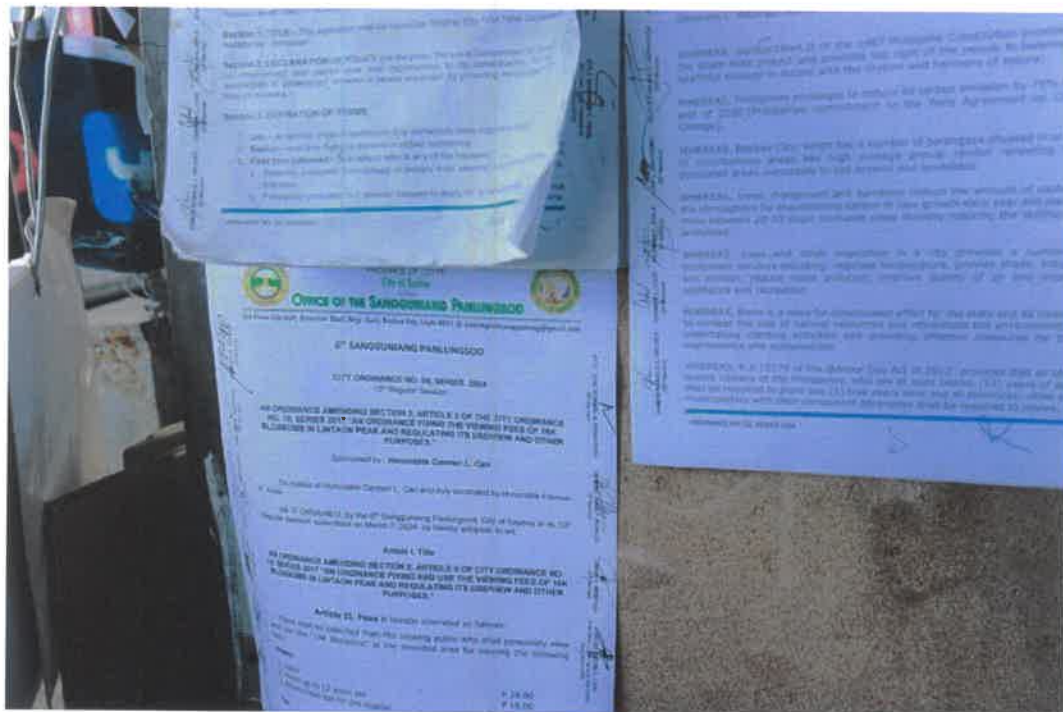
