384 Agenda Item No. 08 is Ordinance no. 2023-19. An Ordinance renaming the Villanueva-
385 Dalumpines Municipal Road into Vicente Mauricio Veloso, Sr. Municipal Road in the
386 Municipality of Calubian, Leyte, in recognition to one distinguished person & a public servant
387 of the Province of Leyte, as per the opinion of the Provincial Legal Office, for renaming of
388 roads, this requires a consultation with the PHC as per Section 13 (c) of the Local Code
389 given that they did not attached a recommendation from the NHCP. The PHC now is the
390 National Historic Commission of the Philippines.
