## COMMITTEE ON TOURISM, TRADE AND INTERNATIONAL RELATIONS

Committee Report No. 06, S. 2024

This refers to the proposed provincial ordinance entitled "AN ORDINANCE LEVYING RENTAL FEES AND CHARGES FOR TOURISM FACILITIES AND EQUIPMENT OWNED BY THE LEYTE PROVINCIAL GOVERNMENT".

During the committee meeting, clarifications and suggestions were made which are now provided for in the attached draft ordinance<sup>1</sup>. The committee finds that the measure is timely and absolutely needed to be passed to raise funds to maintain, improve, and expand the Tourism Facilities and Equipment of the Leyte Provincial Government as mentioned in the proposed ordinance.

The committee also find no provision in the said proposed measure that contravenes the Constitution and other existing laws and that the same is compliant to the general limitations of legislation, that:

- a. It does not contravene the Constitution;
- b. It is not unfair or oppressive:
- c. It is not partial or discriminatory:
- d. It does not prohibit trade;
- e. It is general and consistent with public policy; and
- f. It is not unreasonable.

In view thereof, this committee hereby recommends for the passage of the said ordinance and resolve that the same be scheduled for second reading, subject to the provisions of Section 129<sup>2</sup> and 186<sup>3</sup> in relation to sections 187<sup>4</sup> and 188<sup>5</sup> of Republic Act 7190 otherwise known as the Local Government Code of 1991.

| <b>WHEREAS</b> , Section 129 of Republic Act 7160 otherwise known as the Local Government Code of 1991 empowers Local Government Units (LGUs) like the Leyte Provincial Government to create its own sources of revenue, to wit:   |
| "Section 129. Power to Create Sources of Revenue. – Each local government unit shall exercise its power to create its own sources of revenue and to levy taxes, fees, and charges subject to the provision herein, consistent with the basic policy of local autonomy. Such taxes, fees, and charges shall accrue exclusively to local government units."; |
| <b>WHEREAS</b> , the enactment of this Ordinance is very timely and absolutely needed to promote the tourism industry in the Province of Leyte;  |
| <b>WHEREAS</b> , it is vital to raise funds to maintain, improve, and expand the tourism facilities and equipment owned by the Leyte Provincial Government;  |

## AN ORDINANCE LEVYING RENTAL FEES AND CHARGES FOR TOURISM FACILITIES AND EQUIPMENT OWNED BY THE LEYTE PROVINCIAL GOVERNMENT

Be it ordained by the Sangguniang Panlalawigan of Leyte, that:

**Section 1. Title.** This ordinance shall be known and cited as "An Ordinance Levying Rental Fee and Charges for the Tourism Facilities and Equipment Owned by the Leyte Provincial Government".

**Section 2. Scope.** The rental fees and charges imposed in this ordinance shall apply to those tourism facilities and equipment owned by the Leyte Provincial Government exclusively for tourism promotion.

**Section 3. Definition.** As used in this Ordinance:

- a. **Equipment** refers to the self-balancing scooters used for the Leyte Segway Tour.
- b. **Kiosks** refers to the 24 units 3m x 3m concrete Barbecue "BBQ" Kiosks located at the MacArthur Park Riverside.
- c. Power refers to the supply of electricity used to energize the tourism facilities.
- d. Stall refers to the 8 2x2m stalls located at the Leyte Pasalubong Center.
- e. **Tourism Facilities** refers to permanent structures owned by the Leyte Provincial Government like the Tourism Building and View Deck, Leyte Pasalubong Center, and the MacArthur Park Riverside Kiosks.

**Section 4. Fees and Charges.** The following schedule of fees and charges for the use of the Leyte Provincial Government Tourism Facilities and Equipment shall be imposed as follows:

## a. Tourism Building and View Deck Exhibit Hall

Area: 126.4 sqm

Capacity: 60 persons

Rental: Php 8,500.00 per 8hour event inclusive of electricity & water; additional

charge for lights & sound, and other appliances.

## b. Tourism Building and View Deck Roof Deck Area

Area: 542.94 sqm

Rental: Php 14,500.00 per 8hour event inclusive of electricity, lights only;

additional charge for lights & sound, and other appliances.

## c. MacArthur Park Riverside Kiosks

Area: 3x3 sqm

Rental: Php 2,000.00 per month excluding electricity & water; each kiosk will

be installed with electric and water submeters.

## d. Leyte Pasalubong Center

Area: 2x2 sam stalls

Rental: Php 2,000.00 per month.

## e. Leyte Segway Tours at the Leyte Provincial Government Complex

Rental: Php 400.00 per 1 hour tour with tour guide.

**Section 5. Official Receipts and Permits.** Any use of the above Leyte Provincial Government Tourism Facilities and Equipment shall be covered by a Permit, which shall be issued by the Provincial Governor or his/her authorized representative. Any payment for the rental of said facilities shall be properly receipted by the Provincial Treasurer or his/her authorized representative.

**Section 6. Contract of Lease.** All tourism facilities rentals shall be covered by a lease contract. The terms and conditions of which shall be determined by the Office of the Provincial Governor subject to ratification of the Sangguniang Panlalawigan.

**Section 7. Tour Safety Agreement.** All Leyte Segway Tours shall be covered by a Tour Safety Agreement between the Leyte Tourism and Investment Promotion Center (LTIPC) and the client.

**Section 8. Exception.** The Fees and Charges shall not be imposed if subject facilities and equipment shall be used by the Leyte Provincial Government. Any other user, especially LGUs, accredited NGOs, Peoples' Organizations, and Civil Society Organizations maybe given a discount for exempted from payment of fees and charges at the discretion of the Provincial Governor.

Section 9. Reporting and Monitoring. The Leyte Tourism and Investment Promotion Center (LTIPC) shall lead and oversee the regular monitoring and evaluation of the implementation of this Ordinance. It may designate other relevant office/s or individuals to carry out monitoring, maintenance, and improvement activities in the various tourism facilities and equipment provided that all data gathered shall be submitted to and consolidated by the Leyte Tourism Investment and Promotion Center (LTIPC) for regular reporting to the Provincial Governor. These data shall also be used to decide on necessary actions, such as adjusting or modifying existing set of contracts or agreements, redesigning, or installing building improvements or repairs, and the frequency of such activities.

Section 10. Implementing Rules and Regulations (IRR). The Provincial Governor may issue appropriate and relevant rules and regulations, as necessary for the proper implementation of any and all provisions of this Ordinance.

Section 11. Penal Provision. Violation of Section 4 of this Ordinance shall be ground for revocation of the permit or contract without prejudice to other remedies provided by law.

Section 12. Separability Clause. If any provision of this Ordinance is held invalid or unconstitutional, the other provisions not affected thereby shall remain valid and enforceable.

Section 13. Repealing Clause. Any provincial ordinance, resolution, rules and regulations, or parts thereof, in conflict with or inconsistent with any of the provisions of this Ordinance are hereby amended, modified, or repealed accordingly.

Section 14. Effectivity Clause. This Ordinance shall take effect after publication in the newspaper of general circulation in the Province of Leyte.

- 5. The LESSEE shall not sell or transfer, his/her privilege to occupy the aforesaid stall nor sub-lease the subject stall to another person, natural or juridical;
- 6. The LESSEE shall not utilize the aforesaid stall/ kiosk or any part thereof for residential purposes;
- 7. The LESSEE shall not allow anybody to serve or to dispense liquor, wine, or any kind of intoxicating beverages inside or in the surrounding premises of the said stall/ kiosk.
- 8. The LESSEE shall not remove, construct or alter the original structure of the stall/kiosk, electrical wiring or water connection without prior permit from the LESSOR or its authorized representative.
- 9. The LESSEE undertakes to commence the operation of his business within days from signing of this contract. Otherwise, the kiosk/ stall shall be declared vacant and the same may be a ground for the termination of the lease contract.

## MUTUAL UNDERSTANDING

- 1. Nothing in this Contract shall be construed as an exemption from securing the corresponding Mayor's Permit for the operation of the business in the subject stall/ kiosk, and any other permits as may be required by the government as a condition for its continued operation.
- 2. If, for any reason, the LESSEE discontinues his/her business, or this Contract is revoked before its expiration, the said stall/ kiosk shall be considered vacant and may be awarded to other interested LESSEES.
- 3. Should the LESSEE enter into a business partnership with any party during the duration of this Contract, the LESSEE shall have no authority to transfer to his/her partner the right to occupy and operate the subject stall.
- 4. Upon expiration of this Contract of Lease, it may be renewed with the LESSEE having the first option to lease the subject stall/ kiosk, provided, however, that the LESSEE complied with all the stipulations contained in this Contract and did not violate any existing ordinance, rules and regulations on the operation of business, and provided further that the LESSEE has no outstanding balance.
- 5. LESSEE in good standing or one who religiously pays its monthly rental fee with no record of a late or non-payment thereof, as certified by the Provincial Treasurer, the lease shall, upon its expiration, be automatically renewed with a new lease contract for another term of one (1) year.
- 6. Upon the death of the holder of a stall/ kiosk, the contract of lease covering said stall/ kiosk shall be deemed terminated. However, if the deceased leaves a surviving spouse or legal heirs who are qualified, and who desire to continue the business of the deceased, the lease may be transferred to the deceased's spouse or legal heirs upon application therefor; provided that the LESSOR shall be notified within thirty (30) days after the death of the original lessee of the desire of the spouse or legal heirs to succeed and upon payment of all necessary rents or lease due at the time of death of the original lessee, otherwise right shall be deemed waived.

- 7. The LESSOR shall not be responsible for any loss of, or damage to, properties of the LESSEE kept inside the subject stall/ kiosk, which is caused by fire, theft, robbery, force majeure, or any unavoidable circumstances beyond the control of the LESSOR.
- 8. The LESSOR and the LESSEE hereby agree that parties are bound to adhere to any changes or adjustments in rates, fees, or taxes as may be fixed by applicable Ordinance.

## **DURATION AND REVOCATION**

The Contract of Lease shall be for a period of one (1) year renewable upon its expiration, unless sooner revoked thru mutual agreement of both parties, or unilaterally:

- a. By the LESSEE if he decides to discontinue the operation of his business and voluntarily vacating the subject stall upon prior notice to the LESSOR.
- b. By the LESSOR if the LESSEE violated any of the terms stipulated in this Contract or violated provisions of this Code or Provincial ordinances, rules and regulations in the operation of business.

#### WITNESSETH

1. PURPOSE OF AGREEMENT: This Agreement outlines the terms and conditions under which hand-da, baga agrees to act as a locator at the Leyte Pasalubong Center.

#### 2. LOCATOR REQUIREMENTS:

- 2.1 Locator should be the actual producer.
- 2.2 Locator should submit the following documentary requirements:
  - Mayor's Permit, DTI Permit, Official Receipt and 1 (one) Government Issued ID of the owner.

## 3. LOCATOR RESPONSIBILITIES:

- 3.1. Locator agrees to display and promote his her company's products in a stall at the Leyte Pasalubong Center.
- 3.2 Locator will maintain an adequate inventory of their products and ensure that the display is well-maintained and attractive.
- 3.3 Locator will provide LTIPC with daily sales reports for sales monitoring. Forms will be provided by the management.
- 3.4 Locator shall assign 1 or 2 staff to man the stall for selling and inquiries during business hours.
- 3.5 Locator shall observe proper solid waste management for garbage. Garbage bins will be provided by management.
- 3.6 Locator shall commit to sell their products at the Leyte Pasalubong Center from Tuesdays to Sundays 9am to 7pm.

- 3.7 Locator shall be responsible for the care security of their own products within their respective stall
- 3.8 Locator should keep their stall and its surrounding area neat and clean in accordance with management standards.

## 4. MANAGEMENT RESPONSIBILITIES:

- 4.1. Management will provide the stall with one (1) stall (size is 2 × 2 meters) with table and 1 chair, including signage, to enhance the visibility of the Pasalubong Center products.
- 4.2 Management will provide general cleaners within the vicinity of the Leyte Pasalubong Center before and after opening hours.
- 4.3 Management shall provide one (1) security guard for the Levte Pasalubong Center.
- 4.4 Management shall provide one (1) Manager to oversee and monitor the smooth operations of the Leyte Pasalubong Center.

#### 5. PROCEDURE:

- 5.1 Locator will reserve 6 days in a week to operate at the Pasalubong Center.
- 5.2 The Pasalubong Center shall be open from Tuesday to Sunday. 9:00am to 7:00pm.
- 5.3 Pull out of inventory will be every Monday morning from 8:00 to 12:00 noon. Set up of inventory will be at 1:00 to 5:00 o'clock in the afternoon.
- 5.2 Locator will submit their request to locate every Thursday starting at 9am to 5pm. Acceptance of request will be on a first come. first serve basis

## 6. STALL RENTAL / MAINTENANCE:

- 6.1. Rental shall be free up to February 3, 2024. Thereafter, an amount of P500 / week shall be paid upon submission of the request to locate for maintenance and utilities.
- DURATION OF AGREEMENT: This Agreement shall commence on December 8, 2023 and shall remain in officer until February 3, 2024.
- 8. TERMINATION: Either party may terminate this Agreement with or without cause by providing written notice to the other party.
- CONFIDENTIALITY: Both parties agree to keep confidential all non-public information obtained during the course of this Agreement.

10. GOVERNING LAW: This Agreement shall be governed by and construed in accordance with the laws of the Philippines.
