Section 4. The MacArthur, Leyte Hymn composed by Raymunda F. Roa and Ryan Roa shall be the official hymn of the Municipality of MacArthur, Leyte.

Section 5. Requiring all Barangays, government offices and all educational institutions situated within the territorial and political jurisdiction of the Municipality of MacArthur, Leyte to sing the MacArthur Hymn as part of the flag ceremony and other activities.


Section 6. COVERAGE. - This ordinance shall be applicable in all barangays, government offices, and all educational institutions situated within the territorial and political jurisdiction of the Municipality of MacArthur, Leyte.


Section 7. INCORPORATION OF THE MACARTHUR HYMN AS AN INTEGRAL PART OF THE FLAG RAISING CEREMONY. - The waray-waray version of the MacArthur Hymn, which is owned by the municipal government shall form part of the flag raising ceremony and other activities in all barangays, government offices, and all educational institutions situated within the territorial and political jurisdiction of the Municipality of MacArthur, Leyte



Discretion is left to the barangays, other government entities, and school concerned as to which part of the ceremony the singing of the MacArthur Hymn will be inserted for as long as it will be sung by heart in accordance with its lyrics and music and for the purpose it is composed.

Nothing in the lyrics and music of the hymn shall be modified and singing of the same shall only be in accordance to its original composition. The artist singing the hymn shall not be limited to one artist and may be sung by multiple artists.

**Section 8. DUTY OF BARANGAYS, OTHER GOVERNMENT ENTITIES, AND EDUCATIONAL INSTITUTIONS** - It shall be the duty of all barangays, other government entities, and all educational institutions within the territorial and political jurisdiction of the Municipality of MacArthur, Leyte to conscientiously implement the mandate of this ordinance and to retrieve for their effective use the digital audio copy of the waray-waray version of the MacArthur Hymn from the municipal government.

**Section 9.** The copies of this Ordinance be furnished to the Office of the Municipal Mayor, the thirty (31) Punong Barangays, all concerned Municipal Heads of Office, the School Heads of all public and private elementary and secondary schools in the Municipality of MacArthur, the MGOO, DILG - MacArthur, all National Government Agencies in MacArthur, Leyte for their information and guidance.


**Section 10. PENALTY.** In the event that the mandate of this Ordinance is not complied with, an administrative fine of ONE THOUSAND (PHP1,000.00) PESOS shall be meted out against the educational institution or government office concerned or at least its head of office.

**Section 11. Separability Clause** - If any part or provision of this Ordinance shall be declared unconstitutional or unlawful by the court, or suspended or revoked by competent authorities, all other provisions not otherwise affected thereby shall remain valid and effective.

**Section 12. Repealing Clause** - Any ordinances, executive orders, proclamations and administrative regulations, or parts thereof, which are contrary or inconsistent with any of the provisions of this Ordinance, are hereby repealed, amended or modified accordingly.

**Section 13. Effectivity Clause** - This Ordinance shall take effect after its approval and the requirement of posting prescribed in R.A. 7160 is complied with.
