Gentlemen and Ladies:

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the **General Fund Supplemental Budget No. 01 FY 2024** of the **Municipality Burauen**, **Leyte** duly enacted by the Sangguniang Bayan through **Appropriation Ordinance No. 2024-02** with a total appropriation in the amount of **P44,341,937.67** reveals compliance with the same law and its implementing Rules and Regulations.

It is therefore recommended for approval subject to the following conditions:

- That the procurement of Goods, Supplies, Equipment, Civil Works and other related services shall be made in accordance with the provisions of RA 9184 and its Implementing Rules and Regulations;
- 2. That the creation and funding of the mandatory positions required under MC No.12 shall be in accordance with existing guidelines on the salary implementation of the LGU;
- 3. That the grant of Clothing Allowance shall be pursuant to Budget Circular No. 2021-01 dated April 4, 2024;
- 4. That the allocation of the 5% Local Disaster Risk Reduction and Management Fund (LDRRMIF) shall have a listing of expenditures in accordance with the COA Chart of Accounts emphasizing the thematic areas;
- 5. That the procurement of Motor Vehicles under Capital Outlay shall be made pursuant to the guidelines on the requisition and use of Government Vehicles under Budget Circular No. 2019-3 dated May 16, 2019;
- 6. That the appropriation for RA and TA adjustment for government personnel shall be deferred and shall not be disbursed until an issuance of its legal basis has been issued;
- 7. That disbursement of funds shall be for the specific purpose(s) for which they have been appropriated pursuant to Sections 335 & 336 of RA 7160.

Compliance with DBM issuances, and all other accounting and auditing rules and regulations shall be the responsibility of the implementing Local Government Unit.

SECTION 5 - Effectivity. The provisions of this ordinance shall take effect upon approval.
