WHEREAS, the Sangguniang Bayan passed and approved Ordinance No. 7, Series of 2023 dated May 30, 2023, entitled, AN ORDINANCE CREATING THE FOLLOWING PLANTILLA POSITIONS:

- 1. MUNICIPAL GOVERNMENT DEPARTMENT HEAD I (LDRRMO V) (SG 24) UNDER THE MDRRMO;
- 2. NUTRITION OFFICER I (SG 10);
- 3. SR. ADMINISTRATIVE ASSISTANT I (BUYER III) (SG 13);
- 4. VETERINARIAN III (SG 19);
- 5. INFORMATION SYSTEM ANALYST II (SG 16);

WHEREAS, Section 76 of Republic Act 7160 states that "Every Local Government Unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirement and financial capability";

WHEREAS, the position title is in accordance with NDRRMC-DILG-DBM-CSC Joint Memorandum Circular No. 2014-1 dated April 4, 2014, "Implementing Guidelines for the Establishment of Local DRRM Offices (LDRRMOs) or Barangay DRRM Committees (BDRRMCs) in Local Government Units";

BE IT ORDAINED, as it is hereby ordained by the Sangguniang Bayan of Capoocan, Leyte in session assembled that:

Section 1. THE PLANTILLA POSITION OF THE MUNICIPAL GOVERNMENT DEPARTMENT HEAD I (LDRRMO V) SALARY GRADE 24 UNDER THE MUNICIPAL DISASTER RISK REDUCTION MANAGEMENT OFFICE is hereby rectified to MUNICIPAL GOVERNMENT DEPARTMENT HEAD I (LOCAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE) SALARY GRADE 24 UNDER THE MUNICIPAL DISASTER RISK REDUCTION MANAGEMENT OFFICE.

Section 2. Separability Clause. If any provision of this Ordinance is declared invalid, the remainder or any provision hereof not affected thereby shall remain in force and effect.

Section 3. Repealing Clause. Any ordinance found inconsistent hereof, in whole or in part, is hereby repealed or modified accordingly.

Section 4. Effectivity. This ordinance shall take effect immediately upon approval.
