**A RESOLUTION RETURNING TO THE SANGGUNIANG BAYAN OF ORIGIN MUNICIPAL ORDINANCE NOS. 2023-18 AND 2023-19 OF JULITA, LEYTE FOR PROPER CORRECTION.**

**WHEREAS**, submitted to the Sangguniang Panlalawigan are the following Ordinances from Julita, Leyte, to wit:

- 1. Municipal Ordinance No. 2023-18, entitled: "AN ORDINANCE INSTITUTIONALIZING THE GRANT OF CASH INCENTIVES TO INDIVIDUALS OR GROUPS WHO EXCELLED IN SPORTS AND ACADEMIC COMPETITIONS IN THE MUNICIPALITY OF JULITA, LEYTE, APPROPRIATING FUNDS AND PROVIDING GUIDELINES THEREOF";**
- 2. Municipal Ordinance No. 2023-19, entitled: "AN ORDINANCE INSTITUTIONALIZING THE ACADEMIC EXCELLENCE AWARDS PROGRAM OF THE MUNICIPALITY OF JULITA, LEYTE, APPROPRIATING FUNDS AND PROVIDING GUIDELINES THEREOF, AND FOR OTHER PURPOSES";**

**WHEREAS**, the Provincial Legal Office was requested to review and submit recommendation on the subject Ordinances pursuant to Section 481 (3) (vii) of R.A. 7160;

**WHEREAS**, the Provincial Legal Office rendered similar comments/opinions on both **Municipal Ordinance Nos. 2023-18** and **2023-19** to wit:

1. That Ordinance No. 2023-18 intends to grant "Cash Incentives" to individuals or groups who excelled in sports and academic competitions;
2. That pursuant to the 4<sup>th</sup> "whereas" of subject Ordinance as is, such legislative act shall further inspire the athletes to continue to improve in order to reach their dreams and aspirations to help uplift their families and the community and serve as a guide to success for others taking the same path;

3. That pursuant thereto, Section 8 (source of fund), of subject Ordinance, the budget shall be allocated in the Annual Budget, an indication that the fund to be used will be coming from the government coffers;
4. That the enactment of subject Ordinance is indeed laudable, as it will give inspiration to graduates as indicated in the 4<sup>th</sup> "whereas" of subject Ordinance;
5. That on the other hand, Section 335, chapter 4 of Local Government Code states;

"Section 335, Chapter 4 – No public money or property shall be appropriated or applied for religious or private purposes"

6. That in view thereof, the Provincial Legal office is of the opinion that a review be made on the subject of where the funds are to be sourced regarding Section 7 of the Ordinance to ensure that the same does not run contrary to the mandate of Section 335 Chapter 4 of the Code.

**WHEREAS**, on **Ordinance No. 2023-19**, the Provincial Legal Office opined to wit:

1. That pursuant to the 4<sup>th</sup> "whereas" of subject Ordinance, the same intends to provide rewards and incentives to children and youth in order to inspire them towards a path of achieving academic excellence etc.;
2. That the Ordinance provides for the allocation of the fund to be used as cash incentives for these children and youth recognition of the Academic Excellence that they achieved;
3. That pursuant to Section 7 of the Ordinance, the budget shall be allocated in the Annual Budget of the LGU concerned, which means the same shall be taken from the LGU fund, a Government fund;
4. That worthy of note is the provision of Section 335, Chapter 4 of Code, quoted for reference;

"Section 335, Chapter 4 – No public money or property shall be appropriated or applied for religious or private purposes"

5. That in view thereof, the Provincial Legal office is of the opinion that a review be made on the subject of where the funds are to be sourced regarding Section 7 of the Ordinance to ensure that the same does not run contrary to the mandate of Section 335 Chapter 4 of the Code.

**WHEREAS**, the August Body, deemed it proper, to return said Ordinances for proper correction;

**NOW, THEREFORE**, on omnibus motion presented by Honorable Raissa J. Villasin, duly seconded by Honorable Ma. Corazon E. Remandaban, be it

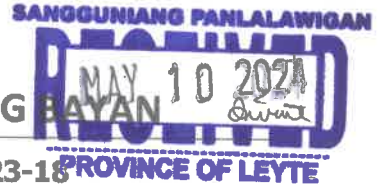

**EXPLANATORY NOTE**

**WHEREAS**, further, Paragraph 19 of Section 2, Article 14, of the 1987 Philippine Constitution provides that the State shall promote physical education and encourage sports programs, league competitions, and amateur sports, including training for international competitions, to foster self-discipline, teamwork, and excellence for the development of a healthy and alert citizenry;

**WHEREAS**, The Philippine Government has adopted a policy of giving incentives to athletes who are winners or medalists in legitimate international and local sports competitions pursuant to R.A. 9064 or the National Athletes, Coaches and Trainers Benefits and Incentives Act of 2001;

**WHEREAS**, the Local Government Unit of Julita, Leyte recognizes the pride and honor that winners of sports, skills and academic competitions bring to the Municipality that shall serve as an inspiration and a good role model to the citizens of this municipality, especially to the youth;

**WHEREAS**, such incentive program shall further inspire the athletes to continue to improve in order to reach their dreams and aspirations to help uplift their own families and the community and serve as a guide to success for others taking the same path;

**NOW THEREFORE**, on motion of the **Hon. Mark Joy E. Macaso**, duly seconded by the **Hon. Aliana Marie R. Tubi and the Hon. Rosila L. Advincula**;

BE IT ENACTED by the Sangguniang Bayan of Julita, Leyte, in session duly assembled, that:

**SECTION 1. Title.** This Municipal Ordinance shall be known as "*An Ordinance Institutionalizing the Grant of Cash Incentives to Individuals or Groups Who Excelled in Sports and Academic Competitions in the Municipality of Julita, Appropriating Funds and Providing Guidelines Thereof*"

**SECTION 2. Declaration of Policy.** It is hereby declared a policy of the Municipality of Julita, Leyte to grant financial incentives to deserving individuals for having given honor to this municipality in various legitimate competitions in the fields of sports and academics competitions. This program shall be known as the Julita Sports and Academic Competitions Awards Program.

**SECTION 3. Definition of Terms.**

- a. Sports Competitions - refer to various sports competitions in the local, national, international or worldwide levels and are duly organized,






accredited or sanctioned by government agencies for competitions conducted within the country. Participation in International and Worldwide competitions must have been permitted and/or authorized by the concerned national government agency


- b. Academic Competitions - refer to the academic related competitions in the local, national, international or worldwide levels and are duly organized by national government agencies for competitions conducted within the country. Participation in International and Worldwide competitions must have been permitted and/or authorized by the concerned national government agency.
- c. Government agencies – Local government agencies or units such as a Municipal Government, Provincial Government, etc. National government agencies such as the Department of Education, Philippine Olympic Committee, Philippine Sports Competition, Department of the Interior and Local Government, Commission on Higher Education, etc.
- d. International Competition – a competition that is participated by other nations and are sanctioned by an international sanctioning body, example the International Olympic Committee. It can be held in other countries or can be hosted in the Philippines. These competitions include but are not limited to Summer Olympics (every 4 years), Winter Olympics (every 4 years), Asian Games (every 4 years), World Championship of respective sports, Asian Championship of respective sports, Southeast Asian (SEA) Games (every 2 years), ASEAN Championship of respective sports, Special Olympics
- e. National Competition – a competition that is participated by individuals or teams from the different regions of the country such as but not limited to, Palarong Pambansa, Philippine National Youth Games (Batang Pinoy), National Open, National Games, Special Olympics
- f. Regional Competition – a competition that is participated by individuals or teams from Region VIII such as but not limited to, Eastern Visayas Regional Athletics Association (EVRAA), Regional Schools Colleges and Universities Athletics Association (SCUAA)
- g. Provincial Competition – a competition that is participated by individuals or teams from Leyte such as but not limited to Leyte Provincial Meet
- h. Area Competition – a competition that is participated by individuals or teams from an area of Leyte in which a the Municipality is a part of such as but not limited to Area Meet
- i. Athlete/Contestant – the individual who participated in the competition and has won the award
- j. Coach – a person registered or authorized to train an athlete/contestant or a team of athletes/contestants before and during the competition.
- k. Individual Sport/Competition – a type of competition that is participated by only one (1) participant as indicated in the rules of the competition
- l. Team Sport/Competition - a type of competition that is participated by five (5) or more participants as indicated in the rules of the competition

3. There shall be allocated an amount for the gifts/token of the awardees depending on the availability of funds.

**SECTION 9. Separability Clause.** If, for any reason or reasons, any part or provision of this Ordinance is held to be unconstitutional or invalid, other parts or provisions hereof which are not affected shall continue to be in full force and effect.

**Section 10. Repealing Clause.** All ordinances, rules and regulations, or parts thereof, in conflict with or inconsistent to the provisions of this Ordinance are hereby repealed or modified accordingly.

**Section 11. Effectivity.** This Ordinance shall take effect immediately after its approval and after its posting in all barangays of the Municipality of Julita, Leyte.
