**AMENDING SECTION 4 OF ORDINANCE NO. 21, S. 2022-2025**

SANGGUNIANG PANLALAWIGAN

**PREFATORY STATEMENTS**



It would have become a painful scenario the existence of aged/elderly who might be left alone by their families to wander with nowhere to shelter themselves and scavenge or search for something useful or edible in rubbish or other discarded materials. On account of this, the idea to preempt the situation emerged, thereby the most-wanted structure for its intervention was given consideration.

The primary ordinance which created the Home for the Aged in the Municipality of Villaba was based upon the provision of Section 6, Chapter II of Ordinance No. 39, s. 2019 enacting the Senior Citizens Code of Villaba, Leyte. This Section provides, among other things, that every senior citizen, and the aged for that matter, has the right to sufficient shelter, proper medical care and all the basic physical requirements of a healthy and vigorous life and, that the neglected, abandoned and exploited be given special space at the Senior Citizens Center under the care of a trained person to be designated by the LCE for such a purpose.












In as much as LGU-Villaba does not have a Senior Citizens Center, it is but appropriate that a space in the Evacuation Center shall serve for the end in view.

Consequently, the above premises define the urgency of the legislative action pertinent to the specific placement of the Home for the Aged and, for this reason, this amendment is executed.

**NOW, THEREFORE**, on motion by the Hon. Rogelio J. Baay, Chairman, SB Committee in Senior Citizens and PWDs, duly seconded EN MASSE, Be it

**ORDAINED**, as the Sangguniang Bayan in regular session assembled hereby ordained, that:

**Section 1. TITLE.** This legislation shall be known as "An Ordinance Amending Section 4 of Ordinance No. 21, S. 2022-2025," herein referred to as:

**AN ORDINANCE CRAFTED TO CREATE A HOME FOR THE AGED IN THE MUNICIPALITY OF VILLABA AND ESTABLISH PUBLIC-PRIVATE PARTNERSHIP FOR THE OPERATION THEREOF**

**Section 2. ORIGINAL PROVISION.** Section 4 of Ordinance No. 21, S. 2022-2025 states that:

“**Section 4.** Establishment of the Home for the Aged-As recommended by the Congressman, the evacuation Center at Sitio Cayangi-an, Brgy. Tinghub, Villaba, Leyte, shall be converted into a Home for the Aged. The structure may be remodeled and make it a well-appointed house, equipped with all the necessary fixtures and facilities suited for a comfortable and healthy living”

**Section 3 AMENDMENT.** Section 4 of Ordinance No. 21 S. 2022-2025 shall hereby be amended to read as follows:

“**Section 4.** Establishment of the Home for the Aged. The Home for the Aged shall, in order of priority, be situated at the lower portion/first floor of the Evacuation Center considering the identified health condition of this class of senior citizens and giving vent to their convenience.”

**Section 4. SEPARABILITY CLAUSE.** If for any reason, any part or provision of this ordinance shall be held unconstitutional or invalid, other parts or provisions hereof which are not affected shall continue to be in full force or effect.

**Section 5. REPEALING CLAUSE.** All ordinances, laws, decrees, executive orders, rules and regulations or part thereof, inconsistent with the provisions of the ordinance, are hereby repealed or modified accordingly.

**Section 6. EFFECTIVITY.** This ordinance shall take effect upon approval and after this shall have been posted in three (3) conspicuous places in accordance with the posting requirement of the Local Government Code;

**MUNICIPAL ORDINANCE NO. 21, S. 2022-2025**

**AN ORDINANCE CRAFTED TO CREATE A HOME FOR THE AGED IN THE MUNICIPALITY OF VILLABA AND ESTABLISH PUBLIC-PRIVATE-PARTNERSHIP FOR THE OPERATION THEREOF**

**PREFATORY STATEMENTS**

Introduced by: **HON. ROGELIO J. BAAY**  
Sangguniang Bayan Member

It is declared in Section 11, Article II of the 1987 Constitution of the Philippines that, "The State values the dignity of every human person and guarantees full respect for human rights."

Section 15, Article II of the same Constitution, further declares that, "The state shall protect and promote the right to health of the people and install health consciousness among them."

The Local Government Code of 1991 (R.A. 7160) mandates the sangguniang bayan, under Section 447, (5), (XIV), Article Three, to provide for the care of paupers, the aged and the abandoned senior citizens and put up centers and facilities for said needy and disadvantaged persons.

As per recommendation by the former Congressman, Justice Vicente Veloso, III, the Municipal Mayor, through a letter dated December 9, 2022 sent by the Municipal Administrator Designate to the Sangguniang Bayan, requested the latter to pass an Ordinance on the creation of a Home for the Aged in this municipality and, thereby, establish a Public-Private-Partnership for its fully carried out operation.

On account of the above – mentioned premises,

**NOW, THEREFORE, Be it ORDAINED**, as the Sangguniang Bayan of Villaba, Leyte in regular session assembled hereby **ORDAINED**, that:

**Section 1. Title.** – This enactment shall be known as "The Home for the Aged Ordinance in the Municipality of Villaba, and Establishing for the Purpose a Public-Private-Partnership."

**Section 2. Scope.** – This ordinance shall cover the care of paupers, the aged and the abandoned senior citizens in the municipality, as well as, the institution of a center or facility for this end.

**Section 3. Definition of Terms.** – As used in this ordinance, the following terms are hereby defined to wit:

- a) **Aged** – of advanced age or having attained a specified age of 75 years old and above
- b) **Charity** – an institution engaged in relief of the poor
- c) **“Home”** – shall refer to the Home for the Aged
- d) **Occupant** – any of a group occupying a single place of residence
- e) **Look After** – Take care of
- f) **Pauper** – a person without means of support except from charity

**Section 4. Establishment of the Home for the Aged.** – The evacuation center at Sitio Cayangi-an, Brgy. Tinghub, Villaba, Leyte, shall be converted into a Home for the Aged. The structure may be remodeled and make it a well-appointed house, equipped with all the necessary fixtures and facilities suited for a comfortable and healthy living.

**Section 5. Source of Fund.** – There shall be allocated by the local government enough funds for the installation of the Home for the Aged and maintenance of subsistence, laundry and other basic necessities of the paupers, indigent aged and/or abandoned senior citizens who will be the occupants of this Home. For the sustainability of this project and, in the event that the local resources will not suffice for a long period, the government may explore the possibilities to foment the organization of a public-private-partnership with open-handed/ philanthropic residents in the locality and abroad. An idea cannot be discounted that through relentless cooperative efforts, this partnership would give rise to a foundation, and when this happens, the Home for the Aged would be under the management of the foundation officials and personnel.

**Section 6. Oversight and Control.** – The Local Chief Executive shall make use of one (1) nurse and two or more regular employees / Job Orders for the supervision and control of the occupants in the Home for the Aged, without prejudice, however, to increasing this number as the need arises in the course of its implementation.

The nurse shall look after the health condition of the persons in this Home through physical check-up/ examination and the administration of the proper medication to them under the instruction of the Rural Health Doctor.

The regular employees/JOs may take turns to help in the distribution of food packs and in seeing to it that the aged are in comfort, that their needs are addressed and that their problems, if any, are reported to proper authority for possible solution.

**Section 7. Protection of the Home Residents.** – Security Guards shall be employed by the Local Chief Executive every day and night for the safety of the home residents. The elderly may be allowed to get out of the Home but occasionally and for a reasonable intension. They shall be escorted in the event that they wish to do so.

**Section 8. Food Preparation.** – The Local Government Unit, through the Local Chief Executive with the assistance of the MSWDO, shall organize a Team of three (3) employees/Job Order's to prepare the ration, or whatever process, for the daily meals of the occupants in the Home for the Aged. These team members may also be augmented as the number of occupants in the Home necessitates.

**Section 9. Enlistment Procedure.** – In order for the paupers, aged and abandoned senior citizens to be worthy of dwelling in the Home for the Aged, the Municipal Mayor shall delegate the Municipal Social Welfare and Development Officer (MSWDO) to create a system of registration and availment of benefits utilizing as guide Sections 10 and 11 of this ordinance.

**Section 10. Requirements.** – The MSWDO shall cause the issuance of an Identification Card (ID) which shall be considered as competent evidence of identity. The following are the requirements:

- 1) Voter's ID or Certification or any government issued ID providing proof that the applicant is a resident of the municipality;
- 2) Barangay Certification to prove that the applicant is a resident of the barangay for at least one (1) year at the time he reached old age;
- 3) Application Form provided by the aforementioned office base on numbers 1) and 2) information, indicating likewise the name, residence, date of birth, category whether pauper, aged or abandoned senior citizens; whether supported by the family or not; whether living with the family or alone, and other related information.

**Section 11. Assessment.** – The applicant who manifests his or her intention to avail of the benefits of this Ordinance shall be subject to assessment by the social worker in the MSWD Office. The assessment shall cover, but not limited to, the following:

Determination of the applicant's category as reflected in No. 3, Section 10 of this ordinance. However, for further clarification purposes, these categories are hereby elucidated:

Pauper is a person without means of support except from charity or charitable institution, an organization engaged in relief of the poor. This organization is usually found in big cities where national and international NGOs are available to provide aid to the people, especially, the elderly. The pauper is a senior citizen but not abandoned because he/she is entrusted to a charitable institution for care.

The aged are of advanced age or having attained a specified old age. He/she may be a pauper if being in the good graces of a government or private foundation, but become an abandoned senior citizen when deprived of assistance from any organization and not even taken care of by his/her immediate relatives.


In the final analysis, the regulation for the admission of the upcoming residents of the Home for the Aged shall be dependent upon the wise, compliant and objective decision of the Screening Committee to be organized by the Local Chief Executive. OSCA and FEBSCAVIL may be tapped to assist in screening.



**Section 12. Availment.** – Proof of entitlement based on the provisions of Section 10 and 11 of this ordinance issued by the MSWDO, shall be presented to the Municipal Mayor, or whoever is assigned to this concern, for registration.


**Section 13. Repealing Clause.** – Any municipal ordinances rules and regulations, executive orders or parts thereof inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

**Section 14. Separability Clause.** – In the event that any part or provision of this ordinance is held unconstitutional or invalid by a court of law, the other parts or provisions shall continue to be in force or effect.

**Section 15. Effectivity.** – This ordinance shall take effect upon approval and after this shall have been posted in three (3) conspicuous places in accordance with the posting requirement of the Local Government Code.

**MINUTES OF THE PUBLIC HEARING ON THE AMENDMENT OF SECTION 4 OF ORDINANCE NO. 21, S. 2022-2025 AND THE RESOLUTION FOR THE CONVERSION OF PART OF THE EVACUATION CENTER AT SITIO CAYANGI-AN BARANGAY TINGHUB, VILLABA, LEYTE INTO A RESIDENTIAL CARE FACILITY OF THIS MUNICIPALITY**

**VENUE: Old Municipal SB Session Hall  
DATE: March 8, 2024 9:00 A.M.**

This Public Hearing was attended by the MSWD representative, OSCA Head and the Officers of FEBSCAVIL, The presence of the Municipal Administrator was not available.

- I. Home for the Aged. The Chair opened the discussion by introducing the approved ordinance on Home for the Aged believing that the invited persons before him were aware of its existence, but only to find out that they have no idea in reference to it. This plainly shows to prove that their offices were not served even a single copy of said ordinance. So it took the Chair ample time to explain the matter before he was fully understood. Thus, at this juncture, a query was raised: "why there is an amendment?" The chair, in response, stated that an amendment is indispensable because the Home for the Aged Ordinance and Residential Care Facility resolution seem to be occupying the same point at the same time. This conflict needs a reasonable solution
- II. Conversion of the Evacuation Center into Villaba Residential Care Facility.

Here is the clash of opposing interest;

On December 9, 2022, the Municipal Mayor requested the August Body of the municipality to pass an ordinance for the establishment of a Home for the Aged, converting the Evacuation Center at Sitio Kayangi-an, Barangay, Tinghub for this purpose.

On February 14, 2024, the Municipal Mayor requested the same August Body to pass a resolution approving the Conversion of the same Cayangi-an evacuation Center Residential Cara Facility.

Hence, to resolve the foregoing issue, Section 4 of Ordinance No. 21, S 2022 must be amended

There having no other question, the Public Hearing closed at 11:00 A.M.


