Gentlemen and Ladies:

We are in receipt of Sangguniang Bayan (SB) Appropriation Ordinance No. 461 embodying the General Fund Supplemental Budget No. 1 CY 2024 of the MUNICIPALITY OF BABATNGON, LEYTE endorsed to this level on 26 March 2024 for preliminary review.

Upon evaluation of the budget documents, we observed the following:

1. Amounts in the Appropriation Ordinance

The Appropriation Ordinance states two (2) amounts PhP96,818,000.00 and PhP26,137,096.53, which renders it ambiguous to determine the amount of the appropriation. It must be noted that the Ordinance shall authorize the total amount of expenditures as embodied in the budgetary form No. 9.

2. Reversion of Appropriations from Personal Services (PS) and from Maintenance and Other Operating Expenses as Fund Source

The reversion of appropriations from PS do not indicate the items or positions the salaries are being taken from and for what period and year.

Likewise, the reversion of appropriations from MOOE does not show the period or the year of the appropriations, thus, difficult for us to trace in the budget.

In view of the foregoing findings, we are returning the said supplemental budget No. 1 CY 2024 of the Municipality of Babatngon, Leyte, without review action and without prejudice to its resubmission upon correction as per our observation.

SECTION 1. — The Supplemental Budget No. 1 of the Municipality of Babatngon, Leyte for Fiscal Year 2024 in the amount of PhP 96,818,000.00 for Supplemental Investment Program including the outside source and the local fund amounting to PhP 26,137,096.53 is hereby approved.

The Supplemental Budget No. 1 documents consisting of the following are incorporated herein and made integral part of this ordinance:

- Certification of Availability of funds signed by the Municipal Treasurer and Municipal Accountant.
- Statement of Funding Sources signed by the Municipal Treasurer and Municipal Accountant.
- Statement of Supplemental Appropriations prepared by the Municipal Budget Officer and approved by the Municipal Mayor.
- Supplemental Investment Program No. 1 prepared by the MPDC and approved by the Municipal Mayor.

SECTION 2. — Sources of Funds. The sources of funds for Supplemental Budget No. 1 in the amount of PhP 96, 818,000.00 includes the outside source and the local fund amounting to PhP 26,137,096.53 derived from Savings.

SECTION 3. — Use of Funds. — The amount of PhP 96,818,000.00 and P 26,137,096.53 is hereby appropriated for Supplemental Budget No. 1, FY 2024 of the Municipality of Babatngon.

SECTION 4. — Separability Clause. If, for any reason, any section or provision of this Appropriation Ordinance is disallowed is declared invalid or unconstitutional, other sections or provisions thereof that are not affected thereby shall continue to be in full force and effect.

SECTION 5. - Effectivity. This ordinance shall take effect upon approval.

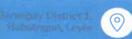

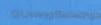
