Respectfully returned to the Sangguniang Panlalawigan of Leyte, through the SP Secretary, the attached Ordinance No. 2024-02 of the Sangguniang Bayan of Palo, Leyte, recommending for the declaration of its validity, pursuant to its power under Section 56 (C) of R.A. 7160, to the opinion of the Provincial Legal Office (PLO), an exercise of the power authorized under Section 19ⁱ of the Local Government Code.

Furthermore, the opinions rendered herein are without prejudice to opinions rendered by higher authorities.

Section 19. Eminent Domain. - A local government unit may, through its chief executive and acting pursuant to an ordinance, exercise the power of eminent domain for public use, or purpose or welfare for the benefit of the poor and the landless, upon payment of just compensation, pursuant to the provisions of the Constitution and pertinent laws: Provided, however, That the power of eminent domain may not be exercised unless a valid and definite offer has been previously made to the owner, and such offer was not accepted: Provided, further, That the local government unit may immediately take possession of the property upon the filing of the expropriation proceedings and upon making a deposit with the proper court of at least fifteen percent (15%) of the fair market value of the property based on the current tax declaration of the property to be expropriated: Provided, finally, That, the amount to be paid for the expropriated property shall be determined by the proper court, based on the fair market value at the time of the taking of the property.

SECTION 1. TITLE. This Ordinance shall be called "AN ORDINANCE AUTHORIZING THE MUNICIPAL MAYOR TO INITIATE EXPROPRIATION PROCEEDINGS OVER A PARCEL OF LAND, AND ITS IMPROVEMENTS, TO BE UTILIZED AND CONSTRUCTED WITH AN ANNEX MUNICIPAL BUILDING IN BRGY. LUNTAD, THIS MUNICIPALITY".

SECTION 2. SCOPE. Authority is hereby granted to the Municipal Mayor, on behalf of Palo Municipal Government, by virtue of the power of eminent domain, to initiate expropriation proceedings over a parcel of land, and its improvements, situated in Brgy. Luntad, this Municipality, for the construction of an Annex Municipal Building, Lot No. 1017, covered by Tax Declaration Number 08-30-0004-00010.

SECTION 3. APPROPRIATION. The amount equivalent to the deposit fees and other expenses to commence the expropriation proceedings as well as the amount to be paid for the properties as determined by the Court shall be allocated from the available funds for Land Acquisition under the General Fund of the municipality.

SECTION 4. EFFECTIVITY. This Ordinance shall take effect immediately upon its approval.
