**Gentlemen and Ladies:**

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the **General Fund Supplemental Budget No. 1 CY 2024** of the **Municipality of Isabel, Leyte** duly enacted by the Sangguniang Bayan through **Appropriation Ordinance No. 01, Series of 2024** with a total appropriation in the amount of **P4,500,000.00**, reveals substantial compliance with the same law and its implementing Rules and Regulations.

It is therefore recommended for approval subject to the following conditions:

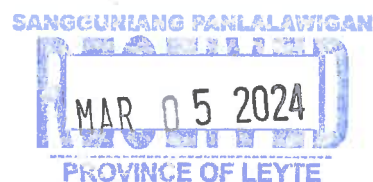

AN ORDINANCE AUTHORIZING THE SUPPLEMENTAL BUDGET NO. 01 OF THE MUNICIPALITY OF ISABEL, LEYTE FOR FISCAL YEAR 2024 INVOLVING AN AMOUNT OF FOUR MILLION FIVE HUNDRED THOUSAND PESOS (PhP 4,500,000.00) FROM THE SAVINGS OF UNUTILIZED APPROPRIATIONS UNDER THE ECONOMIC DEVELOPMENT FUND (EDF) OF THE OFFICE OF THE MAYOR IN FY 2017 AND APPROPRIATING THE SAME FOR THE CONSTRUCTION OF A TWO STORY WAREHOUSE BUILDING.

**WHEREAS**, presented for consideration before this august body is the proposed Supplemental Budget No. 01 of the Local Government Unit of Isabel, Leyte, for CY 2024;

**WHEREAS**, the same covers additional appropriations of expenditures for the construction of a 2 story warehouse building;

**NOW THEREFORE:**

**SECTION 1.** The Supplemental Budget No. 01 of the Municipality of Isabel, Leyte for Fiscal Year 2024 in the total amount of Four Million Five Hundred Thousand Pesos (PhP 4,500,000.00) covering the additional appropriations for the construction of a two story warehouse building.


