



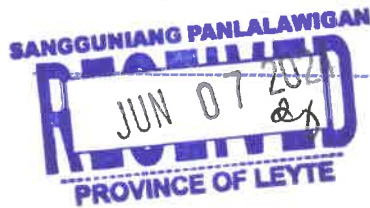

This office is of the opinion that the subject Ordinance is within the corporate powers of the local government unit to enact as provided under Sec 458 of the R.A. 7160.

The subject Ordinance appears to comply with applicable provisions of the Local Government Code particularly Sec. 13 of R.A. 7160 on *Naming of Local Government Units and Public Places, Streets and Structures* and DepEd DO 29, S. 2011 - *Revised Guidelines On The Naming And Renaming Of Schools* wherein the same must be made only upon recommendation of the Local School Board. Hence, recommending for the declaration of its validity.

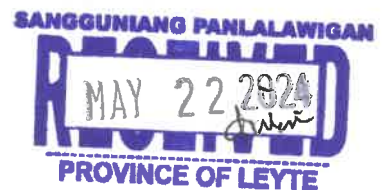

PREFATORY STATEMENT

WHEREAS, Section 13, Book I, Title I, Chapter II of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, empowers the Sangguniang Bayan to change the name of municipal public schools within its territorial jurisdiction upon recommendation of the Local School Board;

WHEREAS, under the revised guidelines of the National Historical Commission of the Philippines, proposed names of public schools, among others, "must have historical and cultural significance and must contribute to the positive development of national pride through the good example exhibited by the name being used;"

WHEREAS, the Local School Board (LSB) of this municipality passed a resolution through Resolution No. 002 favorably recommending renaming Natubgan Elementary School to Zacarias Omega Oronea Elementary School.

WHEREAS, in appreciation of the generosity of the Oronea Family and in recognition of their contribution to the education sector, especially of their patriarch, Zacarias Omega Oronea;

NOW THEREFORE, the Sangguniang Bayan of Kananga, in its regular session duly assembled, hereby ordains the following:

SECTION 1. Title. – This Ordinance shall be known as “An ordinance renaming Natubgan Elementary School to Zacarias Omega Oronea Elementary School.”

SECTION 2. Declaration of Policy. – It is hereby declared a policy that Natubgan Elementary School be renamed as Zacarias Omega Oronea Elementary School located at Barangay Natubgan, in the Municipality of Kananga, Province of Leyte.

SECTION 3. Separability Clause. – If any section or part of this Ordinance is held unconstitutional or invalid, the other sections or provisions not otherwise affected shall remain in full force or effect.

SECTION 4. Repealing Clause. – All other ordinances, orders, issuances, rules, and regulations, which are inconsistent with the provisions of this Ordinance are hereby repealed, amended, or modified accordingly.


SECTION 5. Effectivity. – This Ordinance shall take effect 15 days upon its publication or after due compliance with all the requirements provided under R.A. 7160, otherwise known as the Local Government Code of 1991.
