



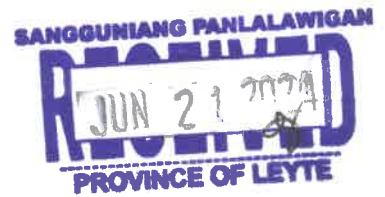

RESOLUTION STRONGLY SUPPORTING SENATE BILL NO. 1378 FILED BY SENATOR MARK A. VILLAR, PROVIDING FOR AN INCREASE AND AUTOMATIC ADJUSTMENT MECHANISM IN THE PERSONNEL ECONOMIC RELIEF ALLOWANCE (PERA) GRANTED TO GOVERNMENT EMPLOYEES AND REQUESTING THE SENATE OF THE PHILIPPINES FOR ITS IMMEDIATE PASSAGE.

Presented for consideration of the Body was Resolution No. 541-2023 of the Sangguniang Panlalawigan of Agusan del Norte which strongly supports Senate Bill No. 1378 filed by Senator Mark A. Villar, an act providing for an increase and automatic adjustment mechanism in the Personnel Economic Relief Allowance (PERA) granted to government employees and requesting the Senate of the Philippines for its immediate passage.

WHEREAS, the said Senate Bill seeks to increase the financial assistance given to government employees to defray some of their expenses corresponding to the cost of basic goods and services;

WHEREAS, the PERA that government employees currently receive is only Two Thousand Pesos (P2,000.00) which is no longer enough to achieve its intended purpose, considering the continuing and uncontrolled escalation of prices of basic commodities aggravated by high inflation rate in the Philippines.

WHEREAS, the increase of PERA from P2,000.00 to P4,000.00 per month as provided in Senate Bill No. 1378 would be of great benefit to government personnel in this time of economic crisis as it will positively relieve and alleviate their predicament of securing their basic necessities, therefore, allowing them to focus more and further encourage them in providing efficient and effective public service;


WHEREFORE, the Sangguniang Panlalawigan, on motion of Honorable Cerebo, seconded by Honorables Tabara and Antao

RESOLVED, as it hereby resolves, to strongly support, as it hereby strongly supports, Senate Bill No. 1378 filed by Senator Mark A. Villar, providing for an increase and automatic adjustment mechanism in the Personnel Economic Relief Allowance (PERA) granted to government employees and requesting the Senate of the Philippines for its immediate passage.
