Heritage, Culture and the Arts, chaired by the Honorable Ma. Corazon E. Remandaban.

"COMMITTEE REPORT No. 01, s. 2024

Referred to this committee is Ordinance No. 2023-19 of the Sangguniang Bayan of Calubian, Leyte entitled "AN ORDINANCE RENAMING THE VILLANUEVA-DALUMPINES MUNICIPAL ROAD INTO VICENTE MAURICIO VELOSO, SR. IN THE MUNICIPALITY OF CALUBIAN, LEYTE, IN RECOGNITION TO ONE DISTINGUISHED PERSON AND PUBLIC SERVANT OF THE PROVINCE OF LEYTE"

The subject ordinance was forwarded to the Sangguniang Panlalawigan for review and approval; and was referred to the Provincial Legal Office for their opinion. The Provincial Legal Office opined that the consultation with and recommendation of the National Historical Commission of the Philippines (NHCP) be complied with in accordance with Section 13 (c) and (d) and observe the provision on Section 13 (h) of the Local Government Code, quoted hereunder:

"Section 13 (c) The Sanggunians of component Cities and Municipalities may, in consultation with the Philippine Historical Commission, change the name of the following within its territorial jurisdiction:

- (1) City and municipal barangays, upon recommendation of the Sangguniang barangay concerned;
- (2) City, municipal and barangay roads, avenues, boulevards, thoroughfares, and bridges;
- (3) City and municipal public elementary, secondary and vocational or technical schools, post-secondary and other tertiary schools:
- (4) City and municipal hospitals, health centers and other health facilities; and
- (5) Any other public place or building owned by the municipal government.
- (d) None of the foregoing local government units, institutions, places, or buildings shall be named after a living person nor may a change of name be made unless for a justifiable reason and, in any case, not oftener than once every ten (10) years. The name of a local government unit or a public place, street or structure with historical, cultural, or ethnic significance shall not be changed, unless by a unanimous vote of the sanggunian concerned and in consultation with the NHCP.
- (h) In any change of name, the Office of the President, the representative of the legislative district concerned, and the Bureau of Posts shall be notified.

The committee then referred the matter to the NHCP for their comments and recommendation and obtain the following response:

That should there be any move to name or rename public streets and structures, prior consultation with the NHCP must be made, pursuant to Section 13 of RA 7160 also known as the Local Government Code of the Philippines. Otherwise, the validity of said ordinance may be put into question.
134 135 136 137	b. Nevertheless, the NHCP does not object to the proposed renaming based on the thorough deliberation of the Sangguniang Bayan of Calubian.
138 139 140 141 142	Since the Sangguniang Bayan of Calubian failed to consult the NHCP prior to enacting the ordinance, the committee finds it appropriate for the municipality to refer to the Revised Guidelines on the Naming and Renaming of Streets, Public Schools, Plazas, Buildings, Bridges and Other Public Structures particularly the following provisions:
