Romualdez, Sr. as a Local Hero of The Municipality of Burauen, Leyte, and declaring every 6<sup>th</sup> day of June as a Special Working Holiday to Commemorate His Birth. It has been recommended by the Provincial Legal Office that this is partially invalid for reasons that, although, the first part of the Ordinance consists of the declaration of Norberto L. Romualdez, Sr. as Local Hero is Valid because it is within the corporate powers of the local government unit as provided under Sec 458 of R.A. 1760. Sec 16 of the same Code refers to the General Welfare clause which grants every local government unit to ensure and support, among other things, the preservation and enrichment of culture. However, the second part which is the declaration of every 6<sup>th</sup> day of June as a Special Working Holiday, it is not within the authority of the local government unit since the authority to declare local holidays be it working or non-working is vested with the Congress of the Philippines or the President. The only ramification if the local special day is declared by the President is that it lacks permanence, thus, the declaration need to be made yearly.
