Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the **General Fund Supplemental Budget No. 02 FY 2024** of the **Municipality Pastrana**, **Leyte** duly enacted by the Sangguniang Bayan through **Appropriation Ordinance No. 29, S. 2024** with a total appropriation in the amount of **P7,697,223.94** reveals compliance with the same law and its implementing Rules and Regulations.







Declaration of Quorum and Call to Order

The MDC Secretary Engr. Juvilla D. Sy requested everyone to rise for the Opening Prayer and the Philippine National Anthem played through an Audio-Visual Presentation (AVP).

Thereafter, the MDC Secretary acknowledged the MDC members and LGU functionaries present and informed the presiding officer, Hon. Maritess Cayaco-Marcos, Chairperson of the Municipal Development Council (MDC) that majority of the MDC members are present. Then, the MDC Chairperson declared the existence of a quorum and called the meeting to order at exactly 1:30 in the afternoon.

Presentation of Agenda of the MDC Meeting

The MDC Chairperson proceeded to present to the body the agenda of the meeting as follows:

- 1.) Fund Resources for the Supplemental Budget No. 02, F.Y. 2024;
- 2.) Deliberation and Discussion of Projects for the Supplemental Investment Program (SIP) No. 02, C.Y. 2024; and
- 3.) Other Matters

Presentation of the Fund Resources for the Supplemental Budget No. 02 F.Y. 2024:

Thereafter the MDC Chairperson requested the Municipal Budget Officer to present to the council the amount and fund resources for the Supplemental Budget No. 2 F.Y. 2024. The Municipal Budget Officer then, disclosed the total fund amounting to Seven Million Six Hundred Ninety-Seven Thousand Two Hundred Twenty-Three Pesos and Ninety-Four Centavos (Php 7,697,223.94). She said that the amount was derived from the reversion of balances from Capital Outlay of different PPAs for the year 2022 as follows:

She added that the above items except for the Inst. Of Power Supply to Habitat having a total amount of 7,447,223.94 had already been augmented in year 2022 intended for the Const. of Public Market but due to the revision in the Budget Operation Manual with enhancement in budgeting procedures, there is a need of the funds to be reverted and to have a supplemental budget.

Deliberation & Discussion of Projects for the Supplemental Investment Program No. 02, C.Y. 2024

Afterwards, the MDC Secretary continued and presented to the body that the proposed and initial projects identified for the Supplemental Investment Program No. 02, C.Y. 2024 from the fund resources that were presented are for the Additional Fund for the Const. of Two-Storey Public Market in the amount of Seven Million Four Hundred Forty-Seven Thousand Two Hundred Twenty-Three Pesos and Ninety-Four Centavos (₱7,447,223.94), and for the Proposed Installation of Temporary Walling of Post-Harvest Facility in Barangay Jones in the amount of Two Hundred Fifty Pesos (₱ 250,000.00). She then said that there is a need to have a Supplemental Investment Program since the identified projects were not included in the approved Annual Investment Program of CY 2024.

The MDC Chairperson added that the additional fund for the Construction of Public Market is needed to complete the Sixty Million (60,000,000.00) project cost of the public market. Likewise, she informed that the Proposed Installation of Temporary Walling of Post Harvest Facility in Barangay Jones is in relation to the equipment's for rice milling that were donated to the LGU by the Philippine Center for Postharvest Development and Mechanization (PhilMech) which are currently in-placed in the LGU owned Post Harvest Facility, wherein the said facility is not yet fully completed and without walling yet. Thus, the LGU needs to temporary install a walling in the said facility to protect the equipment's. The MDC Chairperson added that the equipment's that were given includes two (2) dryer, two (2) generators, three (3) transformers, and weighing scale. She then said that the equipment's donated will be utilized by the LGU and it will become one of the Local Economic Enterprise and additional revenue to the municipality, wherein the LGU will buy palay at a minimal cost and will have rice production and sale it in a minimum cost per kilo where constituents can afford.

After thorough discussion and exchange of views on the projects presented, the MDC Chairperson asked the body if they are amenable to each item presented. The body replied that they abide to the PPA's presented.

Then, the MDC Chairperson asked if there are comments and suggestions. Since there were none, the MDC Chairperson requested for a motion for the approval of the identified Programs, Projects and Activities (PPAs)

Approval of the Supplemental Investment Program (SIP) No. 01 for C.Y. 2024:

Hon. Jonell B. Dominico, Punong Barangay of Brgy. Cancaraja, Hon. Aflred Francis A. Nogal, Punong Barangay of District IV, Hon. Arturo D. Empillo, Punong Barangay of Brgy. Patong, Hon. Joey L. Dominico, Punong Barangay of District III, Hon. Roberto S. Berino, Jr, Punong Barangay of District I, and Letecia Mercado, CSO President of Tingib Integrated Farmers Association moved to approve the projects under Supplemental Investment Program (SIP) No. 02 C.Y. 2024 to be funded from the Reversion of funds from Capital Outlay in the total amount of Seven Million Six Hundred Ninety-Seven Thousand Two Hundred Twenty-Three Pesos and Ninety-Four Centavos (P7,697,223.94) and to pass a resolution approving and endorsing the same to the Sangguniang Bayan for adoption. It was unanimously seconded by other members present. The MDC passed:

RESOLUTION NO. 2024-02 Series of 2024

"A RESOLUTION APPROVING THE PROJECTS UNDER SUPPLEMENTAL INVESTMENT PROGRAM (SIP) NO. 02 C.Y. 2024 TAKEN FROM THE REVERSION OF FUNDS FROM CAPITAL OUTLAY AMOUNTING TO SEVEN MILLION SIX HUNDRED NINETY-SEVEN THOUSAND TWO HUNDRED TWENTY-THREE PESOS AND NINETY-FOUR CENTAVOS (Php 7,697,223.94) AND ENDORSING THE SAME TO THE SANGGUNIANG BAYAN FOR ADOPTION."

Other Matters:

The MPDC informed the body that the council will still convene in last week of June 2024 for the identification and discussion of programs, projects and activities for the Annual Investment Program (AIP) for calendar year 2025. Likewise, she reminded the Punong Barangays present to start preparing their respective Annual Investment Program (AIP) for calendar year 202**g**.

Afterwards the Municipal Mayor express gratitude to the MDC members present for their presence in attending the MDC meeting despite for a very short notice given to them.

With no more matters to be discussed and resolved, Hon. Suzieta M. Omoy, Punong Barangay of Brgy. Aringit moved to adjourn the meeting, and was seconded by Hon. Cita I. Costimiano, Punong Barangay of Brgy. Yapad. The meeting adjourned at 2:30 in the afternoon.
