

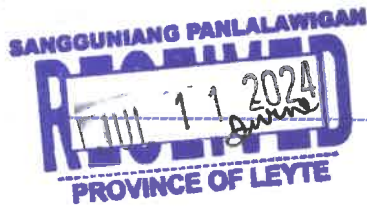

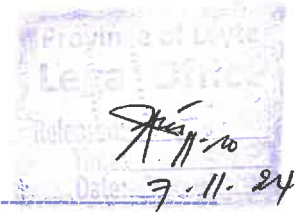

- Ordinance No. 10 S. of 2024 entitled: An Ordinance Approving the Creation of Position Under the Municipal Engineering's Office Two (2) Administrative Aide (Utility Worker 1) Casual.

**REVIEW/RECOMMENDATION/LEGAL OPINION:**

This office is of the opinion that the subject Ordinance is within the corporate powers of the local government unit particularly covered under **Section 447 (viii)** of the Local Government Code of 1991 granting the legislative body of the municipality, to enact ordinances to determine the positions and salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds and provide for expenditures necessary for the proper conduct of programs, projects, services, and activities of the municipal government, and **Section 76** thereof mandating every local government unit to design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission. Hence, this office recommends the declaration of its validity.

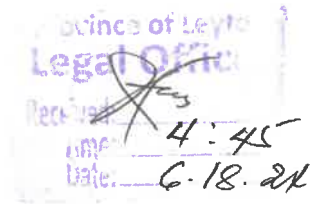

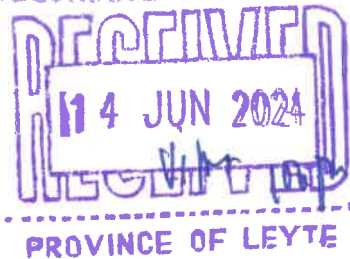

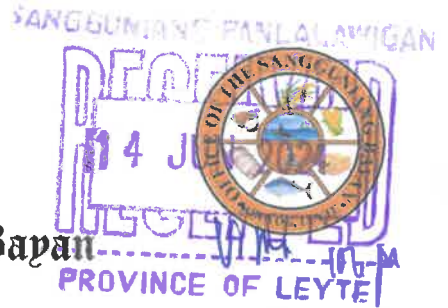

**ORDINANCE NO. 10, SERIES 2024**

**AN ORDINANCE APPROVING THE CREATION OF POSITION UNDER THE MUNICIPAL ENGINEERING'S OFFICE TWO (2) ADMINISTRATIVE AIDE I (UTILITY WORKER I) CASUAL**

**BE IT ORDAINED BY THE 19<sup>TH</sup> SANGGUNIANG BAYAN OF ABUYOG, LEYTE IN A REGULAR SESSION ASSEMBLED; that:**

**SECTION 1. TITLE** - this ordinance shall be known as **AN ORDINANCE APPROVING THE CREATION OF POSITION UNDER THE MUNICIPAL ENGINEERING'S OFFICE TWO (2) ADMINISTRATIVE AIDE I (UTILITY WORKER I) CASUAL**

**SECTION 2. SCOPE AND COVERAGE, SOURCE OF AUTHORITY/PURPOSE** – this ordinance shall apply to the operations and to further effect future employment of personnel and other needed administrative requisites.


**SECTION 3. SEPERABILITY CLAUSE.** If any part of this ordinance be declared as invalid by any court of competent thereof other parts thereof not affected shall remain in force and effect.

**SECTION 4. EFFECTIVITY.** This ordinance shall take effect upon approval.




