DENR Administrative Order No. 2010-21, the Revised Implementing Rules and Regulations of Republic Act No. 7942 or the Philippine Mining Act of 1995, mandates that one of the mandatory requirements for quarry or commercial / industrial sand and gravel permit application is the clearance/endorsement by the Sanggunian concerned that may be affected by the permit application through a formal Resolution.


Furthermore, Section 21 of the Environmental Code of Leyte, provides:

"Section 21. Prior Consent of Sanggunian - For purposes of implementing the provisions of this Code and pursuant to Section 26 and Section 27, RA 7160, national government agencies and instrumentalities are hereby required to consult with local government units and obtain prior consent of the concerned Sanggunian in the implementation and development of investments, programs or projects affecting natural resources. Henceforth, no mineral, quarry, and oil resource management, development, utilization, or processing project, permit, concession, agreement or usufruct permit shall be issued by national government agencies without prior consultation and concurrence through a resolution interposing no objection (to the application and/or proposal) from the Sangguniang Panlalawigan and local government units."

The Sangguniang Bayan of Palo, Leyte where the proposed quarrying project are to be undertaken, issued on June 11 and June 25, 2024 the subject Municipal Resolutions interposing no objection to the requests to quarry. These have been endorsed to the Provincial Government of Leyte.

In view thereof, the Committee hereby recommends the passage of a Resolution interposing no objection to the requests to quarry over the above mentioned properties, subject to compliance of other pertinent certifications, clearances and permits that is being required and / or maybe required by other concerned government agencies and offices, relative to the quarrying.
