Respectfully returned to the Sangguniang Panlalawigan of Leyte, through SP Secretary, the attached Ordinance No. 2024-126 of the Sangguniang Bayan of Mayorga, Leyte.

Issues/concerns for review/recommendation/legal opinion is/are as follows:

 Ordinance No. 2024-126 entitled: "An Ordinance Amending Certain Provisions of Municipal Ordinance No.2017-91, entitled: An Ordinance Regulating the Operation of Motorized Tricycles in the Municipality of Mayorga, Leyte, Designating a Parking Area and Providing Penalties for Violations Thereof.

REVIEW/RECOMMENDATION/LEGAL OPINION:

This office is of the opinion that the Subject Ordinance is in accordance to its power under Section 447 (1)(iii)¹ and (3)(vi)² of the Local Government Code of 1991 (R.A 7160).

Likewise as settled in the case of Constantino v. Desierto 288 SCRA 654, it is within the power of the Local Council to repeal or amend its prior acts either expressly, or by the passage of an essentially inconsistent resolution. Hence, recommending the declaration of its validity.

Please note that the opinion rendered by this Office are based on facts available and may vary or change when additional facts and documents are presented or changed. This opinion is likewise without prejudice to the opinions rendered by higher and competent authorities and/or the courts.





EXPLANATORY NOTE

WHEREAS, Section 447, 3(vi) of RA 7160 otherwise known as the Local Government Code of 1991, states that, the Sangguniang Bayan, subject to the guidelines prescribed by the Department of Transportation and Communications, regulate the operation of tricycles and grant franchises for the operation thereof within the territorial jurisdiction of the municipality;

WHEREAS, it is the paramount duty of the Local Government to ensure the safety of both the riding public and the motorized tricycle operators/owners and its drivers in the conduct of public conveyances;

WHEREAS, the local statute will further preserve the interest of the motorized tricycle operators and drivers and shall safeguard the interests of the public, in general;

WHEREAS, amid the continued price hikes in petroleum products being experienced by the public, a tricycle fare adjustment is in need in order to neutralize its adverse effect to our tricycle operators and drivers;

WHEREFORE, on motion of the Honorable Henry B. Lagarto, duly seconded by the Honorable Jairo C. Beltran; be it

NOW THEREFORE, BE IT ENACTED, AS IT IS HEREBY ENACTED, BY THE SANGGUNIANG BAYAN OF MAYORGA, IN SESSION ASSEMBLED, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, THAT:

SECTION 1. TITLE.

This Ordinance shall be known as the Revised Motorized Tricycles Operations Ordinance of Mayorga, Leyte.

SECTION 2. PURPOSE

- a. To promote orderly traffic rules and regulations.
- b. To preserve the interest of the motorized tricycle operators and drivers and safeguard the interest of the riding public.


SECTION 3. AUTHORITY

This Ordinance is enacted pursuant to the provisions of R.A. 7160 otherwise known as the Local Government Code of 1991 which mandates the LGU to adopt adequate measures to protect, safeguard and improve the quality of life for every Mayorgueño.

SECTION 4. DEFINITION OF TERMS

As used in this Ordinance, the following terms are hereby defined as follows:

- a. Motorized Tricycle a motor vehicle propelled other than muscular power, composed of a motorcycle fitted with a single wheel sidecar or a motorcycle with two wheeled cab, operated to render transport services to the public for a fee;
- b. Electric Motorized Tricycle a three-wheeled vehicle based on the same technology as a bicyle or motorcycle, powered by an electric motor;
- c. Motorized Tricycle Operators Permit (MTOP) a document granting permit to a person, natural or juridical, allowing him to render transportation service to the public for a fee with the use of a motorized tricycle within the territorial jurisdiction of Mayorga;




- d. Franchise a privilege and right granted to a person, natural or juridical, to operate a motorized tricycle in rendering transportation service to the public for a fee within the territorial jurisdiction of Mayorga;
- e. Parking Area a particular area or space for parking motorized tricycles as determined by the Sangguniang Bayan;
- f. Mayorga Tricycle Regulatory and Franchising Council the governing body with regards to the operations of Tricycle for hire in the Municipality;
- g. MCH Motorcab for Hire;
- h. Route Measured Capacity (RMC) the theoretical basis of determining the demand for vehicles on any route.

SECTION 5. OPERATOR'S QUALIFICATIONS

Only Filipino citizens of legal age, or a juridical person, preferably residents of the Municipality of Mayorga, Leyte with roadworthy motorcycle with an equally roadworthy and sturdy sidecar are qualified to be operators of motorized tricycle for hire, subject for inspection by the Mayorga PNP for the issuance of a Police Number, including but not limited to the following physical requirements:

- a. Clean windshield;
- b. Garbage receptacle;
- c. Functional horn that does not emit exceptionally loud or startling sound;
- d. Functional two signal lights, front and back for turning right or left or for emergency purposes;
- e. Functional tail light, including license plate light;
- f. Top chain extending to the rear wheel;
- g. Functional white head light and functional red tail light, visible at least 50 meters from the front and rear of the tricycle and functioning under all weather conditions;
- h. Functional light installed inside the sidecar and kept lighted while plying a designated route;
- i. Fully-operational mufflers;
- j. Roadworthiness of the tricycle unit.




SECTION 6. OPERATING CONDITIONS

In the operation of their transportation business, the franchisee shall observe the following rules and regulations:

- a. Operators shall employ only drivers who are Filipinos of good moral character and duly Professional Licensed by the Land Transportation Office (LTO), to drive a motorized tricycle for hire;
- b. A tricycle for hire shall operate like a taxi service, that is, service rendered upon demand and without a fixed route within the Municipality but should not be allowed to carry passengers or goods or both, more than the capacity allowed under the existing traffic rules and regulations of the Municipality of Mayorga, Leyte;
- c. Operators who will use the designated parking area at the junction of Poblacion Zone I and Poblacion Zone III beside the basketball court shall paint the roof of their MCH with color yellow and the body with color red;
- d. Operators who will use the designated parking area at the junction of Poblacion Zone I and Poblacion Zone II going to La Paz shall paint the roof of their MCH with color yellow and the body with color apple green;
- e. Operators who will use the designated parking area at the junction of Barangay Union and Barangay Ormocay shall paint the roof of their MCH with color yellow and the body with color yellow green;
- f. A tricycle for hire must have two (2) pcs 1-foot long orange reflectorized sticker at the front and back of the unit;
- g. A tricycle for hire must indicate the name of the operator, address and contact number inside the unit;
- h. Electric Motorized Tricycle being applied for franchise shall follow the designated color assigned to a particular parking area where the operator wishes to join;
- i. The Driver's ID shall be displayed inside the unit visible to the passengers;

SECTION 7. AUTHORITY REQUIRED ON CERTAIN ACTS OF THE OPERATORS

Without authority from the Sangguniang Bayan, the operator shall not increase, decrease, transfer, drop and/or substitute units, as well as suspend operation for more than one (1) month unless such



suspension of operation is due to major repair of the unit/s. In which case, notice shall be given to the Office of the Municipal Mayor for proper recording.

Abandonment or termination of its operation herein authorized shall be a cause for cancellation or forfeiture of said authority, in such case the owner or operator himself shall no longer be eligible for the Motorized Tricycle Operator's Permit (MTOP).

Change or transfer of ownership of any unit/s herein authorized to operate shall be valid only upon approval of such application for transfer for a new franchise upon compliance of the requirements under this ordinance.


SECTION 8. PERIOD OR VALIDITY OF MTOP AND FRANCHISE

A Franchise shall be valid only for three (3) years from the date of its issuance and renewable for another three (3) years upon expiration. An MTOP shall be applied yearly within the first twenty (20) days of January by a franchisee. An MTOP issued shall be subject to the conditions, among others, that the operator of the unit concerned shall register the same, as for hire, within one (1) month, otherwise, the said MTOP shall be deemed cancelled or the corresponding penalty herein provided for in this ordinance be imposed against such operator. The LGU shall imprint the designated Police Number at the front and back of the unit having a white background with the size of 18x18 inches. Initial color for the Police Number is black and will change upon renewal of the MTOP, to be determined by the Mayorga PNP.

SECTION 9. FARES

The Sangguniang Bayan shall have the power to fix, increase or decrease the fare rates for motorized tricycles. Said rates shall be chargeable within the Municipal proper or its immediate suburbs, to wit:

SECTION 10. THE MAYORGA TRICYCLE FRANCHISING AND REGULATORY COUNCIL (MTFRC)

There shall be created a Mayorga Tricycle Franchising and Regulatory Council that will supervise and is authorized to implement rules and regulations approved by the Sangguniang Bayan and shall be composed of the following:

Chairperson: Municipal Mayor

Co-Chairperson: SB Chairman on Transportation and

Communication

Members:

Municipal Engineer

Municipal Planning and Development

Coordinator



SECTION 11. POWERS, DUTIES AND FUNCTIONS OF THE MAYORGA TRICYCLE FRANCHISING AND REGULATORY COUNCIL.

The Mayorga Tricycle Franchising and Regulatory Council shall perform the following:

- 1. The council shall exercise quasi-judicial power to hear, modify and conduct hearings for the purpose of recommending suspension, revocation or cancellation to the Municipal Mayor of an MTOP of a motor tricycle operator for any violations stated in this ordinance;
- 2. Accept petitions for fare rate increase and recommend to the Sangguniang Bayan the amount of fares or adjusted fare; increases periodically, to be imposed in a particular zone or fixed route;
- 3. Recommend to the Sangguniang Bayan other reasonable fees and related charges in the regulation of tricycle-for-hire, after conducting a public hearing for that purpose;
- 4. Promulgate rules and regulations for the proper implementation of this Article which shall continue to be in full force and effect until revoked or modified by the Sangguniang Bayan;
- 5. Study, develop and recommend Tricycle Zones or Routes, Route Measured Capacity (RMC); designation of Color Scheme, Body Number and Tricycle Terminals.



- 6. In special or exceptional cases, the Municipal Mayor, thru the recommendation of the MTFRC, may deputize members of the Philippine National Police or traffic enforcers or barangay officials, who shall apprehend erring tricycle drivers, confiscate driver's license, issue Citation Tickets such as Ordinance Infraction Receipt or Ordinance Traffic Violation Receipt, and impound public tricycle;
- Observe and certify election of officers of TODA/Tricycle Service Cooperative (TSC) and Federation of TODA/TSC;
- 8. Require TODA/Tricycle Service Cooperative to submit list of its members or franchise holders every month of July; and
- 9. Perform such other duties, powers and functions as may hereafter be authorized by the Sangguniang Bayan.

SECTION 12. RECORD KEEPING

All franchise granted by Mayorga Tricycle Regulatory Council shall have a complete record to be kept by the Business Permit and Licensing Office, who shall furnish a copy of the same to the Sangguniang Bayan.

SECTION 13. LIMIT ON THE ISSUANCE OF MTOP

Upon the recommendation of the Mayorga Tricycle Franchising and Regulatory Council, the Sangguniang Bayan shall have the power to increase or decrease the number of MTOP that may be issued for motorized and/or electric tricycle unit to operate in the Municipality of Mayorga, Leyte.

SECTION 14. FEES

There is hereby imposed the following fees valid for three (3) years upon date of issuance, to be paid to the Municipal Treasurer, this municipality, before any MTOP shall be issued:


a. Franchise fee
Php 1,000.00 per unit

For annual fees to be paid to the Municipal Treasurer, this municipality:

- a. Motorized Tricycle Operators Permit Php 700.00 per unit with Driver's ID
- b. Inspection fee
 Php 300.00 per unit

For special fees to be paid to the Municipal Treasurer, this municipality:

a. Fare Adjustment fee for fare increase — Php 300.00 per unit



- b. Filing Fee for Amendment of MTOP

 Php 200.00 per MTOP
- c. Filing Fee for Amendment of Franchise Php 500.00 per Franchise
- d. Filing Fee for Amendment of Franchise Php 200.00 per Franchise in case of death of
 the Franchisee


There is hereby imposed a parking fee upon use of the designated parking area, to be paid to the Municipal Treasurer or his representative, this municipality:

a. Parking Fee
Php 10.00 per day

SECTION 15. PENALTY CLAUSE

The following acts or omissions shall subject the operator the corresponding surcharges or fines indicated therein:

- a. A fine of not less than Php 500.00 or an imprisonment of one (1) month, or both fine and imprisonment at the discretion of the court for Motorcab for hire (MCH) without a valid Motorized Tricycle Operator's Permit (MTOP).
- b. A surcharged of Php 150.00 plus a monthly interest of 5% of all fees mentioned in Section 14 of this ordinance shall be imposed upon holders of MTOP who fails to renew on time.
- c. A penalty of Php 200.00 shall be imposed upon MCH operators who fail to register his motorized tricycle unit, as for hire, with the Land Transportation Office (LTO) within one (1) month after the issuance of its MTOP.
- d. A fine of Php 500.00 shall be imposed upon motorized tricycle operators who shall hire or allow their units to be driven by persons without the proper valid driver's license.
- e. A fine of Php 1,000.00 and cancellation of the operator's franchise if found to have used one or single police number to two (2) or more units allowing others to use his police number.
- f. A fine of Php 1,000.00 should the operator or owner of the franchise fail to notify in writing the Sangguniang Bayan of any change, transfer, dropping or substitution of any of his units as provided for under Section 7 hereof, within thirty (30) days from such change, transfer, dropping or substitute.



SECTION 16. DRIVER'S LIABILITIES.

A fine of Two Hundred Pesos (Php 200.00) shall be imposed upon motorized tricycle drivers who shall commit the following acts:

- a. For refusing to render transport service without any valid or justifiable reasons;
- b. For carrying passengers or goods or both more than the capacity for which a motorized tricycle is ordinarily designated. Which is six (6) persons including the driver or three hundred (300) kilograms equivalent load capacity for goods;
- c. For carrying passengers in an arrogant, discourteous or reckless manner;
- d. For driving in the influence of liquor and/or prohibited drugs;
- e. For wearing *sando* or sleeveless while rendering transportation service;
- f. Overcharging of fare;

In case of third violation in any of the aforementioned acts or omissions, a fine of Php 1,000.00 shall be imposed upon the driver, and upon the operator, the suspension of his authority or franchise for a period of not exceeding six (6) months.

SECTION 17. CIVIL REMEDIES.

To assure the payments of all fees, fines or penalties imposed by this ordinance, the motorized tricycles involved of the erring operator shall be impounded and shall be released only until such fees or penalties are duly paid. An impounding fee of Php 50.00 per day, per unit shall be collected.

SECTION 18. CANCELLATION OF MTOP.

The Mayorga Tricycle Regulatory and Franchising Council may recommend to the Municipal Mayor to revoke or cancel an MTOP on the following grounds:

- 1. Making false statements and informations in the application;
- 2. Drunkenness of the driver;
- 3. If the unit, for which it has been issued, is no longer roadworthy or its sidecar dilapidated or for other justifiable reasons for which would promote the safety and best interest of the riding clientele, in particular and the public in general.

SECTION 19. PERSON LIABLE IN CASE OF JURIDICAL ENTITY.

The person managing the operation of the Motorized Tricycle service shall be liable for the payment of all fees, fines and penalties and other liabilities and may be subject to imprisonment for the violation of any of the provisions of this ordinance.

SECTION 20. DESIGNATION OF TEMPORARY TERMINAL PARKING AREA.

Motorized Tricycles with MTOP are authorized to park their units at the junction of Poblacion Zone I and Poblacion Zone II going to La Paz, the junction of Poblacion Zone I and Poblacion Zone III beside the basketball court and the junction of Barangay Union and Barangay Ormocay as their designated temporary terminal parking area.

SECTION 21. SEPARABILITY CLAUSE

If any provision of this Ordinance or any part thereof be declared invalid or unconstitutional, the remaining provisions not affected thereby shall continue in full force and effect.

SECTION 22. APPLICABILITY CLAUSE

All other matters related to the impositions of this ordinance shall be governed by the pertinent provisions of existing laws and other ordinances.

SECTION 23. REPEALING CLAUSE

All ordinances, resolutions, executive orders or regulations and other issuances inconsistent with the provisions and/or purposes of this Ordinance are hereby repealed, amended or modified accordingly.

SECTION 24. EFFECTIVITY CLAUSE.

This ordinance shall take effect upon approval by the Sangguniang Panlalawigan of Leyte.



EXPLANATORY NOTE

WHEREAS, Section 447, 3(vi) of RA 7160 otherwise known as the Local Government Code of 1991, states that "the Sangguniang Bayan, subject to the guidelines prescribed by the Department of Transportation and Communications, regulate the operation of tricycles and grant franchises for the operation thereof within the territorial jurisdiction of the municipality;

WHEREAS, it is the paramount duty of the Local Government to ensure the safety of the both the riding public and the motorized tricycle operators/owners and its drivers in the conduct of public conveyances;

WHEREAS, the local statute will further preserve the interest of the motorized tricycle operators and drivers and shall safeguard the interests of the public, in general;

WHEREFORE, on motion of the Honorable Joseph A. Amante, duly seconded by the Honorable Joselito V. Cochero; be it

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of Mayorga in session to enact this Ordinance:

SECTION 1. TITLE.

This Ordinance shall be known as the Motorized Tricycles Operations Ordinance of Mayorga, Leyte.

SECTION 2. PURPOSE

- A. To promote orderly traffic rules and regulations.
- B. To preserve the interest of the motorized tricycle operators and drivers and safeguard the interest of the riding public.

SECTION 3. AUTHORITY

This Ordinance is enacted pursuant to the provisions of R.A. 7160 otherwise known as the Local Government Code of 1991 which mandates the LGU to adopt adequate measures to protect, safeguard and improve quality of life for every Mayorgueńo.

SECTION 4. DEFINITION OF TERMS

- a. Motorized Tricycle a motor vehicle propelled other than muscular power, composed of a motorcycle fitted with a single wheel sidecar or a motorcycle with two wheeled cab, operated to render transport services to the public for a fee;
- b. Motorized Tricycle Operators Permit (MTOP) a document granting permit to a person, natural or juridical, allowing him to render transportation service to the public for a fee with the use of a motorized tricycle within the territorial jurisdiction of Mayorga;
- c. Franchise a privilege and right granted to a person, natural or juridical, to operate a motorized tricycle in rendering transportation service to the public for a fee within the territorial jurisdiction of Mayorga;
- d. Parking Area a particular area or space for parking motorized tricycles as determined by the Sangguniang Bayan;

SECTION 5. OPERATOR'S QUALIFICATIONS

Only Filipino citizens of legal age, or a juridical person, preferably residents of the Municipality of Mayorga, Leyte with roadworthy motorcycle with an equally roadworthy and sturdy sidecar are qualified to be operators of motorized tricycle for hire;

SECTION 6. OPERATING CONDITIONS

In the operation of their transportation business, the franchise shall observe the following rules and regulations:

- a. Operators shall employ only drivers who are Filipinos of good moral character and duly Licensed by the Land Transportation Office (LTO), to drive a motorized tricycle for hire:
- b. A tricycle for hire shall operate like a taxi service, that is, service rendered upon demand and without a fixed route within the Municipality but should not be allowed to carry passengers or goods or both, more than the capacity allowed under the existing traffic rules and regulations of the Municipality of Mayorga, Leyte;

SECTION 7. AUTHORITY REQUIRED ON CERTAIN ACTS OF THE OPERATORS

Without authority from the Sangguniang Bayan, the operator shall not increase, decrease, transfer, drop and/or substitute units, as well as suspend operation for more than one (1) month unless such suspension of operation is due to major repair of the unit/s. In which case, notice shall be given to the Office of the Municipal Mayor for proper recording.

Abandonment or termination of its operation herein authorized shall be a cause for cancellation or forfeiture of said authority, in such case the owner or operator himself shall no longer eligible for the Motorized Tricycle Operator's Permit (MTOP).

Change or transfer of ownership of any unit/s herein authorized to operate shall be valid only upon approval of such application for transfer for a new franchise upon compliance of the requirements under this ordinance.

SECTION 8. PERIOD OR VALIDITY OF MTOP

An MTOP shall be valid only within one (1) year from the date of issuance but renewable for the same length of time on the anniversary date of issuance. An MTOP issued shall be subject to the conditions, among others, that the operator of the unit concerned shall register the same, as for hire, within one (1) month, otherwise, the said MTOP shall be deemed cancelled or the corresponding penalty herein provided for in this ordinance be imposed against such operator.

SECTION 9. FARES

The Sangguniang Bayan shall have the power to fix, increase or decrease the fare rates for motorized tricycles. Said rates shall be chargeable within the Municipal proper or its immediate suburbs, to wit:

SECTION 10. LIMIT ON THE ISSUANCE OF MTOP

The Sangguniang Bayan shall likewise have the power to increase or decrease the number of MTOP that may be issued for motorized tricycle unit to operate in the Municipality of Mayorga, Leyte.

SECTION 11. FEES

There is hereby imposed the following fees, to be paid to the Municipal Treasurer, this municipality, before any MTOP shall be issued:

a. Franchise fee
b. Supervision fee
c. Confirmation fee
Php 100.00 per unit.
Php 100.00 per unit.

For annual fees to be paid to the Municipal Treasurer, this municipality:

a. Motorized Tricycle - Php 300.00 per unit Operators Permit (MTOP)

For special fees to be paid to the Municipal Treasurer, this municipality:

a. Fare Adjustment fee - Php 100.00 per unit for fare increase

b. Filing Fee for — Php 100.00 per MTOP

Amendment of MTOP

There is hereby imposed a parking fee upon use of the designated parking area, to be paid to the Municipal Treasurer or his representative, this municipality:

a. Parking Fee - Php 5.00 per day

SECTION 12. PENALTY CLAUSE

The following acts or omissions shall subject the operator the corresponding surcharges or fines indicated therein:

- a. A fine of not less than Php 500.00 or an imprisonment of one (1) month, or both fine and imprisonment at the discretion of the court for Motorcab for hire (MCH) without a valid Motorized Tricycle Operator's Permit (MTOP).
- b. A surcharged of Php 150.00 plus a monthly interest of 5% of all fees mentioned in Section 11 of this ordinance shall be imposed upon holders of MTOP shall fail renew the same month after its anniversary date of issuance.
- c. A penalty of Php 200.00 shall be imposed upon MCH operators who fail to register his motorized tricycle unit, as for hire, with the Land Transportation Office (LTO) within one (1) month after the issuance of its MTOP.
- d. A fine of Php 500.00 shall be imposed upon motorized tricycle operators who shall hire or allow their units to be driven by persons without the proper valid driver's
- e. A fine of Php 1,000.00 and cancellation of the operator's franchise if found to have used one or single police number to two (2) or more units allowing others to use his police number.
- f. A fine of Php 1,000.00 should the operator or owner of the franchise fail to notify in writing the Sangguniang Bayan of any change, transfer, dropping or substitution of any of his units as provided for under Section 7 hereof, within thirty (30) days from such change, transfer, dropping or substitute.

SECTION 13. DRIVER'S LIABILITIES.

A fine of Two Hundred Pesos (Php 200.00) and four (4) hours community service, shall be imposed upon motorized tricycle drivers who shall commit the following acts:

- a. For refusing to render transport service without any valid or justifiable reasons;
- b. For carrying passengers or goods or both more than the capacity for which a motorized tricycle is ordinarily designated. Which is six (6) persons including the driver or three hundred (300) kilograms equivalent load capacity for goods;
- c. For carrying passengers in an arrogant, discourteous or reckless manner:
- d. For driving in the influence of liquor and/or prohibited drugs;
- e. For wearing sando or sleeveless while rendering transportation service;

In case if third violation of any of the aforementioned acts or omissions, a fine of Php 1,000.00 shall be imposed upon the driver, and upon the operator, the suspension of his authority or franchise for a period of not exceeding six (6) months.

SECTION 14. CIVIL REMEDIES.

To assure the payments of all fees, fines or penalties imposed by this ordinance, the motorized tricycles involved of the erring operator shall be impounded and shall be released only until such fees or penalties are duly paid. An impounding fee of Php 50.00 per day, per unit shall be collected.

SECTION 15. CANCELLATION OF MTOP.

The Municipal Mayor may revoke or cancel an MTOP if the unit, for which it has been issued, is no longer roadworthy or its sidecar dilapidated or for other justifiable reasons for which would promote the safety and best interest of the riding clientele, in particular and the public in general.

SECTION 16. PERSON LIABLE IN CASE OF JURIDICAL ENTITY.

The person managing the operation of the Motorized Tricycle service shall be liable for the payment of all fees, fines and penalties and other liabilities and may be subject to imprisonment for the violation of any of the provisions of this ordinance.

SECTION 17. DESIGNATION OF PARKING AREA.

Motorized Tricycles with MTOP are authorized to park their units at the junction of Poblacion Zone I and Poblacion Zone II going to La Paz and the junction of Poblacion Zone I and Poblacion Zone III beside the basketball court as their designated parking area.

SECTION 18. SEPARABILITY CLAUSE

If any provision of this Ordinance or any part thereof be declared invalid or unconstitutional, the remaining provisions not affected thereby shall continue in full force and effect.

SECTION 19. APPLICABILITY CLAUSE

All other matters related to the impositions of this ordinance shall be governed by the pertinent provisions of existing laws and other ordinances.
