

ORDINANCE NO. 05, S. 2024

AN ORDINANCE REGULATING THE USE OF THE "DON SIMPLICIO APOSTOL GYMNASIUM" AND OTHER MUNICIPAL GOVERNMENT FACILITIES OF THE <u>MUNICIPALITY OF BARUGO FOR PRIVATE PURPOSES AND FIXING THEIR</u> RENTAL

Be it ordained by the Sangguniang Bayan in regular session assembled:

SECTION 1. The following are the municipal government facilities for purposes of this Ordinance:

a. Don Simplicio Apostol Gymnasium (Municipal Gymnasium)

b. EDS Function Room

c. Legislative Session Hall

SECTION 2. The fixed rentals above the above facilities if used for private purposes are hereunder provided:

A. DON SIMPLICIO APOSTOL GYMNASIUM:

(1) WITHOUT Air Conditioning. - The amount of Four Thousand Pesos (P4,000.00) for the first six hours of use and an additional amount of Five Hundred Pesos (P500.00) for each additional hour of use.

(2) WITH Air Conditioning. - The of amount of Eight Thousand Pesos (P8,000.00) for the first six hours of use and an additional amount of One Thousand Pesos (P1,000.00) for each additional hour of use.

B. EDS FUNCTION ROOM:

WITH Air Conditioning Only. - The amount of Seven Thousand Pesos (P7,000.00) for the first six hours of use and an additional amount of One Thousand Pesos (P1,000.00) for each additional hour of use.

C. LEGISLATIVE SESSION HALL:

(1) WITH Air Conditioning Only. - The amount of Five Thousand Pesos (P5,000.00) for the first six hours of use and an additional amount of One Thousand Pesos (P1,000.00) for each additional hour of use.

In order to maintain the symbolic stature and solemnity of the Legislative Session Hall as the pedestal of local legislative domain, it shall not be made available for lease to or use by other persons/entities regardless of its purpose except for extreme necessity as determined by the presiding officer and the sanggunian.

SECTION 3. Scheduling of Activities and Payment of Rates

- A. The Municipal Mayor shall designate an employee within the Office of the Municipal Mayor who shall receive, facilitate, and plot the schedule of the application on a first-come, first-served basis for the use of the above-mentioned facilities, except the Legislative Session Hall. The plotted schedule shall be posted in the municipal bulletin board and at the facilities.
- B. Applications for the use of the Legislative Session Hall shall be submitted in writing to the Office of the Vice-Mayor.
- C. Payments shall be made at the Office of the Municipal Treasurer and the Official Receipt shall be as the basis of the Office of the Municipal Mayor to confirm the schedule. Provided, that the municipal government reserves the right to cancel any scheduled activity at the facilities mentioned should exigencies of public service requires. In such cases, payment shall be refunded.

SECTION 4. REPEALING CLAUSE. - All resolutions, ordinances and executive issuances, or provisions thereof, which are inconsistent with any of the provisions hereof are hereby accordingly repealed, amended and/or modified.

SECTION 5. SEPARABILITY CLAUSE. - Should any provision of this ordinance be subsequently declared unconstitutional or ultra vires, the rest of the provisions not so declared shall remain to be in full force and effect.

SECTION 6. EFFECTIVITY. - This ordinance shall take effect upon its approval.

UNANIMOUSLY APPROVED, this 7th day of May, 2024 in Barugo, Leyte.


