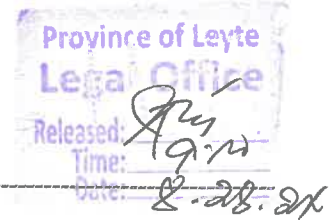

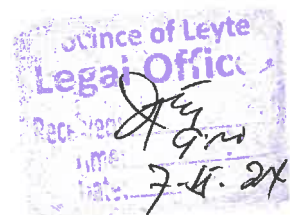



**AN ORDINANCE ESTABLISHING AND CREATING A LOCAL COLLEGE IN THE MUNICIPALITY OF BARUGO TO BE KNOWN AS THE "BARUGO BAYVIEW COLLEGE", GRANTING ITS CHARTER AND PROVIDING FUNDS THEREFOR**

WHEREAS, it has been the declared policy of the State to recognize the vital role of the youth in our society and the need to assist them in their full development;

WHEREAS, the 1987 Philippine Constitutions mandates that the State shall promote and protect the right of all citizens to quality education at all levels and shall take appropriate steps to make education accessible to all;

WHEREAS, education is accorded with paramount importance towards the full development of the human resource of the municipality in particular and the country at large;

WHEREAS, the Sangguniang Bayan firmly believes that education is an effective tool in emancipating the underprivileged sector of our society from the bondage of poverty, thus legislative undertakings such as the establishment of a local college/local higher learning institution will definitely transform deserving students with the desired competitive work knowledge, skills and values that are essential to their progressive living as individuals and members of the community and society;

WHEREAS, a significant number of families in the municipality fail to send their children for college education because of their inability to cope with the prohibitive cost in private higher learning institutions, additional transportation allowance and accommodation expenses;

WHEREAS, the marginalized youth with capability to pursue college education must be provided with equal access to quality and affordable higher education;

WHEREAS, cognizant of the very important role that a college education to building a strong foundation in arming the youth for community and nation building, the Honorable Mayor thru the Committee on Education, Culture and Science proposed the establishment of a local college that will offer different degree courses in the fields of education, programs allied to information technology, and other disciplines as the need arises;

WHEREAS, the establishment of the college will serve as an important legacy in building a brighter life for our youth today and in the future.

NOW, THEREFORE;

Be it ordained by the Sangguniang Bayan of Barugo, Leyte, in session duly assembled, that:

**ARTICLE I – GENERAL PROVISIONS**

SECTION 1. TITLE. This Ordinance shall be known as the CHARTER of the local college to be known as BARUGO BAYVIEW COLLEGE.

SECTION 2. FUNDAMENTAL PRINCIPLES. The establishment of the local college shall be guided by the following fundamental principles:

- a. The basic education level must be sustained by means of a specialized formal training through an affordable, accessible, and high standard of collegiate education;
- b. The basic right to higher education of every capable individual must be respected and be given equal opportunity for development in his/her chosen field of specialization;
- c. The local college will serve as a catalyst for human development, cultural convergence and unity; and
- d. The local college shall pursue disciplines of study that significantly contributes to progress and development.

SECTION 3. VISION, MISSION AND OBJECTIVES. The Board of Trustees (BOT) of Barugo Bayview College shall set the vision and strategic direction of the College.

SECTION 4. The Barugo Bayview College, hereinafter referred to as the College, shall primarily provide higher and globally competitive professional courses in, such as but not limited to, the arts and sciences leading to degrees in education, criminology, computer science, business administration, hotel and restaurant management and nursing as well as short-term technological or vocational instruction and training in computer science, computer secretarial, agriculture and fishery as the Board of Trustees may deem necessary to meet the demands of employment and industry.

**ARTICLE II – INTERNAL GOVERNANCE**

SECTION 5. COMPOSITION OF THE GOVERNING BOARD. The governance of the College is hereby vested in and exercised by a Board of Trustees to be known as the **Board of Trustees of the Barugo Bayview College**. The Board of Trustees (BOT) shall be composed of the following:

Chairperson: Local Chief Executive  
Vice Chairperson: President or equivalent position of BBC

Members:

- President of the duly recognized Faculty Association;
- President of the duly recognized Supreme Student Council/Government;
- President of the duly recognized Alumni Association;
- Chairperson of the Sangguniang Bayan Committee on Education;

- Representative of the Department of Science and Technology or the Representative of the Department of Agriculture;
- Representative from the duly-recognized Business or Industry Sector, to be appointed by the BOT for a term of two years;
- Representative from the Commission on Higher Education (CHED), as permanent resource person, designated by the CHED Chairperson; and
- A representative from the Regional Office of the National Economic and Development Authority may be invited as a resource person.

The College constitutes a body corporate and as such is endowed with the attributes of perpetual succession of a corporation and possessed with such powers which pertain to a College to be exercised in conformity with the provisions of its Charter and the Revised Corporation Code of the Philippines. The College shall have the following corporate powers:

- To sue and be sued; to contract and be contracted with;
- To own and hold such real and personal property as shall be necessary for corporate purposes;
- To receive real and personal property by gift, devise or bequest;
- To adopt bylaws, rules and regulations;
- To exercise all the general powers of a corporation under the Revised Corporation Code;
- To have a continuous succession in its corporate name;
- To have and use a corporate seal;
- To exercise such powers as are granted by the Sangguniang Bayan of Barugo, Leyte, subject to the limitations provided in this ordinance and other pertinent laws; and
- To perform all such acts as may be necessary in furtherance of its purposes.

**SECTION 6. FUNCTIONS OF THE BOARD OF TRUSTEES.** The College shall exercise the general powers prescribed by this Ordinance in order to carry out and perform the powers and functions which are hereby vested exclusively in the Board of Trustees. The Board of Trustees is the highest policy-making body of the College and, as such, shall:

- set the vision and strategic direction of the College, ensuring its alignment with the LGU's development agenda, higher education agenda, and the national government's thrust;
- establish effective and efficient structure of the College;
- ensure sound financial management; and
- approve plans or policies related to the overall governance of the College.

Specifically, the Board of Trustees shall have the following duties and responsibilities:

- establish policy guidelines, rules, regulations and procedures not contrary to law and which are necessary to carry the purpose and function of the College, and ensure participative decision-making and transparency within the institution;
- approve academic arrangements for capacity building of the institution, with appropriate institutions and agencies, public or private, local or foreign, and to appoint experts/specialists as consultants, or visiting or exchange professors, scholars, researchers, as the case may be, consistent with the provisions of the Transnational Higher Education Act (RA No. 11448), and other guidelines of CHED relative to such academic arrangements;

- c. approve the curricula, institutional programs and rules of discipline drawn by the administrative and academic councils in accordance with the existing CHED Policies, Standards and Guidelines;
- d. set policies on admission, retention and graduation of students;
- e. award honorary degrees upon persons in recognition of outstanding contribution in the field of education, public service, arts, science and technology or in any field of specialization within the academic competence of the College, subject to the existing CHED guidelines, and to authorize the award of certificates of completion of non-degree and nontraditional courses, subject to existing CHED policies and guidelines;
- f. ensure the efficient management of non-academic services such as medical and dental, guidance and counseling, career and job placement, canteen, buildings, grounds, property maintenance and similar services;
- g. institutionalize and strengthen research and extension programs;
- h. recommend to the Local Chief Executive the appointment of President/Administrator or equivalent position of the College from the list of three (3) qualified candidates/ applicants based on the search made under Section 12 of CHED Memorandum Order No. 18 Series 2022;
- i. recommend to the Local Chief Executive the appointment/designation of the vice presidents, deans, directors, heads of departments, faculty members and other officials and employees whose salaries and wages are wholly or mainly paid out of the local funds and whose appointments are not otherwise provided for under RA No. 7160, as well as those the Local Chief Executive may be authorized by law to appoint;
- j. fix the tuition fees and other necessary school charges such as, but not limited to, matriculation fees, graduation fees and laboratory fees, as the board may deem proper to impose after due consultations with the involved sectors subject to compliance with existing CHED policies, standards and guidelines;
- k. adopt and implement a socialized scheme of tuition and school fees for greater access to poor but deserving student, if in case the College is not a recipient of a government subsidy;
- l. coordinate with the Sangguniang Bayan to provide for the regular support for the development, operation, and maintenance of the College;
- m. recommend to the Sangguniang Bayan policies on higher education and other related development legislation on effective governance and management;
- n. approve consortia and other forms of linkages with local government units, institutions and agencies, both public and private, local and foreign, in furtherance of the purposes and objectives of the institution including its Internationalization initiatives;
- o. receive and appropriate budget as may be provided, to support of the institution in the manner it may determine, in its discretion, to carry out the purposes and functions of the College;
- p. receive in trust legacies, gifts and donations of real and personal properties of all kinds, to administer and dispose of the same when necessary for the benefit of the College, subject to limitations, directions and instructions of the donors, if any. Administer the same in the absence of specific directives of the donor. Such donations shall be subject to applicable laws on tax exemptions on donations and gifts, and all applicable laws;
- q. recommend to and implement the Local Government Unit-approved construction or repair of its buildings, machineries, equipment and other facilities and the purchase and acquisition of real and personal properties including necessary supplies, materials and equipment. Purchases and other transactions entered into by the College through the Board of Trustees shall be subject to applicable laws on tax exemptions on donations and gifts, and all applicable laws;

- r. approve salaries of faculty members and administrative officials and employees subject to the provisions of the revised compensation and classification system and other pertinent budget and compensation laws governing hours of service, and such other duties and conditions as it may deem proper; to grant them, at its discretion, leaves of absence under such regulations as it may promulgate, any provisions of existing law to the contrary notwithstanding; and to remove them for cause in accordance with the requirements of due process of law;
- s. approve the absorption/adoption of LGU acquired non-chartered tertiary institutions within the College in coordination with the CHED and other relevant agencies and to offer therein needed programs or courses, to promote and carry out equal access to educational opportunities mandated by the Constitution;
- t. establish chairs in the College and to provide fellowships for qualified faculty members and scholarships to deserving students;
- u. authorize, as may be needed, an external management audit of the institution to institute reforms, including academic and structural changes, on the basis of the audit results and recommendations;
- v. approve the set up on the adoption of modern and innovative modes of transmitting knowledge through different teaching and learning modalities subject to CHED requirements;
- w. seek technical advice and updates from the CHED Resource Person pertaining to the College operations; institutionalize and strengthen programs that prioritize and support the LGU's development programs and capacity development needs;
- x. establish, maintain and institute mechanisms to share with the LGU and stakeholders, a knowledge-base of the College's experts and resources to support LGU governance and administration processes; and,
- y. delegate specific duties and responsibilities provided for hereinabove to the President /Administrator or equivalent position and/or other officials of the College as it may deem appropriate so as to expedite the administration of the affairs of the College.

SECTION 7. **Secretary of the College Board of Trustees.** The Board of Trustees shall designate a secretary who shall serve as such for both the Board of Trustees and the College and shall keep all records and proceedings of the Board of Trustees. The Secretary shall communicate to each member of the Board of Trustees notice of meetings.

SECTION 8. **Regular Meetings.** Regular meetings of the Board shall be held quarterly every first Thursday of the quarter, or any day fixed by the board, at the College or in any other place in the Municipality of Barugo as determined by the board from the last preceding meeting.

SECTION 9. **Special Meetings.** Special meetings of the Board shall be held at the College or in any place in the Municipality of Barugo upon the call of the chairman or the majority of the Board members with at least 24-hour notice, stating the date, time and purpose. No items other than the stated purpose of the special meeting shall be undertaken during the special meeting.

SECTION 10. A **written notice** to the Board members stating the date, time and agenda of the regular meeting shall be served personally at least three (3) days before the meeting is held.

SECTION 11. **Quorum.** A majority of all the members shall constitute a quorum to transact official business and decide any question at the meeting.

**SECTION 12. Order of Business.** The order of business of the meetings of the Board shall be as follows:

- a. Call to order
- b. Prayer
- c. Roll Call
- d. Approval of the minutes of the previous meeting
- e. Ratification of all the acts and/or resolutions approved by the Ex-Com
- f. Calendar of Business for the Day
- g. Adjournment

**SECTION 13. Voting.** Each member of the Board shall be entitled to one vote and no proxy is allowed.

**SECTION 14. Qualifications.** All members of the Board shall be bonafide citizens of the Philippines with proven expertise and ability, unquestionable reputation and probity

**SECTION 15. Vacancy.** In case of vacancy in the Board by reason of resignation, removal from office, death or any other incapacity of one or more of its members, such vacancy shall be filled accordingly by the proper designating/appointing authority.

**SECTION 16. Compensation.** The members of the Board shall serve without compensation except for the reasonable allowances or per diem as may be authorized by the board.

### ARTICLE III – ADMINISTRATION AND OPERATION

**SECTION 17. The Administration.** The administration of the College shall be vested in the President/Administrator or equivalent position who shall render full-time service. The powers and duties of the President/Administrator or equivalent position in the College, in addition to those specifically provided in this Ordinance, shall be those usually pertaining to the Offices of the President of other colleges/universities, and those delegated by the Board of Trustees. The President/Administrator or equivalent position shall have a term of four (4) years and shall be eligible for reappointment for another term only. The President/Administrator or equivalent position shall hold an earned doctoral degree, defined as level 8 in the Philippine Qualifications Framework (L8) as stipulated in PQF-National Coordinating Council Resolution No. 2014-03 adopted on December 11, 2014 and its amendments thereafter, from a CHED-recognized higher learning institution, with at least five (5) years of relevant administrative experience.

In case of vacancy by reason of death resignation, removal for cause or incapacity of the President/Administrator or equivalent position to perform the functions of their office, the Board shall immediately recommend to the Local Chief Executive the designation of an officer-in-charge (OIC), with the same qualifications as required of a President. The designation shall not exceed a period of one (1) year, renewable for another one year, pending the appointment of a new President/Administrator or equivalent position, subject to existing CSC Rules. The Board shall immediately create and convene the Search Committee for President (SCP).

**SECTION 18. Organizational Structure and Functions.** Within three (3) months of the appointment of the President or Acting President, he/she shall submit to the Board of Trustees for approval and concurrence by the Sangguniang Bayan the organizational structure and functions of the College together with its organizational chart.

Subject to subsequent compliance with CHED requirements, the Board of Trustees may appoint a President and other officers of the College (such as the Acting Vice-President for Administration, Acting Vice-President for Academic Affairs, Registrar, etc.) to serve on a full-time basis for a term of one year or until their permanent successors shall have been appointed and qualified, whichever is sooner. Their compensation shall be fixed by the Board.

**SECTION 19. Search Process and Minimum Qualifications of the College President.** The Search Process and Minimum Qualifications for the College President are based on the applicable provisions of CHED Memorandum Order No. 7 Series 2022. With regard to the search for qualified applicants for the position, and appointment, of College President, the SCP shall be guided by the search process and minimum qualifications as set forth in Annex “E” of CHED Memorandum Order No. 18 Series 2022.

**SECTION 20. Basic/Manpower Complement.** The following are the basic or mandatory plantilla positions of the College:

President/Administrator or equivalent position		1
Registrar		1
Librarian		1
Guidance Counselor		1
Nurse		1
Faculty Positions (Full-Time)		10

Other plantilla positions may be created according to the needs of the College subject to the approval of the Sangguniang Bayan.

\*The position and salary grade for each plantilla position shall be in accordance with the **Index of Occupational Services, Position Titles and Salary Grades in the Local Government (IOS-LGU)** of the Department of Budget and Management.

**SECTION 21. Faculty.** The composition of the members of the faculty of the College shall be selected based on standards set by the Commission on Higher Education and existing policies of the Civil Service Commission and other meritorious performances.

**SECTION 22. Appointment of Faculty Members.** The members of the faculty of the College shall be recommended for appointment by the President and shall be approved by the Board.

**SECTION 23. Non-Teaching Personnel.** The non-teaching personnel shall be composed of college employees performing non-teaching duties and functions. The members of the non-teaching personnel shall be recommended for appointment by the President subject to the approval of the Board.

**SECTION 24. Student Admission.** Preference in the admission of students shall be given to the bonafide residents of Barugo subject to the selection and admission policies approved by the Board, provided, however, that no student shall be denied admission to the College by reason of age, sex, religious, belief, or political affiliation.

**SECTION 25. Student Academic Policies, Systems and Processes.** Policies to be implemented with regard to the following shall be approved by the Board and made available to stakeholders through manuals, memos and other printed materials:

1. Recruitment, Admission and Retention;
2. Student Loading;
3. Student Discipline;
4. Grading System; and
5. Promotion, Graduation and Job Placement.

**SECTION 25. College Councils.** The Board of Trustees, as it may deem necessary, shall create the College Academic Council, the College Administrative and other councils setting forth their functions, duties and responsibilities.

### ARTICLE IV – MISCELLANEOUS PROVISIONS

**SECTION 31. Board of Visitors.** The Mayor and the members of the Sangguniang Bayan of Barugo shall constitute the Board of Visitors of the College whose duties and functions are the following:

- a. To attend the commencement exercise of the college;
- b. To conduct visits at the college at any time possible as it may deem proper;
- c. To inspect and evaluate the books of accounts, properties, programs of study, discipline and state of finances of the college; and
- d. To submit reports and recommendations to the Sangguniang Bayan relative to the exercise of its duties and functions.

**SECTION 32. Reports.** The Board of Trustees shall submit to the Sangguniang Bayan an audited annual financial report and on the progress and condition of the college.

**SECTION 33. Accounting Reports.** The New Government Accounting System prescribed by the Commission on Audit shall be implemented to provided adequate information to the needs of the users of financial reports. All accounts and expenses therefor shall be audited by the Commission on Audit or its duly authorized representative

**SECTION 34. Funding –** The Municipal Government of Barugo shall ensure fiscal autonomy of the college, and as provided for by law, and to this end the Sangguniang Bayan shall establish a College Educational Development Fund which shall consist of the following:

- a. Collections from tuition and other school fees which are affordable and reasonable to be automatically retained by the college;
- b. Five percent (5%) of the NTA and from the proceeds of collections from market stall fees and other local fees collected by the municipality, subject to the approval by the Sangguniang Bayan, which shall be released automatically by the Municipal Treasurer to the College;
- c. Subsequent Municipal Government appropriations for the College shall be based on need as may be recommended by the Board, taking into consideration factors of necessity, beneficially and equity, subject to the approval of the Sangguniang Bayan.
- d. Proceeds from grants and donations from individuals, the national government, local and international funding institutions or foreign governments; and

- e. Subject to the approval of the Municipal Mayor and the concurrence of the Sangguninag Bayan, the amount collected for the College Educational Development Fund shall be appropriated by the Board of Trustees of the College, exclusively for the improvement of its facilities and equipment, library, school buildings and upgrading of the salaries and allowances of its faculty and support personnel including faculty and staff development.
- f. The site of the College shall be the existing building on the east side of the Barugo Integrated Bus Terminal and/or any other existing municipal facilities appropriate for the purpose as may be determined by the Local Chief Executive. Initial funding in the amount of not more than One Million Pesos (P1,000,000.00) for preparatory works in minor renovation of the selected facility may be sourced from savings from the 2024 and prior fiscal years.

**SECTION 35. Transitory Provision.** The Board of Trustees shall approve the provisional organizational chart of the College as recommended by the College President and shall remain as the table of organization until amended or revised. Except those which require additional funds, the Municipal Mayor is authorized to enter into any and all agreements, execute any and all documents, and do any and all acts and things as he may deem just and proper to effectuate the creation of Barugo Bayview College for the best interest of the City and its constituents.

**SECTION 37. Separability Clause.** If any provision of this Ordinance is held invalid or unconstitutional, any other provision not so affected shall continue to be valid and effective.

**SECTION 38. Repealing Clause.** Any Municipal Ordinance or Resolution and its rules and regulations, or any part thereof, which are inconsistent with any of the provisions of this Ordinance are hereby repealed or amended accordingly.

**SECTION 39. Effectivity Clause.** This Ordinance shall take effect upon its approval.






