

The newly- created positions is made part and integral element of the FY 2024 PLANTILLA OF POSITIONS incorporated in the FY 2024 ANNUAL GENERAL FUND BUDGET of the Local Government Unit of Santa Fe, Leyte and will be automatically funded from hereon.

Section 7. Repealing Clause

All previous ordinances and issuances inconsistent with this ordinance are deemed amended and / or repealed.

Section 8. Effectivity

This ordinance shall take effect after the final review of the members of the Sangguniang Panlalawigan of Leyte and the requirement of posting is complied with.
