¹ Section 447 (viii)- Determine the positions and salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds and provide for expenditures necessary for the proper conduct of programs. projects, services, and activities of the municipal government;

² Section 76- Organizational Structure and Staffing Pattern. - Every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission.

SECTION 1. CREATION AND QUALIFICATION STANDARDS- The following position is hereby created with their respective salary grade and qualification standards, wit:

1. MIDWIFE IV

Salary Grade: 15 /~

Education: Completion of the Midwifery Course Experience: 3 years of relevant experience Training: 16 hours of relevant training

Eligibility: RA 1080

No. of Personnel (Item) - 1

SECTION 2. POWERS, DUTIES AND FUNCTIONS. The powers, duties, and functions of the above-stated position shall be based on the provisions of the Local Government Code of 1991, the Civil Service Commission (CSC), and other relevant laws, rules, and regulations.

SECTION 3. FUNDING. The newly created position is made an integral part of the plantilla of positions of the Local Government Unit of Tabango and shall be funded accordingly.

SECTION 4. SEPARABILITY CLAUSE - If for any reason/s, any part of the provision of this ordinance shall be held unconstitutional or otherwise invalid, other parts or provisions hereof which are not affected thereby shall be in full force and effect.

SECTION 5. EFFECTIVITY CLAUSE - This ordinance shall take effect upon its approval.
