



Respectfully returned to the Sangguniang Panlalawigan of Leyte, through SP Secretary, the attached Ordinance No. 10 S. 2024 of the Sangguniang Bayan of Capoocan Leyte.

#### Issues/concerns for review/recommendation/legal opinion is/are as follows:

Ordinance No. Ordinance No. 10 S. 2024 entitled: <u>An Ordinance Amending Article E, Service Fees for Health Examination</u>, of <u>Municipal Ordinance No. 36</u>, Series of 2020 entitled "Revenue Code of the <u>Municipality of Capoocan</u>, <u>Leyte.</u>

#### REVIEW/RECOMMENDATION/LEGAL OPINION:

This office is of the opinion that the subject Ordinance is within the corporate powers of the local government unit particularly covered under Section 447 of the Local Government Code.

The power of local government to levy taxes, fees and charges is provided in the under Section 5<sup>1</sup>, Article X, of the 1987 Constitution.

To appropriately rule on the validity of this Ordinance, the LGU's exercise of the taxing powers must conform to the fundamental principles that taxes and charges must be equitable, be levied and collected only for public purposes, must not be unjust, excessive, oppressive, or confiscatory, must not be contrary to law, public policy, national economic policy, or in restraint of trade. Hence, it is recommended that inquiry on propriety of the rates in comparisson to the 2020 Revenue Code and its basis for such amendment must be inquired upon to ensure conformity to said mentioned principles.

Moreover, the revenue collected shall be used solely for the benefit of, and be subject to disposition by the local government unit levying the tax, fee, charge or other imposition unless other otherwise provided.

We hope to have assisted you with this request.

Please note that the opinion rendered by this Office are based on facts available and may vary or change when additional facts and documents are presented or changed. This opinion is likewise without prejudice to the opinions rendered by higher and competent authorities.

<sup>&</sup>lt;sup>1</sup> Section 5. Each local government unit shall have the power to create its own sources of revenues and to levy taxes, fees and charges subject to such guidelines and limitations as the Congress may provide, consistent with the basic policy of local autonomy. Such taxes, fees and charges shall accrue exclusively to the local governments.

**BE IT ENACTED** by the *Sangguniang Bayan* of the Municipality of Capoocan, Province of Leyte in Regular Session duly assembled that:

SECTION 1. Article E, Section 4E.01 of Municipal Ordinance No. 36, Series of 2020 is hereby amended to read as follows:

#### SERVICE FEES FOR HEALTH EXAMINATION

**Section 4E.01. Imposition of Fees.** There shall be collected a fee of Fifty Pesos (P50.00) from any person who is given a physical examination by the Municipal Health Officer or his duly authorized representative, as required by existing ordinances.

A fee of Twenty Pesos (P20.00) shall be collected for each additional copy or subsequent issuance of a copy of the initial medical certificate issued by the Municipal Health Officer.

## Section 2. Article E, Section 4E.05 of Municipal Ordinance No. 36, Series of 2020 is hereby amended to read as follows:

A twenty percent (20%) discount shall be given to Senior Citizens and Persons with Disability (PWD).

Senior citizens, students and PWDs are exempted to pay when securing a medical certificate.

**Section 3. Separability Clause –** If any provision of this Ordinance is declared invalid, the remainder or any provision hereof not affected thereby shall remain in force and effect.

**Section 4. Repealing Clause.** Any ordinance found inconsistent hereof, in whole or in part, is hereby repealed or modified accordingly.

**Section 5. Effectivity.** This ordinance shall take effect upon compliance of the mandatory posting and publication requirements prescribed under Republic Act No. 7160, otherwise known as the Local Government Code of 1991.

#### MUNICIPAL ORDINANCE NO. 36, S. 2020

# AN ORDINANCE AMENDING ORDINANCE NO. 309 SERIES OF 2016, "REVENUE CODE OF THE MUNICIPALITY OF CAPOOCAN, LEYTE"

Be it ordained by the *Sangguniang Bayan* of the Municipality of Capoocan, Province of Leyte in regular session assembled that:

#### REVENUE CODE OF THE MUNICIPALITY OF CAPOOCAN, LEYTE

#### **CHAPTER I. GENERAL PROVISIONS**

#### ARTICLE A. SHORT TITLE AND SCOPE

Section 1A.01. Title – This ordinance shall be known as the Revenue Code of the Municipality of Capoocan, Province of Leyte.

**Section 1A.02. Scope and Application** – This Code shall govern the levy, assessment, and collection of taxes, fees, charges and other impositions within the territorial jurisdiction of this municipality.

#### ARTICLE B. CONSTRUCTION OF PROVISIONS

Section 1B.01. Words and Phrases Not Herein Expressly Defined. Words and phrases embodied in this Code not herein specifically defined shall have the same definitions as found in RA 7160, otherwise known as the Local Government Code of 1991.

**Section 1B.02. Rules of Construction.** In construing the provisions of this Code, the following rules of construction shall be observed unless inconsistent with the manifest intent of the provisions.

(a) General Rules. All words and phrases shall be construed and understood according to the common and approved usage of the language; but the technical words and phrases and such other words in this Code which may have acquired a peculiar or appropriate meaning shall be construed and understood according to such technical, peculiar or appropriate meaning.

(b) Gender and Number. Every word in the Code importing the masculine gender shall extend to both male and female. Every word importing the singular number shall apply to several persons or things as well; and every word importing the plural number shall extend and be applied to one person or thing as well.

**Section 4C.02. Time of Payment.** The service shall fee provided under this Article shall be paid to the Municipal Treasurer upon application for police clearance certificate.

#### ARTICLE D. SANITARY INSPECTION FEE

**Section 4D.01. Imposition of Fee.** There shall be collected the following annual fees from each business establishment in this municipality or house for rent, for the purpose of supervision and enforcement of existing rules and regulations and safety of the public in accordance with the following schedule:

**Section 4D.02. Time of Payment.** The fees imposed in this Article shall be paid to the Municipal Treasurer upon filing of the application for the sanitary inspection certificates with the Municipal Health Officer and upon renewal of the same every year thereafter within the first twenty (20) days of January.

#### Section 4D.02. Administrative Provisions.

- (a) The Municipal Health Officer or his duly authorized representatives shall conduct an annual inspection of all establishments and buildings, and accessories and houses for rent, in order to determine their adequacy of ventilation, general sanitary conditions and propriety for habitation.
- (b) The Municipal Health Officer shall require evidence of payment of the fee imposed herein before the sanitary inspection certificate.

#### ARTICLE E. SERVICE FEES FOR HEALTH EXAMINATION

**Section 4E.01. Imposition of Fees.** There shall be collected a fee of Fifty Pesos (P50.00) from any person who is given a physical examination by the Municipal Health Officer or his duly authorized representative, as required by existing ordinances.

**Section 4E.02. Time of Payment.** The fee shall be paid to the Municipal Treasurer before the physical examination is made and the medical certificate is issued.

#### Section 4E.03. Administrative Provisions.

- (a) Individuals engaged in an occupation or working in the following establishments, are hereby required to undergo physical and medical examination before they can be employed and once every six months (6) thereafter.
  - 1. Food Establishments establishments where food or drinks are manufactured processed, stored, sold or served.
  - 2. Public swimming or bathing places.
  - 3. Dance schools, dance halls and nightclubs (including dance instructors, hostess, cooks, bartenders, waitresses, etc.), videoke and karaoke bars.
  - 4. Tonsorial and beauty establishments (including employees of barber shops, beauty parlors, hairdressing and manicuring establishments, exercise gyms and figure slandering saloons, facial centers, aromatherapy establishments, etc.).
  - 5. Massage clinics and sauna bath establishments (including masseurs, massage clinic/sauna bath attendants, etc.).
  - 6. Hotel, motels and apartments, lodging, boarding, or tenement houses, and condominiums.

(b) Owners, managers or operators of the establishments shall see to it that their employees who are required to undergo physical and medical examinations have been issued the necessary medial certificates.

(c) The Municipal Health Officer shall keep a record of physical and other health examinations conducted, and the copies of medical certificates issued indicating the name of the applicant, the date and the purpose for which the examinations was made.

**Section 4E.04. Penalty.** A fine of One Hundred Pesos (P100.00) shall be paid by the owner, manager or operators of the establishment for each employee found to be without the necessary medical certificates.

**Section 4E.05. Exemption.** A twenty percent (20%) discount shall be given to Senior Citizens and Person with Disability (PWD).

#### ARTICLE F. DOG VACCINATION FEE

**Section 4F.01. Imposition Fee.** There shall be collected/imposed from every owner of the dog a vaccination fee of *Fifty Pesos (P50.00)* for every dog vaccinated within the territorial jurisdiction of this municipality.

Registration and License Fee: P100.00

**Section 4F.02. Time of Payment.** The fee shall be paid to the Municipal Treasurer prior to the vaccination of the dog in close coordination with the Municipal Agricultural Office and the Office of the Provincial Veterinarian.

#### Section 4F.03. Administrative Provisions.

- Vaccination Against Rabies means the inoculation of a dog with rabies vaccine licensed for the species by the Bureau of Animal Industry, Department of Agriculture. Such vaccination must be performed by trained individual from BAI, Provincial Veterinarian Office and Municipal Agriculture Office.
  - (a) Every dog 3 months of age and older should be submitted by the owner for vaccination against rabies every year. Young dogs shall be vaccinated within thirty (30) days after they have reached three months of age.
  - (b) During free mass dog rabies vaccination campaign, every dog three (3) months of age and older should be submitted by the owner for vaccination. Dogs not submitted on the scheduled date or within one month thereafter shall be exterminated under the supervision of the Municipal Rabies Control Authority.

Becomes optional after a mass dog rabies vaccination campaign covering at least 80% of the dog population.

2. It shall be the duly of each trained veterinarian when vaccinating any dog to prepare a complete certificate of rabies vaccination (in duplicate for each animal vaccinated). The certificate shall include the following information.

(a) Owner name, address and telephone number if any

(b) Description of dog (color, sex, marking, age, name, species and breed if any)

(c) Dates of vaccination and vaccine expiration if known

(d) Rabies vaccination tag number

(e) Vaccine produced

(f) Vaccination signature

(g) Veterinarians license number/vaccinator's address

#### CHAPTER VIII. GENERAL PENAL PROVISIONS

**Section 8.01. Penalties for Violation of Tax Ordinance.** Any person or persons who violate any of the provisions of this Ordinance or the rules or regulations promulgated by authority of this Ordinance shall, upon conviction, be punished by a fine of not less than One Thousand Pesos (P1, 000.00) nor more than Two Thousand Five Hundred Pesos (P2, 500.00), or imprisonment of not less than one (1) month nor more than six (6) months, or both, at the discretion of the court.

If the violation is committed by any juridical entity, the President, General Manager, or the individual entrusted with the administration thereof at the time of the commission of the violation shall be held responsible or liable therefor.

Punishment by a fine or imprisonment as herein provided for, shall not relieve the offender from the payment of the tax, fee or charge imposed under this Ordinance.

#### **CHAPTER IX. FINAL PROVISIONS**

**Section 9.01. Separability Clause.** If for any reason, any section or provision of this Ordinance shall be held to be unconstitutional or invalid by competent authority, such judgment or action shall not affect or impair the other sections or provisions thereof.

**Section 9.02. Applicability Clause.** All other matters relating to the impositions in this Ordinance shall be governed by pertinent provisions of existing laws and other ordinances.

**Section 9.03. Repealing Clause.** All ordinances, rules and regulations or part thereof in conflict with, or inconsistent with any provisions of this Code are hereby repealed or modified accordingly.

Section 9.04. Effectivity. This Code shall take effect after the required posting and publication.
