ORDINANCE CREATING THE PLANTILLA POSITION OF LOCAL LEGISLATIVE STAFF OFFICER II (LLSO II) WITH SALARY GRADE 13 AT THE OFFICE OF THE SANGGUNIANG BAYAN OF VILLABA, LEYTE AND APPROPRIATING FUNDS THEREFOR.

**WHEREAS,** the Local Government Code of 1991 provides that the Sangguniang Bayan, as the legislative body of the municipality, shall determine the positions, benefits and other emoluments of officials and employees whose salaries are paid wholly or mainly from municipal funds;

**WHEREAS,** with the advent of R.A. No. 7160, conferring vast powers and duties to the local sanggunian, the office of the Sangguniang Bayan has become one of the busiest offices in the municipal government dealing with voluminous clerical works and other legislative related functions,

WHEREAS, in view of the foregoing and in the interest of effective and efficient legislative office, the creation of the position of Local Legislative Staff Officer II to augment the existing plantilla positions in the Sangguniang Bayan office is deemed a necessity;

WHEREFORE, on motion by the Honorable Rogelio J. Baay, unanimously seconded;

**BE IT ORDAINED** by the Sangguniang Bayan of Villaba, Leyte assembled in session to enact the foregoing ordinance, to wit:

**Section 1. Title:** This ordinance shall be known and cited as: "An Ordinance creating the plantilla position of Local Legislative Staff Officer II (LLSO II) with salary grade 13 at the Office of the Sangguniang Bayan of Villaba, Leyte and appropriating Funds therefor."

**Section 2. Legal Basis:** Section 447, (a),(viii) of the Local Government Code of 1991 provides that the Sangguniang Bayan shall determine the positions and the salaries, wages, allowances and other emoluments and benefits of officials and employees paid wholly or mainly from municipal funds and provide for expenditures necessary for the proper conduct of programs, services and activities of the municipal government.

**Section 3. Duties and Functions:** The Local Legislative Staff Officer II (LLSO II) shall have the following duties and functions among others, to wit:

Section 4. Salary Grade and Funding Source: The position of Local Legislative Staff Officer II shall bear Salary Grade Thirteen (13) which shall be charged against the lump sum appropriation for Personal Services for fiscal year 2025 of the local government of Villaba, Leyte.

Section 5. Separability Clause: If for any reasons, any provision of this ordinance is declared unconstitutional or invalid by the court, or revoked by competent authorities, the remaining provisions not affected thereby shall continue to remain in full force and effect.

Section 6. Repealing Clause: Any previous ordinances, rules and regulations or parts thereof that are in conflict/inconsistent with any provisions of this ordinance are hereby repealed, amended or modified accordingly.

Section 7. Effectivity: This ordinance shall take effect upon its approval.

This Ordinance was approved by the Sangguniang Bayan in its Regular Sassion on July 8, 2024.

MINUTES OF THE COMMITTEE HEARING ON THE "ORDINANCE CREATING THE PLANTILLA POSITION OF LOCAL LEGISLATIVE STAFF OFFICER II, (LLSO II) SALARY GRADE 13, AT THE OFFICE OF THE SANGGUNIANG BAYAN OF VILLABA, LEYTE AND APPROPRIATING FUNDS THEREFOR"

Conducted on July 4, 2024 at the SB Session Hall New Municipal Building 9:30 A.M.

Persons invited to this Committee Hearing were the Municipal Administrator/Human Resource Management officer, the Local Finance Committee, the Vice Chairman and Member of the SB Committee on Employment.

The hearing started when the majority of the invited persons personally appeared and was presided over by the SB Committee Chair concerned.

The participants being furnished beforehand a copy each of the ordinance immediately proceeded with the critique on the said measure.

The Budget Officer spearheaded the critical estimate and discussion about the matter. He emphasized more on the strict policy of COA, especially the younger officers replacing the retired ones, over government expenditures, particularly, on the PS cap. He said that the total income realized for C.Y. 2023 is PHP 191, 255,293.00 x 45% the PS cap or limitation is equal to PHP 86,065,882.00.

According to the Budget Officer, if we are going to approve the Plantilla Position of Local Legislative Staff Officer III, Salary Grade 16, the PS shall be PHP 93,122,592.00 which is over the PS Limitation by PHP 7,057,712.00 or 8.20% which COA will never allow.

Whereas, if we have to adopt the Plantilla Position of Local Legislative Officer II, Salary Grade 13, although it is still over the PS Cap of PHP. 86,065,882.00, there is a possibility that COA would consider the situation on account of the appropriation for the terminal benefits of the four (4) SB members this Calendar Year.

Thus, the recommendation of the Local Finance Committee narrowed down to retaining the original proposal for the creation of a Plantilla Position of the Local Legislative Officer II, Salary Grade 13 at the office of the Sangguniang Bayan, Villaba, Leyte.

There having no other business to deliberate on, the Committee Hearing ended at 10:30 a.m.
