

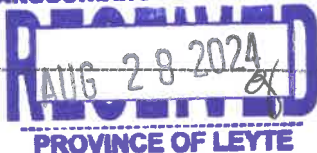

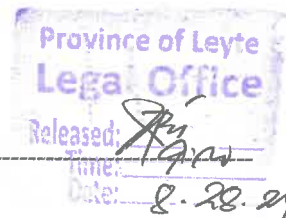

**Issues/concerns for review/recommendation/legal opinion is/are as follows:**

- Ordinance No. 191 series 2024 entitled: **“An Ordinance Granting Cash Incentives to All Individuals, Pairs, or Teams, and their Coaches Who Excels in Academics, Skills, Sports competitions and to All Topnotchers in a National Professional Licensure Examinations and Appropriating Funds Therefore.**

**REVIEW/RECOMMENDATION/LEGAL OPINION:**

This office is of the opinion that the Subject Ordinance is in accordance to its power under Section 16<sup>1</sup> General Welfare Clause of the Local Government Code of 1991 (R.A 7160), Article II, Section 17<sup>2</sup> and Article XIV Section 19(1)<sup>3</sup> of the 1987 Philippine Constitution. Hence, recommending the declaration of its validity.

*Authority, with the active participation of private industries, shall organize and conduct annual National Skills Olympics. The Authority, through the TESDA Secretariat, shall promulgate the necessary rules and guidelines for the effective and efficient conduct of Annual National Skills Olympics and for the country's participation in international skills Olympics."*

WHEREAS, the proclamation No. 125, 1993 of the Office of the President Fidel V. Ramos states that: The government recognizes that persons with disabilities have same rights as other people to take their proper place in society;

WHEREAS, it is the mission of Special Olympics to provide year-round sports training and athletic competition in a variety of Olympic-type sports for children and adults with intellectual disabilities, giving them continuing opportunities to develop physical fitness, demonstrate courage, experience joy and participate in sharing of gifts, skills and friendship with their families, other Special Olympics athletes and the community;

WHEREAS, for bringing honor and prestige to the name of the Municipality of Matag-ob, in the Province of Leyte, the Local Government Unit of Matag-ob deems it right to provide due compensation in the form of cash incentives to these deserving academic, skills, sports competition medalists and National Professional licensure examinations topnotchers;

NOW THEREFORE, IT IS HEREBY ORDAINED BY THE SANGGUNIANG BAYAN OF MATAG-OB, LEYTE THAT:

**Section 1. TITLE.** This Ordinance shall be known as the, "MATAG-OB Excellence Incentive Program".

**Section 2. SCOPE AND COVERAGE.** The participants who may be entitled to the incentives granted by this Ordinance shall be those who have landed as medalists (Gold, Silver, Bronze) in their respective levels of academic, skills, sports and competitions or topnotchers (1<sup>st</sup>. to 10<sup>th</sup>. placer) in national professional licensure examinations.

**Section 3. DECLARATION OF PURPOSE.** It is hereby declared a policy of the Municipality of Matag-ob, Province of Leyte to extend financial incentives to deserving academic, skills, sports competition winners and national





professional licensure examinations topnotchers who give honor to the Municipality of Matag-ob;

**Section 4. DEFINITION OF WORDS AND PHRASES.**  
For the purpose of this ordinance, the terms hereunder mentioned shall be defined as follows:

**A. Academic competitions** – refers to all provincial, regional, ASEAN, Asian and International/worldwide level related competitions and are duly organized, permitted, and/or authorized by the concerned national government agency such as Department of Education (DepEd), Commission on Higher Education (CHED)/Higher Education Institutions (HEIs), Department of Interior and Local Government (DILG).

Academic competitions may be categorized as: but not limited to the following, Math Challenge, Press Con, Technolympics.

**B. Skills competitions** - is the multi-level skills competitions which aim to recognize the skills excellence of young skilled workers and graduates of technical vocational schools and training centers. These competitions are organized and/or sanctioned/authorized or accredited by the Technical Education and Skills Development Authority (TESDA).


For the purpose of this Ordinance, the following are the levels of skills competitions:

1. Provincial;
2. Regional;
3. National;
4. Association of Southeast Asian Nation (ASEAN);
5. Asian and International
6. Worldwide levels.



**D. Paralympics** – a periodic series of multi-sport events involving athletes with a range of physical disabilities.

**E. Special Olympics** – a periodic series of multi-sport events involving athletes with a range of physical disabilities.

**F. National Professional Licensure Examinations.**

National Professional Licensure Examinations – in this ordinance is defined as: Examinations conducted nationwide as per schedule to determine the qualifications of graduates of various professions who seek licensure to practice their respective professions or area of specialization sanctioned by the Professional Regulations Commission (PRC) for the BOARD Exams and the Supreme Court of the Philippines for the BAR exams.

**G. Topnotchers in this ordinance** - is defined as individuals who are officially ranked from top 1 to top 10 of the Board and Bar professional licensure examinations with any corresponding certification from the appropriate administering government agency.

**Section 5. QUALIFICATIONS for participant GRANTEES.** To qualify as a grantee, he/she must:

A. For participants in academic, skills and sports competitions:







An active student in any private or public school in the Municipality of Matag-ob or a student enrolled in any private or public school within the Municipality of Matag-ob, Leyte;

2. Must have duly represented the Municipality of Matag-ob in a Provincial, Regional, National, ASEAN, Asian or International/Worldwide competition as an individual, pair, member and/or team member.

3. Be able to submit an original or a certified true copy of certification or any appropriate documentation/proof that he/she participated and won first, second or third place accordingly in a duly accredited academic, skills or sports competition in the Provincial, Regional, National, ASEAN, Asian, or International/Worldwide Levels;

4. Must claim incentive within 365 days from the day he/she won the medal/s.

B. For Coaches in academic, skills and sports competitions:

1. Duly represented the Municipality of Matag-ob in a Provincial, Regional, National, ASEAN, Asian or International Competition as a coach in an individual, paired and/or team competition event which is composed of at least 50% qualified grantees.

2. Be able to submit an original or a certified true copy of certification or any appropriate documentation/proof that he/she coached the grantee/s who won first, second or third place accordingly in a duly accredited academic, skills or sports competition in the Provincial, Regional, National, ASEAN, Asian or International/worldwide levels.

3. Must claim the incentive within 365 days from the day their athlete won the medal/s.



**C. For National Professional Licensure Examinations Topnotchers:**


1. Be a bonafide resident of the Municipality of Matag-ob with any proof of residency or any appropriate documentation indicating the Municipality of Matag-ob as his/her place of birth.
2. Must provide any original or certified true copy of certification or any appropriate documentation/proof that he/she was officially included in the top ten (10) highest ranking passers in his/her national professional licensure exams.
3. Must claim the incentive within 365 days from the day of the announcement of the national professional examination official result.







**Section 7. CREATION OF THE MATAG-OB EXCELLENCE INCENTIVE COMMITTEE.** The Matag-ob Excellence Incentive Committee (MEIC) is hereby created, which is primarily tasked to judiciously screen applicants based on the qualifications set forth in this Ordinance.

A. Composition. The Matag-ob Excellence Incentive Committee (MEIC) shall be composed of the following:

- Chairman : Municipal Mayor
- Co-chairman : SB Chairman Cmte. on Education
- Members : Mun. SK Federation President
- : SB Chairman Cmte on Sports
- : DepEd Personnel who are local residents of Matag-ob (maximum of 5)
- : Municipal Social Welfare and Development Officer (MSWDO)
- : Municipal Local Government Operations Officer (MLGOO)
- : Any LGU employee who is a local resident of Matag-ob, Leyte

B. All DepEd and LGU personnel to be included in the Committee's original composition shall be named through a Sangguniang Bayan Resolution or an Executive Order issued by the Municipal Mayor.

C. The Committee shall have the power to make changes in its original LGU and DepEd members as long as qualifications are met.

2. Municipal Social Welfare and Development





**Section 10. Separability Clause.** If, for any reason/s, any part or provision of this Ordinance be held unconstitutional or invalid, other parts or provisions hereof which are not affected thereby shall continue to be in full force and effect.

**Section 11. Repealing Clause.** All ordinances, as well as pertinent rules and regulations thereof, which are inconsistent with the provisions of this Ordinance are hereby repealed or amended accordingly.

**Section 12. Amendments.** This ordinance may be amended or modified as necessary through appropriate legislative process.

**Section 13. Effectivity Clause.** This ordinance shall take effect Ten (10) days within its approval and shall be published for three (3) consecutive weeks in a newspaper of a local circulation.
