• Ordinance No. 03 Series of 2024 entitled: "An Ordinance Amending Municipal Ordinance No. 03, Series of 2005, Prescribing Thereto the New Tariff Rates on Tricycad/Potpot Units in the Municipality of Merida, Leyte, and Imposing a Daily Terminal Fee Thereof."

#### **REVIEW/RECOMMENDATION/LEGAL OPINION:**

This office is of the opinion that the Subject Ordinance is in accordance to its power under Section 447 (1)(iii)<sup>1</sup> and (3)(vi)<sup>2</sup> of the Local Government Code of 1991 (R.A 7160).

Likewise as settled in the case of Constantino v. Desierto 288 SCRA 654, it is within the power of the Local Council to repeal or amend its prior acts either expressly, or by the passage of an essentially inconsistent resolution.

Said ordinance is consistent with the authority devolved by LTO to the Local Government to determine, fix, prescribe or periodically adjust fares or rates for the service provided in a zone after public hearing. Hence, recommending the declaration of its validity.

This opinion is likewise without prejudice to the opinions rendered by higher and competent authorities and/or the courts.

SECTION 3. The duly licensed potpot operator shall secure the "taripa" and shall pay a corresponding fee of Twenty-Five Pesos (Php25.00) and imposing a daily Terminal Fee of Five Pesos (Php5.00) only.

SECTION 4. Failure to secure the TARIPA will cause the impoundment of the respective tricycad/potpot unit.

SECTION 5. Penalty – Violation of Section 2 in this Ordinance is subject to a fine of Three Hundred Pesos (Php300.00) each for the duly licensed driver and operator for first offense; Five Hundred Pesos (Php500.00) each for second offense; and Six Hundred Pesos (Php600.00) and cancellation of permit to drive and operate on the third offense.

SECTION 6. Effectivity – This Ordinance shall take effect upon its approval.
