2nd INDORSEMENT

August 22, 2024

Respectfully returned to the Sangguniang Panlalawigan of Leyte, through SP Secretary, the attached Ordinance No. 23L.24-054 of the Sangguniang Bayan of Kananga, Leyte.

Issues/concerns for review/recommendation/legal opinion is/are as follows:

Ordinance No. 23L.24-054 entitled: "An Ordinance Reclassifying Lot No.1-B-1, PSD-08-028756-D with an Area of 5,252 Square Meters, Situated in Barangay Lonoy, Kananga, Leyte from Agricultural Land Use to Agro-Industrial Land Use.

REVIEW/RECOMMENDATION/LEGAL OPINION:

This office is of the opinion that the subject Ordinance is within the corporate powers of the local government unit particularly covered under Section 447 of the Local Government Code.

Moreover, Section 20.¹ Chapter 1 of the Local Government Code, empowered the city or municipality through an ordinance, to reclassify agricultural land when the land ceases to be economically feasible and sound for agricultural purposes as determined by the Department of Agriculture or where the land shall have substantially greater economic value for residential, commercial, or industrial purposes, as determined by the sanggunian concerned. Reclassification likewise finds support under Section 3, Article XII of the 1987 Constitution².

It must be noted however, that the power of the LGUs to reclassify agricultural lands is not absolute. The authority of the DAR to approve conversion of agricultural lands covered by Republic Act No. 6657 to non-agricultural uses has been validly recognized by said Section 20 of Republic Act No. 7160 by explicitly providing therein that, "nothing in this section shall be construed as repealing or modifying in any manner the provisions of Republic Act No. 6657."

Hence, recommending the declaration of its validity.

¹ Section 20. Reclassification of Lands. - xxx (a) A city or municipality may, through an ordinance passed by the sanggunian after conducting public hearings for the purpose, authorize the reclassification of agricultural lands and provide for the manner of their utilization or disposition in the following cases: (1) when the land ceases to be economically feasible and sound for agricultural purposes as determined by the Department of Agriculture or (2) where the land shall have substantially greater economic value for residential, commercial, or industrial purposes, as determined by the sanggunian concerned: Provided, That such reclassification shall be limited to the following percentage of the total agricultural land area at the time of the passage of the ordinance.

² Section 3. Lands of the public domain are classified into agricultural, forest or timber, mineral lands and national parks. Agricultural lands of the public domain may be further classified by law according to the uses to which they may be devoted. Alienable lands of the public domain shall be limited to agricultural lands. xxx

AN ORDINANCE RECLASSIFYING LOT NO. 1-B-1, PSD-08-028756-D WITH AN AREA OF 5,252 SQUARE METERS, SITUATED IN BARANGAY LONOY, KANANGA, LEYTE FROM AGRICULTURAL LAND USE TO AGRO-INDUSTRIAL LAND USE.

PREFATORY STATEMENT

WHEREAS, the spouses Ferdinand B. Borela and Gina Linda D. Borela, the owners of Lot No. 1-B-1, Psd-08-028756-D with an area of 5,252 square meters, situated in Barangay Lonoy, Kananga, Leyte, thru a letter dated November 15, 2023 duly signed by Mr. Borela, requested the Sangguniang Bayan for reclassification of the use of the said land from agricultural to agroindustrial;

WHEREAS, the submitted documents include the Transfer Certificate of Title No. 115-2018000159 covering the land, Tax Declaration, Subdivision Plan, Certificate of Zoning Compliance, Certification from the Municipal Agriculture Office, National Irrigation Administration and Certification from the DAR;

WHEREAS, an intensive perusal of the proposed reclassification was jointly conducted by the Committee on Rules and Laws and the Committee on Urban Development, Zoning and Public Works, and after series of meetings and consultation, and the applicants' compliance of the required documents, positive view regarding the classification was recommended as embodied in the Joint Committee Report No. 2023-23-116;

WHEREAS, the Office of the Municipal Agriculturist of Kananga issued a Certification dated August 30, 2023, certifying that the area ceases to be economically feasible and no longer sound for agricultural production and the same is not irrigated land. The DAR Leyte-Biliran Provincial Office issued a Certification dated August 29, 2017 certifying that the land is not covered by CARP. The CENRO in Ormoc City issued a Certification dated January 17, 2024 certifying that the said parcel of land is within the Alienable and Disposable Area. Certification of the DENR Regional Office VIII also certifies that the said land is outside the scope and coverage of ENIPAS Act of 2018;

WHEREAS, a public hearing was conducted regarding the proposal on June 18, 2024 and no objection was heard during the hearing up to the time of the approval of this ordinance;

WHEREAS, the subject area for reclassification meets all the requirements of the provision of Section 20 of Republic Act No. 7160, which provides that: "(a) A city or municipality may, through an ordinance passed by the sanggunian after conducting public hearings for the purpose, authorize the reclassification of agricultural lands and provide for the manner of their utilization or disposition in the following cases: (1) when the land ceases to be economically feasible and sound for agricultural purposes as determined by the Department of Agriculture or (2) where the land shall have substantially greater economic value for residential, commercial, or industrial purposes, as determined by the sanggunian concerned: Provided, That such reclassification shall

be limited to the following percentage of the total agricultural land area at the time of the passage of the ordinance: (1) For highly urbanized and independent component cities, fifteen percent (15%); (2) For component cities and first to third class municipalities, ten percent (10%)";

NOW THEREFORE, BE IT ORDAINED, as it is hereby ordained by the 23rd Sangguniang Bayan of Kananga, Leyte on a regular session duly assembled on July 1, 2024 and upon motion of SB Member Brenzon C. Cabintoy, seconded en masse, to wit:

SECTION 1. TITLE - This Ordinance shall be known as "An Ordinance Reclassifying Lot No. 1-B-1, Psd-08-028756-D with an area of 5,252 square meters, situated in Barangay Lonoy, Kananga, Leyte from Agricultural Land Use to Agro-Industrial Land Use."

SECTION 2. RECLASSIFICATION - The property owned by spouses Ferdinand B. Borela and Gina Linda D. Borela, particularly Lot No. 1-B-1, Psd-08-028756-D with an area of 5,252 square meters, situated in barangay Lonoy, Kananga, Leyte, covered by Transfer Certificate of Title No. 115-2018000159 is hereby reclassified from AGRICULTURAL LAND USE to AGRO-INDUSTRIAL LAND USE.

SECTION 3. MANNER OF UTILIZATION - The subject land shall be strictly utilized in accordance with the Municipal Zoning Ordinance of Kananga, Leyte and other applicable laws, rules and





1. - Hon. Capanas(Chairman of the Committee on Rules and Laws) said that Public Hearing is required to be held when agricultural land is being reclassified its uses and this is under Section 20 of the Local Government Code of 1991. Also the existing laws, required the council to conduct public hearing at the location of the proposed site for reclassification, so this is the purpose why we are here. This Public Hearing for ordinance reclassification of land owned by Mr.& Mrs. Ferdinand Borela and Gina Linda Borela located in your barangay from Agricultural to Industrial. He read and explained the provision of Section 20 of RA 7160 to be clear by the residents of the said barangay.
- Mr. Borela(Applicant of reclassification) said that he gave thanks the Sangguniang Bayan Council headed by the Vice Mayor. He said that this reclassification will benefit the barangay, because it provide works and products among constituents.
