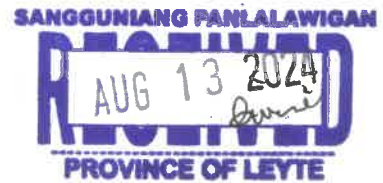

**Unanimously approved.**


