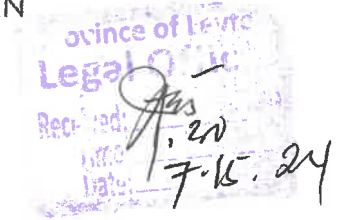

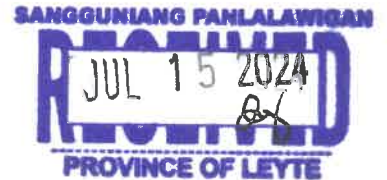

ORDINANCE No. 24 – 08

AN ORDINANCE GRANTING CASH INCENTIVES TO THE POOR BUT DESERVING COLLEGE STUDENTS IN THE MUNICIPALITY OF INOPACAN, PROVINCE OF LEYTE, PROVIDING FUNDS FOR IMPLEMENTATION THEREOF AND FOR OTHER PURPOSES

SECTION 1: TITLE. This ordinance shall be known as “The COLLEGE STUDENTS CASH INCENTIVES IN THE MUNICIPALITY OF INOPACAN”.

SECTION 2: DEFINITION OF TERMS. As used in this ordinance the following terms shall mean & construed as:

2.1 CASH INCENTIVES – shall mean a monetary value given to incoming college students to motivate them in order to excel in their studies.

2.2 POOR BUT DESERVING STUDENTS -shall mean indigent persons whose intellectual capacities are hampered due to financial constraints.

SECTION 3. SCOPE AND COVERAGE-Residing and incoming freshmen college students in this Municipality shall be eligible in this ordinance.

SECTION 4. ELIGIBILITY. The incoming freshmen students are eligible to apply with the following rules and regulations:

4.1 Only one (1) honor student shall be selected per National High School;

4.2 In case the honor students shall not qualify as their parents have financial capacity to educate them, the next in rank shall be eligible;

4.3 The High School Principal in every school shall select one (1) aspirant student that belongs to poor but deserving family;

4.4 Among top five (5) aspirants, school principals shall endorse them to the Local Government Unit subject for verification and validation by the task force committee.

SECTION 5. Creation of student’s cash incentive committee. The committee shall be created namely:

Chairman: Municipal Mayor

Vice Chairman: SB Member, Committee on Education

Members: Five (5) School Principals or its Authorized Representatives



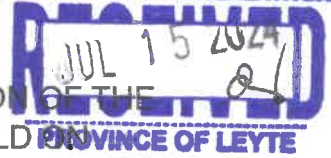

SECTION 6. POLICY. Scholars shall abide the Policies compelled of this Ordinance, to wit:

6.1 he/she shall submit a Class card or any proof of evidence every semester that he/she obtains a passing grade;

6.2 No replacements shall be made during the period covered where he/she enrolled in the university;

6.3 Should the student(s) obtain an incomplete grade or INC, the stipend shall be withheld unless he/she submits a documentary proof showing completion of the requirements necessary to pass the subject.

6.4 He/she shall transfer to another universities or dropped his course.

SECTION 7. IMPLEMENTING AGENCY. The Local Government Unit of Inopacan shall initiate the implementation of this cash incentives ordinance and shall be given to qualified scholars in the amount of five hundred pesos (500.00) per month and be claimed to Municipal Treasurer's Office.

SECTION 8. FORFIETURE. Availment of cash incentives shall be forfeited subject to the following grounds:

8.1 He/she shall obtain a failing grade;

8.2 He/she shall not comply the policy as stipulated under section 6 of this ordinance;

8.3 Found out guilty of any administrative or criminal offense by any government quasi-judicial bodies of courts of justice during his/her college tenure.

SECTION 9. FUNDING REQUIREMENT. The funds to pay shall be chargeable against the Local Government Unit's appropriation. An initial amount of One Hundred Fifty Thousand Pesos (Php 150,000.00) shall be appropriated for the implementation of this ordinance.

SECTION 10. REPEALING CLAUSE. All Ordinances, Resolutions, Order and/or Rules and Regulations inconsistent herewith are hereby repealed and modified accordingly.

SECTION 11. SEPARABILITY CLAUSE. If any sections or provisions of his Ordinance is declared void or unconstitutional the remaining section or provision hereof shall not be affected by such declaration.

SECTION 12. EFFECTIVITY CLAUSE. This ordinance shall take effect upon its approval.
