### **II. HEALTH CARE PROVIDER NETWORK**

1. Primary Care Provider Network

Inter-Local Health Zone System, where the network starts from the Barangay Health Station (BHS) to Rural Health Unit (RHU) and Birthing Facilities.

- 1.1. All Infirmaries, District and Provincial Hospitals are linked to an Apex Hospital (EVMC).

- RHU nurses trained in First Aid and BLS and physicians trained in Basic Emergency Care.

#### MEMORANDUM OF AGREEMENT

THE PROVINCIAL GOVERNMENT OF LEYTE, a group of primary to tertiary care providers with office address at Government Center, Candahug, Palo, Leyte, represented herein by its authorized representative, Hon. Carlos Jericho L. Petilla, Governor, and hereafter referred to as "FIRST PARTY";

EASTERN VISAYAS MEDICAL CENTER, a Level 3 hospital with office address at BRGY. 93, Bagacay, Tacloban City, represented herein by its authorized representative Dr. Salvador B. Evardone, and hereafter referred to as "SECOND PARTY";

This AGREEMENT is entered into and executed by and between: WITNESSETH that:

WHEREAS, the Universal Health Care Act of 2019 provides that the health services delivery may be population-based or individual-based;

WHEREAS, Section V.E of Administrative Order (AO) 2020-0019 "Guidelines on the Service Delivery Design of Health Care Provider networks" mandates all health care provider networks (HCPN) to have primary to tertiary care providers with linkages to an apex hospital and other facilities providing specialized services needed by its catchment population;

WHEREAS, Section VI.D.1.e of the said AO requires HCPNs to enter into a Memorandum of Agreement with at least one apex hospital;

WHEREAS, Section II(B)(1) of Department of Memorandum (DM) 2020-0434 "Updated Interim Guidelines on Health Care provider Network (HCPN) during the COVID-19 Pandemic" mandates each province to establish province- and city-wide HCPNs from primary care to tertiary care, to include government and private facilities and providers;

WHEREAS, the Second Party has been designated by the Department of Health as an apex or endreferral hospital to provide specialized services that are not expected to be provided in HCPNs;

WHEREAS, the First Party is an HCPN that is compliant with AO 2020-0019 and wishes to link with the Second Part as its apex hospital;

NOW, THEREFORE, for and in consideration of the foregoing premises, the Parties agree as follows:

### The Parties' Undertaking:

A. Pirst Party, as an HCPN, undertakes to ensure compliance with AO 2020-0019 and other pertinent issuances, such as, but not limited to the following requirements/obligations:

F

people shall have access to a primary care facility within thirty (30) minutes travel time and to a hospital within one (1) hour.

#### Π.

- A. The Parties may, upon mutual consent, amend or modify this Agreement through an addendum signed by both parties, and which shall become an integral part hereof:
- B. Neither party may assign this Agreement nor any of its rights, interests and obligations hereunder without the other party's consent;
- C. The parties shall altogether ensure that the resources are used in accordance with the purpose/s for which they were allocated or provided;

#### III. Representations and Warranties

- A. The Parties represent and warrant that they possess all rights and have full power and authority necessary to enter into this Agreement and perform all of their ob-
- B. Each Party's execution, delivery and performance of this Agreement does not conflict with any agreement, oral or written, to which it is a party or by which it is bound, nor violate any law or regulation of any court, governmental body, or administrative agency having jurisdiction over such Party;
- C. In performing their respective obligations under this Agreement, the Parties warrant compliance with all applicable legal and regulatory requirements.

#### IV. Effectivity and Termination

This Agreement shall enter into force upon signing of the parties, and shall continue to be in effect until terminated by either party with a 30-day advance written notice, without prejudice to an immediate termination on the following grounds:

- i. Failure of either party to maintain its capability as apex hospital or HCPN, as the case may be;
- ii. Breach of any of the provisions; or
- iii. Misrepresentation

Provided that, in no case shall any patient be prejudiced by such termination; provided further, that, obligations which are by nature shall continue after the termination of the agreement shall survive such termination.

#### V. Miscellaneous Provisions

- A. Processing of personal information shall made in accordance with the Data Privacy Act of 2012 at all times;
- B. The Parties shall act in good faith at all times in their performance of their respective obligations under this Agreement;
