#### **ORDINANCE No. 2024-06**

### AN ORDINANCE CREATING THE JAVIER TRAFFIC AUXILIARY (JTA) IN THE MUNICIPALITY OF JAVIER, LEYTE.

WHEREAS, the Municipality is mandated to regulate traffic on all streets and bridges within its territorial jurisdiction;

NOW THEREFORE, be it ordained by the Sangguniang Bayan of Javier, Leyte, THAT:

**SECTION 1.** This Ordinance shall be known as the Javier Traffic Auxiliary.

#### **SECTION 2.** Definition of Terms:

- Traffic refers to the movement of vehicles-motor driven, man-driven or animal drawn as well as movement of pedestrians on the streets, roadways and highways of Javier, Leyte
- 2. Traffic Auxiliaries refers to uniformed civilians hired by LGU-Javier, and duly deputized by the Local Chief Executive charged with the duty to regulate and direct traffic and implement the Municipal Traffic Code, Ordinances and Laws.
- 3. Traffic Violator shall mean any person who violates the provisions of the Municipal Traffic Code and Laws.

**SECTION 3.** The Traffic Auxiliary shall be deputized thru an Executive Order of the Local Chief Executive, and shall be supervised and controlled by the Philippine National Police of Javier, Leyte.

The Traffic Auxiliary shall undergo trainings and seminars conducted by legitimate agencies like the Land Transportation Office, Land Transportation and Franchising Regulatory Board or any private agencies accredited by the Department of Transportation.

SECTION 4. The qualifications of the Traffic Auxiliary are as follows:

- 1. With good moral character
- 2. Duly deputized by the Local Chief Executive

**SECTION 5.** The Traffic Auxiliary shall have the following duties, responsibilities and powers:

- 1. Conduct traffic direction and control at their respective area of assignments.
- 2. Apprehend all violators of the existing Municipal Traffic Code and Ordinances
- 3. Issue Traffic Citation Tickets to the traffic violators of the Municipal Traffic Code and Ordinances and in this case shall not confiscate his/her Driver's License.
- 4. Assist traffic investigation of all traffic and vehicular accidents under the supervision of the Chief of Police.
- 5. Perform such other traffic-related duties delegated by the Local Chief Executive and as deputized by the Land Transportation Office to act as their Deputized Agents.

SECTION 6. Funds shall be appropriated out of the funds of the local to fund the operation of the Javier Traffic Auxiliary.

SECTION 7. All ordinances, rules and regulations or parts thereof which inconsistent with any of the provisions of this ordinance are hereby deemed repealed, modified or dissolved accordingly.

SECTION 8. This Ordinance shall take effect immediately upon approval
