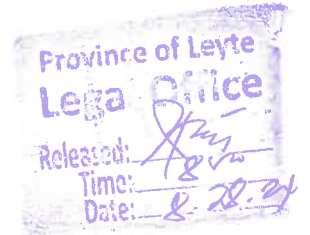

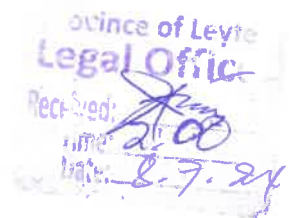

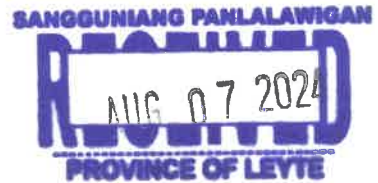

**AN ORDINANCE ADOPTING R.A. NO. 11148, OTHERWISE KNOWN AS " AN ACT SCALING UP THE NATIONAL AND LOCAL HEALTH AND NUTRITION PROGRAMS THROUGH A STRENGTHENED AND COMPREHENSIVE INTEGRATED STRATEGY FOR MATERNAL, NEONATAL, CHILD HEALTH AND NUTRITION IN THE FIRST 1,000 DAYS OF LIFE, APPROPRIATING FUNDS THEREOF AND FOR OTHER PURPOSES IN THE MUNICIPALITY OF JAVIER, LEYTE.**

**WHEREAS**, Republic Act No. 11148, also known as the "Kalusugan at Nutrisyon ng Mag-Nanay Act", mandates the scaling up of national and local health and nutrition programs through a strengthened and comprehensive integrated strategy for maternal, neonatal, child health and nutrition in the first 1,000 days of life ;


**WHEREAS**, the Rural Health Unit (RHU) of Javier, in collaboration with the Local Health Board, recognizes the critical importance of adopting and implementing this Act to enhance the health and nutrition outcomes for mothers and children in the community ;

**WHEREAS**, the Local Health Board of Javier fully supports the adoption and local implementation of R.A. No. 11148 to ensure comprehensive and accessible health and nutrition services for mothers and children in the municipality ;

**NOW THEREFORE**, be it **ORDAINED** by the Sangguniang Bayan of Javier, Leyte, **THAT :**

**SECTION 1. Title** – This Ordinance shall be known as the "Kalusugan at Nutrisyon ng Mag-Nanay Act Implementation Ordinance of Javier."

**SECTION 2. Adoption of R.A. No. 11148.** The Municipality of Javier hereby adopts and implements R.A. No. 11148, ensuring the scaling up of health and nutrition programs through a comprehensive and integrated strategy for maternal, neonatal, child health, and nutrition in the first 1,000 days of life.

**SECTION 3. Implementation of Health and Nutrition Programs.** The Rural Health Unit of Javier, in coordination with relevant agencies and stakeholders, shall ensure the full implementation of R.A. o. 11148. This includes providing:

- Complete prenatal care and vitamin supplementation for pregnant women
- Vaccination of infants to protect them from vaccine-preventable diseases.
- Promotion and support of exclusive breastfeeding for the first six months of age
- Continued vitamin supplementation and other necessary health interventions.
- Regular nutrition status assessments to monitor and address the growth and development of infants and children.

**SECTION 4. Funding and Resources.** The Municipality of Javier shall allocate adequate funding and resources to support the health and nutrition programs. This includes procuring necessary supplies, training healthcare providers, and conducting outreach activities to ensure comprehensive coverage.

**SECTION 5. Monitoring and Evaluation.** The Rural Health Unit, in collaboration with the Local Health Board, shall establish a monitoring and evaluation system to track the progress and impact of the health and nutrition programs. Regular reports shall be submitted to the Sangguniang Bayan to ensure transparency and accountability.

**SECTION 6. Community Engagement.** The Municipality of Javier shall conduct regular community engagement activities to raise awareness about the importance of maternal, neonatal, child health, and nutrition. This includes informational campaigns, community meetings, and partnerships with local organizations to promote the programs.

**SECTION 7. Effectivity.** This Ordinance shall take effect immediately upon its approval.




