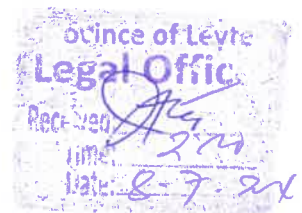

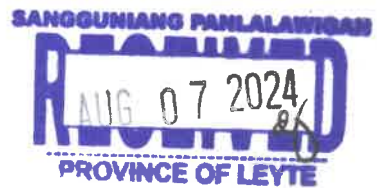

ORDINANCE No. 2024-07

AN ORDINANCE ADOPTING THE OFFICIAL SEAL OR LOGO OF THE RURAL HEALTH UNIT OF JAVIER, PRESCRIBING THE USE AND IMPOSING PENALTIES FOR UNOFFICIAL OR UNAUTHORIZED USE THEREOF.

SECTION 1. Title . This Ordinance shall be known as the "Official Seal of the Rural Health Unit of Javier Ordinance"

SECTION 2. Adoption of Official Seal/Logo. The Official seal/logo of the Rural Health Unit of Javier is hereby adopted. The official logo/seal shall be depicted as follows :



SECTION 3. Symbols and Representation.

- a. Yellow & Green : Represents allegiance to the Local Government Unit of Javier. These colors shall depict health and warmth.
- b. Red : Signifies neutrality, impartiality, humanitarian aid, passion, and emergency response.
- c. Structure : Symbolizes the office of the Local Government Unit.
- d. Mountains : Symbolizes the mountainous areas in Javier
- e. Curved Lines: Symbolizes the continuity of healthcare and services.
- f. Blue River : Represents God's life-giving presence.
- g. Caduceus : An ancient Greek or Roman herald's wand with two serpents twined around it carried by the messenger God Hermes or Mercury represents healing.

SECTION 4. Purpose of Seal and Authorized Use. The official logo/seal of the RHU shall be for official purposes only. It shall appear in all official documents of the Department and in circumstances where the Municipal Health Office permits its use.

SECTION 5. Unauthorized Use of the Logo/Seal. It shall be unlawful for any person, natural or juridical, to print the official logo/seal of the Municipal Health Office for the purpose of sale, distribution, or circulation, manufacture, publish, use, display, or offer for sale any document or items, merchandise which simulate the official logo/seal of the MHO without the express written consent of the Office.

SECTION 6. Penalties for Violation. Violation or unauthorized use of the official logo/seal shall be punishable by imprisonment of not more than thirty (30) days or a fine of not more than Two Thousand Five Hundred Pesos (P2,500.00) or both, subject to the discretion of the courts.

SECTION 7. Implementing Rules and Regulation. The Local Health Board, in coordination with the Municipal Health Office, shall formulate the necessary implementing rules and regulations for the effective implementation of this Ordinance within 60 days from its approval.

SECTION 8. Repealing Clause. All ordinances, resolutions, and other issuances inconsistent with this Ordinance are hereby repealed or modified accordingly.

SECTION 9. Effectivity. This Ordinance shall take effect immediately upon its approval.


