NCE INSTITUTIONALIZING THE KATUWANG SA DIWA AT GAWA PARA SA MASAGANANG ANI AT MATAAS NA KITA (KADIWA) NG PANGULO IN THE **MUNICIPALITY OF HILONGOS**

WHEREAS, the State recognizes the role of agriculture in nation-building and shall provide support to agriculture through appropriate technology and research and sufficient financial, production, marketing, and other support services;

WHEREAS, the State also recognizes the right of every citizen to adequate food and shall ensure that the people have access to essential food commodities at affordable prices;

WHEREAS, recently our country was challenged by the issue of a lack of supply or shortage of essential commodities;

WHEREAS, in the response, Presiding Ferdinand R. Marcos, Jr. through the Department of Agriculture resumed the KADIWA Program and introduced innovations which will ensure the availability of agricultural products in the country at the affordable prices;

WHEREAS, the Department of the Interior and Local Government issued Memorandum Circular No. 2024-003 which is the Participation of LGUs in the Katuwang Sa Diwa at Gawa Para sa Masaganang Ani at Mataas Na Kita (KADIWA) Ng Pangulo 2023;

WHEREAS, the KNP is part of the government's efforts to ensure stable food supply as it enables the farmers to sell directly to consumers by removing market layers;

NOW THEREFORE, on motion of Hon. Edwin F. Faller, as duly seconded by Hon. Bernadeth M. Nerves

BE IT ORDAINED in the 16th Sangguniang Bayan Hilongos during its Regular Session assembled that:

SECTION 1. Title - This ordinance will be entitled as An Ordinance Institutionalizing the KADIWA ng Pangulo in the Municipality of Hilongos.

Objectives - The KADIWA ng Pangulo (KNP) aims of achieving the following **SECTION 2.** objectives:

- a) To increase participation of Local Government Unit to KNP;
- b) To ensure food security, delivery of nutritious food and access to affordable goods and commodities;
- c) To support farmers to sell agri-produce, to facilitate product regional exchange of One Town, One Product (OTOP) products, and to provide opportunity to local micro-entrepreneurs to market their products;
- d) To provide market opportunities to MSME'S through local products promotion and eliminating as many marketing layers, allowing producers to earn bigger

- e) To encourage consumer spending, thereby jumpstarting and reviving local economies.
- **SECTION 3. Scope and Coverage** The KADIWA Program will be implemented within the Municipality of Hilongos.
- **SECTION 4. Schedule and Venue of the KADIWA Program** The KNP shall run every 15th and 30th every month to take effect upon the approval of this ordinance.
 - The KNP shall have 3 market areas/product clusters, to wit:
 - a) Agricultural produce such as rice, vegetables, and fruits of farmers;
 - b) Processed goods both food and non-food produce by MSMES;
 - c) Mercato stalls (ready to eat food) for micro-enterprises
 - Moreover, the venue will be in an area indicated by the Local KNP Committee.
 - Lastly, there will be no registration fee that will be collected from participating farmer/MSME merchants nor from visiting consumers.

SECTION 5. Roles and Responsibilities – Kadiwa ng Pangulo (KNP) is a joint program and collaborative arrangement among concerned government agencies of national government and local government units. It also encourages full participation and support of non-government organizations, business sectors and cooperatives.

The LGU Hilongos shall have the following responsibilities in the Implementation of the KNP:

SECTION 7. MONITORING AND EVALUATION – A monitoring and Evaluation Committee will be established to evaluate the impact on the local economy which shall provide the following information/data:

- a) Number of farmers/sellers that participated including the revenue generated during the KNP;
- b) Number of entrepreneurs that participated including the revenue generated during the KNP day;
- c) Number of people that visited the KNP, time and place of KNP Activity;
- d) Monitoring on the impact of the program to the farmers and consumers.
- **SECTION 8. FUNDING** The Municipal Government of Hilongos shall allocate an amount in the Annual and Supplemental Budgets for the implementation of the KNP.
- **SECTION 9. SEPARABILITY CLAUSE** In case any provision of this ordinance shall be held or declared invalid or unconstitutional, the validity of the other provisions hereof shall not be affected thereby.
- **SECTION 10. REPEALING CLAUSE** Any provision of local ordinance, executive order or rules and regulations in consisted with the provision of this ordinance is thereby repealed, amended, or modified accordingly.

SECTION 11. EFFECTIVITY CLAUSE - This ordinance shall take effect upon its approval.
