 Ordinance No. 189, series of 2024 entitled: "An Ordinance Amending Certain Provisions of Municipal Ordinance No. 86, Series of 2019, Otherwise Known as the Anti-Littering Ordinance of Matag-ob Leyte.

REVIEW/RECOMMENDATION/LEGAL OPINION:

This office is of the opinion that the Subject Ordinance is in accordance to its power under Section 447(1)(iii)¹ and (5)(xiii)² of the Local Government Code of 1991 (R.A 7160).

Likewise as settled in the case of Constantino v. Desierto 288 SCRA 654, it is within the power of the local council to repeal or amend its prior acts either expressly, or by the passage of an essentially inconsistent resolutions. Hence, recommending the declaration of its validity.

This opinion is likewise without prejudice to the opinions rendered by higher and competent authorities and/or the courts.







Be it ordained by the Sangguniang Bayan of Matag-ob, Leyte, in its regular session assembled, that:

Section 1. Add the foregoing Section which assigned as Section 4, to read as follows:


"Section 4. It shall be unlawful to throw trash or garbage in any places within the territorial jurisdiction of the Municipality to maintain cleanliness and orderliness of their immediate surroundings and frontage, or any prohibited act stated in Municipal Ordinance No. 174 s. 2023.

Section 2. Section 4 of Municipal Ordinance No. 86 series 2019 shall be assigned as **Section 5**, which shall be amended to add a sub-section to read as follows:

"5.3 All biodegradable must be thrown in compost pit area, while non-biodegradable must be placed at material recovery facility of respective barangays of the 21 component barangays of the municipality.

Section 3. Section 8 shall be assigned as Section 9 and shall be amended to read as follows:

First Offense: Pay the Administrative Fine of 300.00 or render community service of 3-hours;

Second Offense: Pay the Administrative Fine of Five Hundred (P500.00) Pesos or render community service of 4-hours:

Third offense: Pay the Administrative Fine of Thousand Pesos (Php1,000.00) and/or imprisonment of 1 day, or both such fine and imprisonment at the discretion of the court.

Section 4. Repealing Clause. By virtue of this ordinance, Municipal Ordinance No. 32 series 1991, and Municipal Ordinance No. 25 series 2003, and all other ordinances inconsistent herewith are hereby repealed and/or modified accordingly.

Section 5. Amendments Clause. This ordinance may be amended or modified as necessary through the appropriate legislative process.

Section 5. Effectivity Clause. This ordinance will take effect 15 days upon approval.


