Gentlemen and Ladies:

Pursuant to the provisions of the Local Government Code of 1991 (Republic Act No. 7160), our preliminary review of the General Fund Supplemental Budget No. 2 CY 2024 of the Municipality of Palompon, Leyte duly enacted by the Sangguniang Bayan through Appropriation Ordinance No. 491-080724 with a total appropriation in the amount of P30,765,681.23, reveals compliance with the same law and its implementing Rules and Regulations.

It is therefore recommended for approval subject to the following conditions:

- 1. That the reversion of appropriations is duly authorized by the concerned officials and are made available to support the expenditures under Supplemental Budget No. 2;
- 2. That the procurement of Goods, Supplies, Equipment, Civil Works and related services shall be made in accordance with the provisions of RA 9184 and its Implementing Rules and Regulations;
- 3. That the appropriations for the increase in RATA to officials of LGU Palompon, Leyte shall be in accordance with the provisions of LBC No. 157 dated May 3, 2024;
- 4. That the I appropriations for the increase of Unform/Clothing Allowance shall be subject to the guidelines of Budget Circular 2024-01 dated April 4, 2024
- 5. That disbursement of funds shall be for the specific purpose(s) for which they have been appropriated pursuant to Sections 335 & 336 of RA 7160.

Compliance with DBM issuances, accounting and auditing rules and regulations and all other existing laws shall be the responsibility of the implementing Local Government Unit
