And we are also going to present today, with Architect Paulo Alcazaren, the proposal for the Master Plan of the Leyte Province Government Center in Palo. So I'll give the floor to Architect Paulo Alcazaren. He will be introducing himself and then he will present and discuss to you the plans of these projects. Thank you again, Vice Gov and to the entire SP of the Province of Leyte.

Thank you, Mayor Ann. Good morning to Vice Gov Sandy Javier and to the members of Sanggunian Panlalawigan ng Leyte. Thank you for the opportunity to present to you this morning. Since I've been asked to introduce myself, which I don't usually do, I am Paulo Alcazaren, Principal of PGAA Creative Design where Master Planners, Urban Designers and Landscape Architects are. I have 42 years of experience in the business, 12 of which was in the Head Office in Singapore, which is still there. So we're one of the few consultancy firms offices overseas and our coverage over the last 42 years has been over 200 completed projects in 14 countries, mostly, in Southeast Asia. And these cover projects are townships and districts. Back here in the Philippines, actually, we're going tomorrow to make a presentation for the Tourism Master Plan of Camotes and Bantayan Islands in Cebu to present it to the Office of the President for the Visayas. And our most well-known project here in the Philippines has been the Iloilo Esplanade which is 9 kilometer of Linear part along the Iloilo River and we are about to complete the renovation of the 6 Public Plazas in Iloilo. But we also have project all over the country including private developments. All of the Major real estate developers are our clients such as Mega World Ayala, Active Realty where we are just finishing three townships in Batangas. So again, our expertise is really in Planning, Urban Design and Landscape Architecture. We have also been consultants to Ayala, Makati, BGC

173	and Ortigas Central Business for Improvements of these districts. Because they have to
174	change over the last 20-30 years. So we've been invited by Mayor Ann Petilla to come in a
175	take a look at both MacArthur Memorial Landing Park for the 80 th Leyte Landing

- There is a diagonal road that can make a difference in developing your plan. That diagonal road from the Government Center going to Capitol is very Critical. Kung magawa yan, done na ang ating plano dyan, dba?

I agree 100% because if we build that first, it will all happen that means you're connecting the two sides and then the land owners, themselves, can see the benefit. Lands can be expropriated but we can just sit down with them because everyone will benefit. If Palo and Province can get together, incentives also can be given to the land owners it terms of them agreeing into giving up that land.

HON. LEONARDO M. JAVIER, JR.: PRESIDING OFFICER/VICE-GOVERNOR

Alam mo ba, Architect Paulo, 50% of that project is already solved by what I saw. Do you notice the property from the Capitol to the Government Center? There is an area there that is already pre-developed. Tinambakan na yan eh. Did you notice there is a clearing? It only takes a few clearing para makatawid ka dun sa Maharlika Highway going to the Capitol from the Government Center. Now, you are solved already with 50% of your problem, because I decide on that property. Alam ni Mayor Ann yan eh.

We can have discussion of that kay Uykim, the owner of that area which have been converted to PEZA Zone, and I think, Vice Gov if you tell him he would probably take your lead. If you tell him that if he says yes, the remaining property will even more than double the value of the property that will be given up to development.

 - Architect, yung property sa harap ng Capitol sa atin yan. Malapit na yung property ko sa property ni Mayor Ann, yung FPOSI. Kaya to patch a road there, wala na tayong problema. I can volunteer that para lang gumanda ang Palo Area kasi ang ganda ng lugar eh. Pag nagawa yan ang ganda kasi naiinggit ako sa Cebu kasi lahat ng Government Offices and Agencies doon sila nagcoconference and nagbabayad sila ng hotel. Pwede naman yan sa Leyte dba? I used to be the National President of the Mayor's League tapos ang ginagawa namin kapag may conference or convention pumupunta pa kami ng Cebu. So if dito na satin, mas maraming hanap buhay ang mabibigay sa mga taga Leyte. That is what we are here for, we are Public Servants. Unya, bisaya ka man Architect dba?

258	Mr. Architect, as I was looking at this development plan, there are no details how
259	much the initial budget for this is.

265	Okay, it's the Phase 1. So, we would also like to know the initial budget for this
266	proposed Master Plan for the McArthur Landing Memorial Park.

ARCHITECT PAULO ALCAZAREN:

Yes, we already have and you already approved the first improvements for the 80th and the additional improvements which I believe TIEZA wants to fund. So there apparently is a fund to develop the entire, roughly 5 hectares of the memorial area.

HON. TRINIDAD G. APOSTOL: TEMP. FLOOR LEADER/2ND DISTRICT BOARD MEMBER

So you already have a budget for that particular area?

ARCHITECT PAULO ALCAZAREN:

Yes, we already have a detailed budget for that but the Master plan of the 70-hectare is only the first look at the Master plan. Of course, we can give you the general idea of the cost. The first thing we have to put in, is the new road, so, if it's going to be channeled to DPWH they would love that because they love building roads and drainage. But we can make a projection. Right now, no one except yourselves has seen the new road plan.

HON. TRINIDAD G. APOSTOL: TEMP. FLOOR LEADER/2ND DISTRICT BOARD MEMBER

So we have to tap with several agencies regarding this, as you have mentioned, DPWH is one.

ARCHITECT PAULO ALCAZAREN:

The Province can make representations with DPWH for the general development of the area. DWPH also builds roads when it comes to tourism destinations and that's why it's important to zone that area. You can also tap DBM for assistance. The first thing that you need to do is do all of the due diligence and the detailed planning. Funds for the detailed planning can also be accessed to DBM.

HON. TRINIDAD G. APOSTOL: TEMP. FLOOR LEADER/2ND DISTRICT BOARD MEMBER

Can you give me an idea about this 70 hectares? It will start from the MacArthur Landing up to where? I just want to know the whole area.

ARCHITECT PAULO ALCAZAREN:

All the way to the National Road which is the Maharlika Highway. Where you have the Philippine Science High School.

MRS. FRANCES ANN B. PETILLA: LEYTE TOURISM CONSULTANT

The area that will be covered for the development of the Government Center or what Architect Paulo has called the Palo Global city is will start with the Macarthur Park and it will cover the entire 70+ hectares of the Government Center and hopefully the development will go all the way to the Capitol Complex which is where we are right now. On the coverage of our commissioning of Architect Paulo is the planning of this area, how to put what buildings, what height, what infrastructure, and what roads. So it is more for the planning. The implementation is going to be us and other government agencies that we will partner with later on. Architect Paulo is about giving us the plan, the blueprint.

I remember at one time Architect Paulo has actually told me, sabi nya "you know what Ann I saw Makati a long time ago" and he said that Makati looked like Palo before and we have a good canvass because we still have a lot of open spaces where we can still fix our Government Center. We have the opportunity right now to put everything in its proper place. I think this is the best time to do the plan or else, if we will just let it be, we might just have a "chopseuy" area where everybody will just build anything everywhere.

ARCHITECT PAULO ALCAZAREN:

That's correct. Moving forward, the first 4 to 5 years, is to put in the basic infrastructure which is the road system. So tama si Vice Gov Sandy that the diagonal road which is the connection to there should be the first thing and the next parallel to that kailangan I re-parcel yung property from the MacArthur Park to the National Highway. There are certain parcels that are needed to be realigned. So it's essentially reblocking and re alignment. And we have already checked that it does not compromise the existing buildings that are there. But what we want to do is to provide the parcels that will be attractive to potential locators as well as to make sure your transport system works. Ang problema sa iba is they put a road without anticipating the need of public and private transport system, side walk, bike lanes and support facilities.

ARCHITECT PAULO ALCAZAREN: 332 Any other questions? If there are none I would like to say, thank you very much. We 333 334 will leave the Master plan copies and we also have a very simple scale model for all of you. Thank you very much. 335 HON. LEONARDO M.
