Javier, Jr., Provincial Vice Governor, to Review and Approve the Herein Attached Water Supply Improvement Project Plan of the Municipality of Matag-ob, Leyte."

After a thorough study and review of the attached "Water Supply Improvement Project Plan of the Municipality of Matag-ob, Leyte" and the ocular inspection in Matag-ob, Leyte conducted by Vice Chairperson Atty. 

Attached herewith is the report conducted by our office on the said water source in Matag-ob, Leyte.



MATAG-OB WATER SOURCE INSPECTION REPORT


BULAK SPRING (BRGY. BULAK, MATAG-OB)

The Bulak Spring is situated at Brgy. Bulak, Matag-ob which is 4.6km away from the Matag-ob proper. It can be reached by vehicle from National Highway to proper Barangay Bulak and must walk roughly for 15 to 20 minutes to make it to the Bulak Spring. During the ocular inspection, it was observed that spring has a plenty of water that supplies the existing Intake Box. Due to its abundant water, the Intake Box cannot accommodate such volume which results for excess water to overflow, thus, needs to rehabilitate and imoprove. It has been said that the Bulak Spring serves the area mostly all the Barangays of the Poblacion, Matag-ob and nearby Barangays.



MASAB-A (BARRAKS) SPRING (BRGY. SAN VICENTE, MATAG-OB)

The Masab-a (Barraks) Spring is located at Brgy. San Vicente, Matag-ob. The center of Brgy. San Vicente is 6.7km away from the Matag-ob proper and can be reached through any vehicle, then must hike for 20 minutes to get to the Masab-a Spring. During the ocular inspection the existing intake box is already full of water supply which causes for the excess water to overflow. The Masab-a Spring has 3 water source points to which supplies the existing intake box, with this, the design of existing intake is too small that it cannot accommodate such large volume of water entering the box, thus, the construction of new and bigger intake box is needed. The Masab-a Spring only supplies and serves as the main water source of Brgy. San Vicente.


