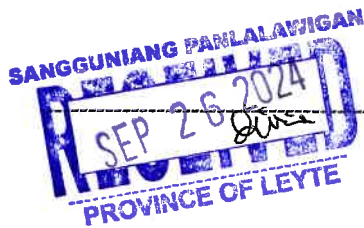

REVIEW/RECOMMENDATION/LEGAL OPINION:

This office is of the opinion that the Subject Ordinance is in accordance to its power under Section 447(1)(viii)¹ of the Local Government Code of 1991(R.A 7160.

Likewise as settled in the case of Costantino v. Desierto 288 SCRA 654, it is within the power of the Local Council to repeal or amend its prior acts either expressly, or by the passage of an essentially inconsistent resolution. Hence, recommending for the declaration of its validity


The Chair opines and directed Ms. Metran to proceed reading of the committee report.

After the reading on the committee report, the Chair ask from the Body if there are amendments, and hearing none, request Hon. Salgado to offer the final motion.

Hon. Salgado opines and said that if there are no more inquiry to the Public Hearing of Ordinance No. 30, Series of 2024, moves for the adoption of the committee report, and it was duly seconded en masse.

A PROPOSED RESOLUTION ADOPTING SANGGUNIANG BARANGAY RESOLUTION NO. 15, SERIES OF 2024, DATED FEBRUARY 3, 2024 OF BARANGAY HIBUNAWON, AND INTERPOSING NO OBJECTION TO THE SAND AND GRAVEL INDUSTRIAL PERMIT APPLICATION OF MR. DAVE WALTER C. SY, LOCATED IN MINULHO RIVER, BARANGAY HIBUNAWON JARO, LEYTE.

Hon. Landilino T. Katangkatang moves the above proposed resolution, seconded by Hon. Altres, Hon. Emnas, and Hon. Aure.

The Chair opines and declared for the plenary discussion of the aforesaid proposed resolution, and then give the floor to Hon. Katangkatang.

Hon. Katangkatang speaks out and informed the Body that the SAG-Permit Applicant-Mr. Dave Walter C. Sy, has already comply all the documents requested by the committee (ex. new Barangay Resolution approved by the new Sangguniang Barangay, and the minutes and attendance of the Public Hearing).

The Chair opines that he had the copy of the mentioned resolution, and the records of the Public Hearing conducted on August 1, 2024 at Brgy. Hibunawon.

Hon. Pormida opines and said that he has no copy of the mentioned documents, and request from the proponent the copies of the said documents.

Hon. Katangkatang opines and said that in the previous session the SB member has been provided copies of the documents, however he could reproduce the documents for those SB members, which have no copies yet.

The Chair suggest to Hon. Katangkatang, that while the documents will be xerox, if he is agreeable to proceed first to the next item, to save time.

Going back for the consideration of Item No. 01, under the Unfinished Business, Hon. Katangkatang reiterates that copies of documents has already provided to the SB members, and further said that the SB members may proceed to their inquiries pertaining to the aforesaid proposed resolution.

Hon. Pormida opines and said that it is understood, that the SAG-Permit Applicant is only applying solely for SAG-Extraction in Brgy. Hibunawon without a crushing plant, for he is misled the word "Industrial".

Hon. Katangkatang reply that in the Sangguniang Barangay Resolution, the Concessionaire-Mr. Sy is applying only SAG-Extraction, and there is no mention with a crusher plant.

Further Hon. Katangkatang continues that as far as he can remember there are at least two (2) SAG-Concessionaires who has applied for Industrial SAG-Extraction with a crusher plant (Mercado-Villamor).

Hon. Que opines and ask from Hon. Katangkatang, to date how many SAG-Permit had already been granted by the Sangguniang Bayan.

Hon. Katangkatang reply at the moment he could not answer on the query of Hon. Que, however to satisfy his concerns the resolution could be retrieved from the SB records.

The Chair opines that inquiry of Hon. Que could be verified thru the records of the SB approved resolutions, specifically on the grant of SAG-Permit.

Hon. Que, said that his purpose of inquiry is in order to determine the number of SAG-Permit the SB had already issued/approved, so that it could be submitted to the DENR/MGB or to the Provincial SAG-Office for the purpose of monitoring if there are no indiscriminate SAG-Extraction Operations for the safety of the municipality.

The Chair opines and said the idea of Hon. Que for the DENR/MGB to conduct monitoring activities in the LGU on those SAG-Extractions in different rivers could be thru a resolution.

Further, the Chair said that the insight of Hon. Que is basically a precaution to rigidly monitor and regulate all the SAG-Quarrying in the municipality to protect the mineral resources (SAG), for their will come a time that these mineral resources would be depleted, due to uncontrolled SAG-Quarrying (ex. the Municipality of Albuera due to numerous resources has been found out later as depleted already).

Further Hon. Que inquire from Hon. Katangkatang, during the committee meeting have they asks Mr. Sy if their SAG-Extractions will not affect the water sources of the Leyte-Prime Water/LMWD for one of their sources of water is the Minulho River.

Hon. Katangkatang, reply that the committee did not asks the concessionaires Mr. Sy, and the committee did not conduct ground survey in the area, hence it cannot be determined if the SAG-Operations of Mr. Sy, will affect the water source of the Leyte-Prime Water/LMWD.

Hon. Salgado, opines that on his view, considering that distance of the SAG-Operations of Mr. Sy to the water in-take if the LMWD has a considerable distance, on his view the possible sediment will already subdue before the water is siphoned to the water treatment plant, the water will be purified already.

The Chair opines that on his observation the DENR/MGB is requiring first the SAG-Permit Applicant to secure first resolutions of No Objections to the SAG-Quarrying from the host barangay and the LGU before the grant the permit.

The Chair said further that on his view the DENR/MGB supposedly being the grantor of the SAG-Permit, shall first conduct an ocular survey, on the exact location of the SAG-Extraction will be operated to determine if there are no other existing SAG-Extraction of other concessionaires adjacent to the lot of the new SAG-Permittee to prevent overlapping.

The Chair continue that on his opinion the MGB shall issue a locational clearance first of the area free from any other SAG-Quarrying which the document (locational clearance) is among of the documents to be the reference of the resolution of No Objections from the Sangguniang Bayan.

Hon. Emnas opines that he concurs to the observations of the Chair, that the procedure in granting the SAG-Permit is reverted, supposedly the SAG-Permit Applicant should secure first the resolution from the host barangay, a Public Hearing has been conducted, ocular inspection on the area have been made (MGB), before the Sangguniang Bayan should enact the resolution of No Objection.

Hon. Emnas said further pertaining to the concerns/inquiry of Hon. Que, on whether or not the SAG-Extraction of Mr. Sy in Barangay Hibunawon will affect the water source of the Prime Water/LMWD, he suggests for the committee to conduct an on-site ocular survey, to be attended by the SB member, Barangay Officials and the SAG-Permit Applicant.

Hon. Salgado speaks out that he agrees to the suggestion of Hon. Emnas, to conduct an on-site ocular survey in order to determine on whether or not the SAG-Extraction of Mr. Sy in that barangay will affect the water source of Leyte-Prime Water/LMWD.

Further Hon. Salgado said that the Local Government Code of 1991, provides the LGU, shall be given more powers, authority, responsibilities and resources (IRR-Rule 1, Article 3).

With the provisions enshrined in the LGC 1991, the LGU has the power of autonomy, and in the exercise of its powers expressly granted, shall discharge, implement efficient and effective governance essential to the promotion of the general welfare, therefore, the LGU has the power to regulate the use of its mineral resource within its territorial jurisdiction.

The National Agencies such as the DENR/MGB and the Provincial Level it has the obligations to monitor every SAG-Extractions Operations and to see to it that the terms and conditions contained in their permit is strictly complied.

Hon. Que opines and suggest to the Body, for the Sangguniang Bayan to inquire from the DENR/MGB on how many SAG-Quarrying is allowed to be granted SAG-Permit in a particular river of the LGU.

Further Hon. Que said, and if the Body will agree with him that in the future SAG-Permit Applications should first be held in abeyance until such time the DENR/MGB could provide the number of SAG-Extraction is allowed in one particular site/river.

Hon. Katangkatang opines that considering that there are still inquiries and issues to be resolved first, before the grant of SAG-Permit to Mr. Dave Walter C. Sy, he will abide to the decision of the Body, on whether or not to hold in abeyance the approval of the SAG-Permit.

The Chair opines that the suggestions and recommendations of the SB members, will be applicable to future grant of SAG-Permit, and advice Hon. Katangkatang to take note of these recommendations.

And with no further discussions, the Chair request Hon. Katangkatang to offer the final motion.




Hon. Salgado moves the above proposed resolution, seconded by Hon. Altres, Hon. Aure and Hon. Pormida. And then after, the Chair ask the proponent if the SB has the draft of the Ordinance already and give the floor to Hon. Salgado.

Hon. Salgado opines and discuss to the Body prevailing's laws as the basis for the enactment of the Ordinance, as follows:

- a. Section 16, LGC of 1991, General Welfare, LGUs shall maintain Peace and Order for the protection of its constituents; and
- b. Executive Order No. 297, regulating the manufacture, selling and distribution of PNP uniforms, insignias and other accoutrements, which also imposed penalties for violation of the E.O.

Hon. Altres speaks out and request Hon. Salgado to explain further the word "accoutrements" Hon. Salgado reply that it includes medals, specializations, accomplishments of the PNP which are attach and form part of the uniform, and then after Hon. Salgado proceed to present the Ordinance thru a power point.


The Chair opines and asks if every establishment/business engage in manufacturing, selling and distribution of PNP uniform shall secure first a "Certificate of Conformity" from the PNP before it could operate their business.

Hon. Salgado said that the Certificate of Conformity is issued by the PNP and it compliments with the business permit issued by the LGU.

The Chair inquire from Hon. Salgado that if the owner of the business is not a resident of Jaro will they be allowed to do business.

Hon. Salgado reply that even though the owner/operator of the business to manufacture PNP uniform are not from Jaro if their place of business is located in Jaro, they will be allowed to operate their business subject to the provisions of the municipal ordinance.

Hon. Salgado said further that the primary purpose to regulate the manufacturing, selling and distribution of PNP uniforms is to prevent the wearing of PNP uniforms by private individuals, for there are cases that it is used by some criminals in the commission of a crimes, for them to have freedom of movement, in perpetrating a crime.



Hon. Aure opines and then proposed to Hon. Salgado, that those engage in on-line selling should also be covered by the Ordinance.



Hon. Salgado opines that the suggestions of Hon. Aure is noted, that those engaging in on-line selling will also be covered the ordinance in social media platform.


Hon. Que suggest to include provisions in the Ordinance for the purchaser of PNP uniform to secure permit from the PNP Office, which the store owner shall require before selling the PNP uniform to the PNP personnel, items to be purchase should be itemized in the PNP-Permit.

Hon. Salgado opines that the suggestions of Hon. Que will be included in the formulation of the IRR of Ordinance No. 30, Series of 2024 (ex. PNP permit, list to be purchase and IDs).




Further Hon. Salgado said that customarily PNP personnel uses only their IDs as legal identity as member of the PNP force, when transacting business with stores, whenever they would purchase PNP uniforms.



Hon. Emnas opines that it has been his observations that those subversive/lawless personalities are wearing PNP/Military Uniforms which is tolerated by the PNP or Military.



Hon. Salgado opines that because of the absence of a law to regulate the use of private individuals of PNP/Military Uniforms, these subversive/lawless personalities can openly purchase such uniforms.



Further Hon. Salgado said with the enactment of the Ordinance in Jaro, although there are no yet manufacturers/sellers of PNP uniforms in the LGU, will serve as a pre-emptive measure, in times when there will be manufacturers/sellers of PNP uniforms.

Hon. Salgado continue that the PNP Regional Office VIII, is encouraging the LGU, to enact the Ordinance, for there are only few nationwide who have enacted the ordinance, and Jaro most likely one of the pioneering to enact the ordinance in the province,

The Chair opines and ask Hon. Salgado if PNP uniforms issued to PNP personnel are ready made, or customized, and if there are tailoring in Tacloban who produced PNP uniforms.

Hon. Salgado reply there are some tailoring in Tacloban, who cater to tailored PNP uniforms, and they were authorized and accredited suppliers of PNP uniforms thru a Memorandum Circular issued by the PNP Agency.




Hon. Que asks from Hon. Salgado if the LGU's in the region has already enacted the Ordinance.

Hon. Que opines it follows that the LGU-Jaro will be ahead from other municipalities in the province.


Hon. Salgado said that Jaro will be the pioneering to enact the ordinance in the region, and this will have a positive impact for the LGU-Jaro.
