

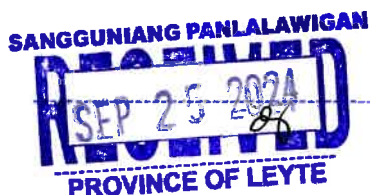

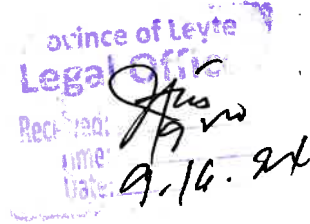

ORDINANCE NO. 2024 - 08

AN ORDINANCE CREATING THE TOURIST INFORMATION AND ASSISTANCE CENTER IN THE MUNICIPALITY OF CALUBIAN, LEYTE.

BE IT ORDAINED, by the Sangguniang Bayan of Calubian, Leyte, in a session assembled that:

SECTION 1. TITLE. This Ordinance shall be known as “*An Ordinance creating the Tourist Information and Assistance Center in the Municipality of Calubian, Leyte*”.

SECTION 2. DECLARATION OF POLICY. Consistent with the Tourism Act of 2009, it is hereby declared policy of the Municipality of Calubian, Leyte to promote, encourage and develop tourism as a major activity in which private sector investment efforts and initiatives are fostered and supported leading to socio-cultural-economic development in local government units and enhance the sense of heritage and pride for all Calubianons.

Towards this end, the Municipality shall seek to:

- a. Recognize sustainable tourism development as a measure to improve the quality of life of the Calubianons through the developments, promotion and marketing of competitive tourism destinations and products;
- b. Promote and develop the eco-tourism sites for them to be ecologically sustainable, responsible, participative, culturally sensitive and ethically and socially equitable for all communities;
- c. Encourage private sector participation and collaboration and linkage with various institutions
- d. Create and secure safe environments with all communities

SECTION 3. LEGAL BASIS. Republic Act 9593 otherwise known as the Tourism Act of 2009, Section 43 states that in coordination with the DOT Regional Offices, every province, city or municipality in which tourism is a significant industry shall establish a tourist information and assistance center / desk to assist tourists and tourism enterprise;

Whereas, **Ordinance No. 2023-18** of the municipality of Calubian, Leyte otherwise known as “**An Ordinance Declaring the Eco-Tourism Site Destinations of the Municipality of Calubian, Leyte, Its Development, Promotion and for Other Purposes**” declared thirty-one (31) eco-tourism sites, destinations and cultural heritage.

SECTION 4. FUNCTIONS. The general function(s) of the Tourism Information and Assistance Center is to initiate marketing- provide materials like leaflets, flyers, brochures, tarpaulin & online pots and publications for all local tourism destinations, receive and assists local and international tourists, create and implement guided tour(s) within the town, assist in the accommodation and transportation, safety and all other related needs for all town visitors.

SECTION 5. LOCATION. The Tourism Information and Assistance Center shall be located in the New Tourism Building at Brgy. T. Poblacion, Calubian, Leyte. The Center shall be under the supervision of the Municipal Tourism Officer or its designate and with other staff under his / her office manning the center on a regularly and daily basis.

SECTION 6. SCOPE AND COVERAGE OF THE ORDINANCE. This ordinance shall cover only the creation and functions of the Tourism Information and Assistance Center, excluding the total Developmental Plan for all eco-tourism site destinations of the municipality.

SECTION 7. REPEALING CLAUSE. All Ordinances or resolutions, local issuances or rules inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

SECTION 8. SEPARABILITY CLAUSE. If any provision of this Ordinance is declared invalid or unconstitutional, the remaining provision not affected thereby, shall continue to be in full force & effect.

SECTION 8. EFFECTIVITY CLAUSE. The Ordinance shall take effect immediately upon approval from the Honorable Sangguniang Panlalawigan of the Province of Leyte.


