AN ORDINANCE INSTITUTIONALIZING THE GRANT OF INCENTIVES TO THE TOP THREE (3) TABANGO, LEYTE PUBLIC SCHOOL LEARNERS FOR ACADEMIC ACHIEVEMENT AND PUBLIC SERVICE.

WHEREAS, pursuant to Section 2 (3) Article XIV of the Philippine Constitution provides that the State shall establish and maintain a system of scholarship grants, student loan programs, subsidies, and other incentives that shall be available to deserving students in both public and private schools, especially to the unprivileged;

WHEREAS, in line with the implementation of Republic Act No. 10533, otherwise known as the Enhanced Basic Education Act of 2013, the Municipality of Tabango, Leyte recognizes the outstanding performance and achievements of learners in academic and public service through student leadership;

WHEREAS, the Academic Achievers Award is a recognition for those Learners who obtained the top 3 highest general average in Grades 6, 12, and 4th year College in all public elementary, secondary, and tertiary schools in the Municipality of Tabango.

WHEREAS, the Joy of Public Service Award, through the Municipal Mayor, Bernard Jonathan Remandaban, the Municipal of Tabango awarded to the students who have shown exemplary commitment to the service of the school, its communities, and its students. The recipient must also have shown interest in and genuine concern for social issues such as environmental protection and children's rights and welfare. Overall, he/she must be a role model of genuine leadership and must be worthy of emulation by others;

WHEREAS, the Municipal of Tabango institutionalizes these recognitions to encourage learners to strive for excellence and become proactive members of the school and community, especially during extraordinary and challenging times.

NOW, THEREFORE, Be it enacted by the Sangguniang Bayan of Tabango, Leyte in session assembled that:

**SECTION 1. SHORT TITLE**. - This Ordinance shall be known as the "Cash Incentives for the Top Three (3) Academic Achievers and Joy of Public Service Awards Ordinance in the Municipality of Tabango."

**SECTION 2. DECLARATION OF POLICY**. - It is the policy of the Municipality of Tabango to recognize exemplary academic achievements and public service through student leadership.

SECTION 3. OBJECTIVES. - This Ordinance shall have the following objectives:

- a. To recognize exemplary academic achievements and leadership of Grade 6, Grade 12, and 4<sup>th</sup>-year college graduating learners of Tabango, Leyte public schools.
- b. To encourage learners to strive for excellence and to become proactive members of the schools and community, especially during these extraordinary and challenging times.

BERNARD JONATHAN M. REMANDARMECTION 4. INCENTIVES FOR TOP 3 GRADUATING LEARNERS. - Graduating learners with the highest general average in Grade 6, Grade 12, and 4<sup>th</sup> year College graduating learners in public schools shall be granted the following incentives.

For Grade Six (6) Top 3 Academic Achievers.

i. First Highest General Average ₱1,500.00
 ii. Second Highest General Average ₱1,000.00
 iii. Third Highest General Average ₱800.00

b. For Grade Twelve (12) Top 3 Academic Achievers.

iv. First Highest General Average
 v. Second Highest General Average
 p1,500.00
 vi. Third Highest General Average
 p1,000.00

For 4<sup>th</sup> Year College Top 3 Academic Achievers.

 vii. Suma Cum Laude
 ₱2,500.00

 viii. Magna Cum Laude
 ₱2,000.00

 ix. Cum Laude
 ₱1,500.00

**SECTION 5. INCENTIVES FOR JOY OF PUBLIC SERVICE AWARD**. - It is hereby institutionalized to recognize students in Grade 6, Grade 12, and 4<sup>th</sup> year College learners who have aptly demonstrated the value of service above self by showing exemplary commitment to the service of the school, its communities, and its students. The Joy of Public Service Awardees shall be granted the following incentives:

a. For Grade Six (6) Graduating Student Php 2,00.00b. For Grade Twelve (12) Graduating Student Php 3,000.00

**SECTION 6. APPROPRIATION**. - The budgetary requirements shall be included in the annual appropriations of the General Fund.

**SECTION 7. IMPLEMENTING OFFICE**. - The Local School Board of Tabango, Leyte shall be the main implementer of this Ordinance.

**SECTION 8. IMPLEMENTING RULES AND REGULATIONS.** - The Local School Board of Tabango, Leyte shall issue the Implementing Rules and Regulations within sixty (60) days from the approval of this Ordinance for its effective implementation.

**SECTION 9. SEPARABILITY CLAUSE**. - If any part or section of this Ordinance is declared unconstitutional for any reason whatsoever such declaration shall not in any way affect other parts or sections of this Ordinance.

**SECTION 10. REPEALING CLAUSE.** - All previous ordinances are hereby repealed or modified accordingly if found inconsistent with the provisions of this Ordinance.

**SECTION 11. EFFECTIVITY CLAUSE**. - This Ordinance shall take effect immediately upon its approval.
