#### REVIEW/RECOMMENDATION/LEGAL OPINION:

This office is of the opinion that the subject Ordinance is within the powers covered under Section 16<sup>1</sup> General Welfare Clause, Section 447(1)(iii)<sup>2</sup> and Section 447(1)(vi)<sup>3</sup> of the Local Government Code of 1991 (R.A7160) and in consonance with Article II Section 16<sup>4</sup> of the 1987 Philippine Constitution.

Furthermore, said ordinance is in line with the mandate of Republic Act 9147 the Wildlife Resources and Protection Act, which provides for the conservation and protection of wildlife resources and their habitats, appropriating funds therefor and for other purposes. Hence, recommending for the declaration of its validity

# **EXPLANATORY NOTE**

Section 16, Article II of the 1991 Philippine Constitution provides that "the state shall protect and advance the right of the people to a balance and healthful ecology in accord with the rhythm and harmony of nature."

Section 2 of Republic Act 9147 also known as the "Wildlife Resources Conservation and Protection Act", states that, "it shall be the policy of the state to conserve the country's wildlife resources and their habitats for sustainability."

Section 35 of RA 9147, provides that Local Government Unit shall initiate conservation measures for endemic species in their areas.

Based on records of the Department of Environment and Natural Resources (DENR), the Philippines is one of the top biodiversity hotspots endemic species of birds, and mammals which are considered threatened or endangered.

Hence, this proposal to enact the herein Ordinance.

## ORDINANCE NO. 26 SERIES OF 2024

# AN ORDINANCE ENACTING THE WILDLIFE PROTECTION OF JARO, LEYTE AND IMPOSING PENALTY FOR VIOLATIONS THEREOF

Be it ordained by the Sangguniang Bayan of Jaro, Leyte, that-

SECTION 1. TITLE – This ordinance shall be known as "The Wildlife Protection of Jaro, Leyte".

**SECTION 2. DECLARATION OF POLICY** - It shall be the policy of the Local Government Unit of Jaro to conserve the municipality's wildlife resources and their habitats for sustainability. In the pursuit of this policy, this ordinance shall have the following objectives:

- A. To conserve and protect municipality's wildlife species and their habitats to promote ecological balance and enhance biological diversity;
- B. To regulate the collection and trade of wildlife;
- C. To pursue, in consonance to the national interest on the commitment for the conversations, protection of wildlife and their habitats; and
- D. To initiate and support scientific studies on the conservation of biological diversity in the municipality.

**SECTION 3. SCOPE** – This ordinance is for the protection of all the municipality's wildlife species and shall be enforceable within the territorial jurisdiction of Jaro, Leyte.

**SECTION 4. DEFINITION OF TERMS** – For the purpose of this ordinance, the following shall mean:

- A. Conservation means preservation and sustainable utilization of wildlife, and/or maintenance, restoration and enhancement of the habitat;
- B. Critically Endangered Species refers to a species or subspecies that is facing extremely high risk of extinction in the wild in the immediate future, such as among of the others: Leyte Bleeding Heart Pigeon, Visayan Writhed Hornbill, Golden Crowned Flying Fox, Leyte Bared Backed Fruit Bat, Visayan Tarictic Hornbill, Visayan Spotted Dear, Palm Civet, Malay Civet) This is inclusive only of endangered species found in Leyte.
- C. Endemic Species means species or subspecies which is naturally occurring and found only within specific areas in the municipality;
- D. Exotic Species means species or subspecies which do not naturally occur in the municipality;
- E. Habitat means a place or environment where a species or subspecies naturally occur or has naturally established its population;
- F. Indigenous Wildlife means species or subspecies of wildlife naturally occurring or has naturally established population in the municipality;

- G. Wildlife means wild forms and varieties of flora and fauna, in all developmental stages, including those which are in captivity or are being bred or propagated;
- H. By-Product or Derivatives means any part taken or substance extracted from wildlife, in raw or in processed form. This includes stuffed animals and herbarium specimens;
- Collection or Collecting means the act of gathering or harvesting wildlife, its by-products or derivatives;
- J. Wildlife Collectors Permit means a permit to take or collect from the wild certain species and quantities of wildlife for commercial purposes;
- K. Wildlife farm/culture permit means a permit to develop, operate and maintain a wildlife and breeding farm for conservation, trade and /or scientific purposes.

SECTION 5. LOCAL TRANSPORT OF WILDLIFE, BY-PRODUCTS AND DERIVATIVES - Local transport of wildlife, by-products and derivatives collected or possessed through any other means shall be authorized unless the same is prejudicial to the wildlife and public health.

Transport of wildlife shall be accompanied by proper permit and documents from the Department of Environment and Natural Resources (DENR). The absence of permit shall be prima facie evidence that the wildlife is illegally obtained and transported. Further, the subject wildlife shall be immediately confiscated and transfer to the nearest Wildlife Rescue Center of the municipality.

Provided further, the conveyance/s used to transport wildlife, by-products and derivatives belonging to a third person/s who has not participated in or knowledge of the illegal acts, the same may be released to said owner/s only after presentation of authentic documents of ownership.

**SECTION 6. PROHIBITED ACTS** - Unless otherwise allowed in accordance with R.A. 9147, it shall be unlawful for any person to willfully and knowingly exploit wildlife resources and their habitats, or undertake the following acts:

- **A.** Killing and destroying wildlife species except in the following instances:
  - 1. When the wildlife is afflicted with an incurable disease;
  - 2. When it is deemed necessary to put an end to the misery suffered by the wildlife;
  - When it is done to prevent an imminent danger to the life or limb of a human being; and
  - **4.** When the wildlife is killed or destroyed after it has been used in an authorized research or experiments.
- B. Trading of wildlife;
- **C.** Gathering or destroying of active nest's, nest trees, host plants and the like;
- D. Transporting of wildlife, by-products and derivatives; and
- E. Collecting, hunting, or possessing wildlife, their by-products and derivatives.

SECTION 7. WILDLIFE TRAFFIC MONITORING UNIT - There must be created a Municipal Wildlife Traffic Monitoring Unit assigned in the Municipal Veterinary's Office, who must have proper training in identifying the wildlife. Such unit, must also disseminate information on what acts are prohibited and banned species in every barangay.

The Municipal Wildlife Traffic Monitoring Unit shall regularly monitor all Pet Shop Stores, situated in our town of Jaro to ensure that no wildlife is illegally traded.

SECTION 8. COMPOSITION OF THE LOCAL MUNICIPAL WILDLIFE ENFORCEMENT OFFICERS - The Municipal Wildlife Enforcement Officers shall be composed of the following:

Chairman

: Municipal Mayor

Vice-Chairman: Chairman Committee on Environmental Protection

Members

: Representative from the Municipal Veterinary's Office

: Representative from the Municipal Department of

Agriculture

: Representative from the Municipal Environment

Resources Office (MENRO)

: Representative from the Town's Legal Sector

: Representative from the Department of Environment and Natural Resources (DENR), or duly authorized

Representative

: Representative from the JARO-PNP

SECTION 9. DEPUTATION OF WILDLIFE ENFORCEMENT OFFICERS

The Wildlife Enforcement Officers shall have the full authority to seize illegally traded wildlife and to arrest violators subject to existing laws, rules and regulations on arrest and detention.

SECTION 10. WILDLIFE RESCUE CENTER - The Municipal Mayor's Office thru the Municipal Veterinary and/or Agriculture Office shall establish a wildlife rescue center that will temporarily detain all confiscated, abandoned and/or donated wildlife to ensure their welfare and well-being.

All confiscated wildlife species shall be properly turned over to the Department of Environment and Natural Resources (DENR) in accordance with the guidelines set forth under RA 9147.

SECTION 11. PENALTIES FOR VIOLATION OF THIS ORDINANCE – For any person who undertakes illegal acts enumerated in Section 6, the following penalties and or fines shall be imposed:

- **A.** First Offense A fine of One Thousand Five Hundred Pesos (P 1,500.00)
- B. Second Offense A fine of Two Thousand Pesos (P 2,000.00)
- C. Third Offense A fine of Two Thousand Five Hundred Pesos (P 2,500.00)

Provided, that the fines imposed under this Ordinance shall be without prejudice to the penalties imposed under Section 28 of R.A. 9147, also known as "The Wildlife Resources Conservation and Protection Act".

SECTION 12. THE LOCAL WILDLIFE ENFORCEMENT OFFICERS - Shall formulate guidelines and Implementing Rules and Regulations (IRR) for the effective implementation of this ordinance subject to the approval of the Sangguniang Bayan.

**SECTION 13. BUDGET -** The Municipality shall allocate an annual budget of **FIVE HUNDRED THOUSAND PESOS (P 500,000.00)** from the General Appropriation Fund for the purpose of this ordinance.

SECTION 14. SEPARABILITY CLAUSE - The provisions of this Ordinance are hereby declared separable and if any clause, sentence, provision or section is declared invalid it shall not affect the other provisions or the application of the ordinance.

**SECTION 15. REPEALING CLAUSE** - All Ordinances and resolutions or any part thereof inconsistent with any of the provisions of this ordinance are hereby repealed and/or modified accordingly.

Hon. Aure speaks out and informed the Body that Miss Sophia Rose Panao Garra, who is studying in Manila (NCR), is the daughter of Mr. and Mrs. Aerole Garra, from Jaro, Leyte and the granddaughter of the late Dr. Toti Garra.

Further, Hon. Aure apprises also the Body that Ms. Garra is a record breaker in swimming 100 meters backstroke in the Palarong Pambansa, which the previous record was 1:95 compared in 2024 of 1:08:05.

## ORDINANCE NO. 26 **SERIES OF 2024**

# AN ORDINANCE ENACTING THE WILDLIFE PROTECTION OF JARO, LEYTE AND IMPOSING PENALTY FOR VIOLATIONS THEREOF

Be it ordained by the Sangguniang Bayan of Jaro, Leyte, that-

SECTION 1. TITLE - This ordinance shall be known as "The Wildlife Protection of Jaro, Leyte".

SECTION 2. DECLARATION OF POLICY - It shall be the policy of the Local Government Unit of Jaro to conserve the municipality's wildlife resources and their habitats for sustainability. In the pursuit of this policy, this ordinance shall have the following objectives:

- A. To conserve and protect municipality's wildlife species and their habitats to promote ecological balance and enhance biological diversity;
- B. To regulate the collection and trade of wildlife;
- C. To pursue, in consonance to the national interest on the commitment for the conversations, protection of wildlife and their habitats: and
- D. To initiate and support scientific studies on the conservation of biological diversity in the municipality.

**SECTION 3. SCOPE** – This ordinance is for the protection of all the municipality's wildlife species and shall be enforceable within the territorial jurisdiction of Jaro, Leyte.

SECTION 4. DEFINITION OF TERMS - For the purpose of this ordinance, the following shall mean:

- A. Conservation means preservation and sustainable utilization of wildlife, and/or maintenance, restoration and enhancement of the habitat;
- B. Critically Endangered Species refers to a species or subspecies that is facing extremely high risk of extinction in the wild in the immediate future, such as among of the others: Leyte Bleeding Heart Pigeon, Visayan Writhed Hornbill, Golden Crowned Flying Fox, Leyte Bared Backed Fruit Bat, Visayan Tarictic Hornbill, Visayan Spotted Dear, Palm Civet, Malay Civet) This is inclusive only of endangered species found in Leyte.
- C. Endemic Species means species or subspecies which is naturally occurring and found only within specific areas in the municipality;
- D. Exotic Species means species or subspecies which do not naturally occur in the municipality;
- E. Habitat means a place or environment where a species or subspecies naturally occur or has naturally established its population;
- F. Indigenous Wildlife means species or subspecies of wildlife naturally occurring or has naturally established population in the municipality:

- **G. Wildlife** means wild forms and varieties of flora and fauna, in all developmental stages, including those which are in captivity or are being bred or propagated;
- H. By-Product or Derivatives means any part taken or substance extracted from wildlife, in raw or in processed form. This includes stuffed animals and herbarium specimens;
- Collection or Collecting means the act of gathering or harvesting wildlife, its by-products or derivatives;
- J. Wildlife Collectors Permit means a permit to take or collect from the wild certain species and quantities of wildlife for commercial purposes;
- K. Wildlife farm/culture permit means a permit to develop, operate and maintain a wildlife and breeding farm for conservation, trade and /or scientific purposes.

SECTION 5. LOCAL TRANSPORT OF WILDLIFE, BY-PRODUCTS AND DERIVATIVES - Local transport of wildlife, by-products and derivatives collected or possessed through any other means shall be authorized unless the same is prejudicial to the wildlife and public health.

Transport of wildlife shall be accompanied by proper permit and documents from the Department of Environment and Natural Resources (DENR). The absence of permit shall be prima facie evidence that the wildlife is illegally obtained and transported. Further, the subject wildlife shall be immediately confiscated and transfer to the nearest Wildlife Rescue Center of the municipality.

Provided further, the conveyance/s used to transport wildlife, by-products and derivatives belonging to a third person/s who has not participated in or knowledge of the illegal acts, the same may be released to said owner/s only after presentation of authentic documents of ownership.

SECTION 6. PROHIBITED ACTS - Unless otherwise allowed in accordance with R.A. 9147, it shall be unlawful for any person to willfully and knowingly exploit wildlife resources and their habitats, or undertake the following acts:

- **A.** Killing and destroying wildlife species except in the following instances:
  - 1. When the wildlife is afflicted with an incurable disease:
  - 2. When it is deemed necessary to put an end to the misery suffered by the wildlife;
  - 3. When it is done to prevent an imminent danger to the life or limb of a human being; and
  - **4.** When the wildlife is killed or destroyed after it has been used in an authorized research or experiments.
- B. Trading of wildlife;
- C. Gathering or destroying of active nest's, nest trees, host plants and the like;
- D. Transporting of wildlife, by-products and derivatives; and
- **E.** Collecting, hunting, or possessing wildlife, their by-products and derivatives.

SECTION 7. WILDLIFE TRAFFIC MONITORING UNIT - There must be created a Municipal Wildlife Traffic Monitoring Unit assigned in the Municipal Veterinary's Office, who must have proper training in identifying the wildlife. Such unit, must also disseminate information on what acts are prohibited and banned species in every barangay.

The Municipal Wildlife Traffic Monitoring Unit shall regularly monitor all Pet Shop Stores, situated in our town of Jaro to ensure that no wildlife is illegally traded.

The Wildlife Enforcement Officers shall have the full authority to seize illegally traded wildlife and to arrest violators subject to existing laws, rules and regulations on arrest and detention.

SECTION 10. WILDLIFE RESCUE CENTER – The Municipal Mayor's Office thru the Municipal Veterinary and/or Agriculture Office shall establish a wildlife rescue center that will temporarily detain all confiscated, abandoned and/or donated wildlife to ensure their welfare and well-being.

All confiscated wildlife species shall be properly turned over to the Department of Environment and Natural Resources (DENR) in accordance with the guidelines set forth under RA 9147.

SECTION 13. BUDGET - The Municipality shall allocate an annual budget of *FIVE HUNDRED THOUSAND PESOS (P 500,000.00)* from the General Appropriation Fund for the purpose of this ordinance.

**SECTION 14. SEPARABILITY CLAUSE -** The provisions of this Ordinance are hereby declared separable and if any clause, sentence, provision or section is declared invalid it shall not affect the other provisions or the application of the ordinance.

SECTION 15. REPEALING CLAUSE - All Ordinances and resolutions or any part thereof inconsistent with any of the provisions of this ordinance are hereby repealed and/or modified accordingly.

## **EXPLANATORY NOTE**

Section 16, Article II of the 1987 Philippine Constitution expressly declares that the State shall protect and advance the right of the people to a balanced and healthful ecology in accord with the rhythm and harmony of nature.

Section 447 (a) (5) (i) of RA 7160, or otherwise known as the Local Government Code of 1991, states that the Sangguniang Bayan shall provide for the establishment, maintenance, protection, and conservation of communal forests and watersheds, tree parks, greenbelts, and other similar forest development projects.

Relative thereto, every municipality is mandated to exert efforts to establish. develop and maintain a permanent forest, tree parks or watershed areas within public lands owned by the municipality with an aggregate size equivalent to at least two percent of its entire area, Provided, that forest, park, or watershed areas may be located in one or more places within the municipality.

Section 2 of Republic Act No. 9275, or otherwise known as Philippine Clean Water Act of 2004, provides that the state shall pursue a policy of economic growth in a manner consistent with the protection, preservation and revival of the quality of our fresh waters. To achieve this end, the framework for sustainable development shall be pursued. As such, it shall be the policy of the State:

- To streamline processes and procedures in the prevention, control and abatement of pollution of the country's water resources;

- To formulate and enforce a system of accountability for short and long-term adverse environmental impact of a project, program or activity; and
- j. To encourage civil society and other sectors, particularly labor, the academe and business undertaking environment-related activities in their efforts to organize, educate and motivate the people in addressing pertinent environmental issues and problems at the local and national levels.

It provides further, that every concerned agency, association and individuals shall extend efforts in order to conserve, protect, restore and enhance the water bodies within the local government unit, consistent with the rules and regulations authorized or promulgated by the Secretary for Agriculture and Natural Resources.

The Municipality of Jaro, Leyte recognizes on the need to conserve and protect the municipal waters and its resources within its territorial jurisdictions, and is committed to ensure the sustainable management, development and its conservation; henceforth, this proposed ordinance for the enactment of the Sangguniang Bayan.

## ORDINANCE NO. 27 **SERIES OF 2024**

AN ORDINANCE FOR THE PURPOSE OF PROTECTION AND PRESERVATION OF RIVERS OWNED WITHIN THE JURISDICTION OF JARO, LEYTE AND IMPOSING PENALTY FOR VIOLATIONS THEREOF.

SECTION 1. TITLE - This Ordinance shall be known as the "An Ordinance for the Purpose of Protection and Preservation of Rivers Owned Within the Jurisdiction of Jaro, Leyte and Imposing Penalty for Violations Thereof".

SECTION 2. DECLARATION OF POLICY - It is hereby the declared policy of the municipality to:

- A. Promote conservation and ensure sustainable and equitable management of its water bodies, especially ( 3 different watershed areas in Jaro, in conformity with local laws and regulations and other applicable special laws of the Philippines;
- B. Ensure, for the benefit and enjoyment of the people of Jaro, the judicious and wise utilization, protection, conservation and sustainable management of its water bodies and its resources to maintain biodiversity and sound ecological balance, protect the surroundings in order to preserve the existing panoramic view of the environment:
- C. Allow people's full and active participation in the conservation and management of the water bodies of Jaro and its resources and promote awareness through appropriate education and training including the proper taking out, catching or collecting of any living or non-living thing from or within the water bodies;

- D. Provide full support for sustainable protection and conservation of the municipal waters through appropriate technology and research, adequate financing, production and marketing assistance and other services:
- E. Allow the private sector to develop and utilize resources under the basic concepts that the grantee, licensee or permittee thereof, shall not only be a privileged beneficiary of the municipality, but also an active participant and partner of the municipal government in the management, development, conservation and protection of the water bodies and the resources of the municipality; and
- F. Promote and adhere to the precautionary principle of conservation, management and exploitation of living water resources in order to assure the sustainable development of its surrounding environment. The absence of adequate scientific and technical information should not be used as a reason for postponing or failing to take conservation and management measures.

**SECTION 3. OBJECTIVE** - The objective of this Ordinance is to protect and manage the water bodies, in all rivers owned within the jurisdiction of the municipality to ensure the sustainable use thereof, for better enjoyment and benefit of the people, and to establish the means and methods to enforce, control and regulate the activities of visitors, tourists, swimmers, and other resource users of the municipal rivers of Jaro.

#### SECTION 4. APPLICABILITY AND ENFORCEMENT OF THE

ORDINANCE - The provisions of this Ordinance shall be applied and enforced in:

**A.** All the municipal waters/rivers in Jaro, which includes creeks and watersheds areas:

- **B.** Apprehension Coordinate with the Philippine National Police-Jaro and Department of Natural and Environment Resources, if necessary for the apprehension of any person, natural or juridical, found to be violating any of the prohibited acts of this Ordinance.
- C. Information, Education, Communication (IEC) Coordinate with the Business Permit and Licensing Office/Local Economic and Investment Promotions Office for the conduct of massive IEC activities in collaboration with appropriate government or private agencies on proper wastewater management to increase the level of awareness and commitment of the public to the conservation and cleanliness of the water bodies and watershed areas of the municipality.

In addition to the foregoing functions, the Municipal Bantay Kalikasan Task Force, shall maintain the quality of the water bodies at the optimal level relative to protection of the conservation areas as well as the natural productivity and the cleanliness of areas devoted for aquaculture development, (ex. in-land fish ponds), in coordination with the concerned offices and departments of the national government.

**SECTION 6. PROHIBITED ACTS -** Thus, the following shall be considered as prohibited acts:

- **A.** Discharging water pollutants and other hazardous substances to the water bodies of Jaro, Leyte.
- **B.** Disposing of potential infectious medical waste into water bodies like in rivers and creeks.
- **C.** Killing and destroying species and other living water resources by using prohibited chemicals, electrocution, and the like.

- D. Throwing of litters or scattering of solid waste in the water bodies within the municipality.
- E. Leaving of animal manure or improper waste disposal of the owner of the animal to any water bodies.
- F. Other activities in the grounds or waters which directly or indirectly result or likely to result in damage or destruction to the water bodies and its resources, or may have such deleterious effect that may harm the living and non-living water resources, or may cause hazard to human health.

SECTION 7. PENALTIES AND FINES - Any person or entity who has committed the prohibited acts enumerated in the preceding section shall be subject to the following penalties and fines:

- A. First Offense A fine of One Thousand Five Hundred Pesos (P 1,500.00) and/or community service for a period of eight (8) hours.
- B. Second Offense A fine of Two Thousand Pesos (P 2,000.00), or community service for a period of sixteen (16) hours.
- C. Third and Subsequent Offenses A fine of Two Thousand Five Hundred Pesos (P 2,500.00), community service for 24 hours.

The fines imposed under this Ordinance shall be without prejudice to the penalties imposed under Section 28 of R.A. 9275, also known as "An Act Providing for a Comprehensive Water Quality Management and for other Purposes."

In addition to the foregoing, the violators shall be required to contain, remove and clean-up the pollutants at their own expense. In case of failure to do such requirement, the municipality shall undertake containment, removal and cleanup operations and the cost incurred in the operations shall be at the expense of the violators.

Provided, That the municipality shall take appropriate legal action for damages under existing and applicable laws and ordinances, including the application for injunctive relief, in order to address the violation of this Ordinance.

Provided, further the collected fines shall be remitted to the Municipal Treasurer for appropriate financial recording and shall form part of the municipal funds. An incentive of twenty percent (20%) of all the fines collected shall be shared equitably among the persons involved in the apprehension of the violators.

**SECTION 8. MANDATORY REVIEW** - The Sangguniang Bayan shall undertake to review mandatorily this Ordinance at least once every three (3) years or as often as it may deem necessary, to ensure that the policies and guidelines relative to the protection, management, conservation and/or development of the water bodies of the municipality and its water resources remain responsive to the changing circumstances of time.

**SECTION 9. SEPARABILITY CLAUSE -** The provisions of this Ordinance are hereby declared separable, and if any clause, sentence, provision or section is declared invalid, it shall not affect the other provisions or application of the ordinance

**SECTION 10. EFFECTIVITY -** This ordinance shall take effect Fifteen (15) days after a copy hereof is posted in at least three (3) conspicuous places in the municipality in accordance with the provision of R.A. 7160.

#### **EXPLANATORY NOTE**

Article XIII Section 11 of the 1987 Philippine Constitution provides that "The State shall adopt an integrated and comprehensive approach to health development which shall endeavor to make essential goods, health and other social services available to all the people at affordable cost."

The Barangay Health Workers are frontliners in the facilitation and delivery of primary health care services in the barangays and play a vital role in uplifting and maintaining a good barangay health standard.

Republic Act 7883 defined a Barangay Health Worker as a person who has undergone training programs under any accredited government and non-government organization and who voluntarily renders primary health care services in the community after having been accredited to function as such by the local health board in accordance with the guidelines promulgated by the Department of Health (DOH).

Section 6 of Republic Act No. 7883, otherwise known as, "An Act Granting Benefits and Incentives to Accredited Barangay Health Workers and for other Purposes", enumerated incentives for the accredited BHWs who are actively and regularly performing their duties shall be entitled to the following benefits and incentives:

- 1. Subsistence Allowance
- 2. Hazard Allowance
- 3. Training, education and career enrichment programs
- 4. One-child scholarship allowance
- 5. Civil Service Eligibility
- 6. Free Legal Assistance
- 7. Preferential access to loans and loan facilities of government lending institutions

## **ORDINANCE NO. 28 SERIES OF 2024**

AN ORDINANCE PROVIDING AN ANNUAL LIFE AND ACCIDENT INSURANCE BENEFIT TO ALL BARANGAY HEALTH WORKERS OF THE MUNICIPALITY OF JARO, PROVINCE OF LEYTE.

BE IT ORDAINED by the Sangguniang Bayan in regular session assembled:

SECTION 1. TITLE - This Ordinance shall be known as "An Ordinance Providing an Annual Life and Accident Insurance Benefit to All Barangay Health Workers of the Municipality of Jaro, Province of Leyte".

SECTION 2. COVERAGE - This Ordinance shall include all Accredited Barangay Health Workers (BHWs) of all barangays within the Municipality of Jaro, Province of Leyte.

SECTION 3. BUDGETARY ALLOCATION - All Barangays must provide on their annual budget under the MOOE classification a budgetary allocation to fund the annual premium to cover the life and accident insurance of BHWs. The annualized premium per Barangay Health Worker shall range from a minimum of Php 500.00 up to a maximum of Php 1,000.00.

SECTION 4. LOCAL BHW ORGANIZATION - The Municipality of Jaro BHW organization shall coordinate and source insurance companies who can provide to them life and accident insurance. After getting quotes from at least three insurance companies, they shall forward such quotes to the Liga Ng Mga Barangay.

SECTION 5. INSURANCE COMPANY PROVIDER - With the annualized premium stipulated from the preceding section, the Liga ng mga Barangay shall determine and choose the Insurance Company who can give the best insurance coverage based on the quotations provided by the Local BHW organization.

SECTION 6. PENALTIES - For failure to comply the provisions of this ordinance, the persons responsible shall be meted with administrative liability.

SECTION 7. SEPARABILITY CLAUSE - If any provision of this Ordinance is declared invalid or unconstitutional, the other provisions not affected thereby shall continue to be in full force and effect.

SECTION 8. REPEALING CLAUSE - Municipal Ordinances, Resolutions, Local Executive Orders or other administrative issuances found to be inconsistent with any provision of this Ordinance are hereby repealed or modified accordingly.

SECTION 9. EFFECTIVITY CLAUSE - This ordinance shall take effect after Fifteen (15) days of its posting in at least Three (3) conspicuous places in the Municipality of Jaro, Leyte, in compliance to RA 7160.


