



ORDINANCE NO. 2024 - 12

AN ORDINANCE ESTABLISHING THE OFFICE FOR SENIORS CITIZENS AFFAIRS (OSCA) IN THE MUNICIPALITY OF CALUBIAN, LEYTE AS MANDATED UNDER REPUBLIC ACT NO. 9994.

NOW THEREFORE, on motion of SB Member Eugenio A. Ching, Jr., duly seconded by the majority Members present;

BE IT ORDAINED, AS IT IS HEREBY ORDAINED, by the Sangguniang Bayan of Calubian, Leyte in session assembled, that:

SECTION 1. TITLE. This Ordinance shall be known as an "An Ordinance Establishing the Office for Senior Citizens Affairs (OSCA) in the municipality of Calubian, Leyte as Mandated under Republic Act No. 9994".

SECTION 2. DEFINITION OF TERMS/ACRONYMS. The following terms/Acronyms shall mean as follows whenever used in this Ordinance:

- (a) Senior Citizen or Elderly refers to any resident citizen of the Philippines at least sixty (60) years old;
- (b) OSCA Office for Seniors Citizens Affairs

SECTION 3. THE OFFICE FOR SENIOR CITIZENS AFFAIRS (OSCA). There shall be established an Office for Senior Citizens Affairs in the Municipality of Calubian, Leyte.

SECTION 4. OSCA HEAD AND TERM OF OFFICE. The Office for Senior Citizens Affairs shall be headed by a senior citizen who shall be appointed by the Mayor for a term of three (3) years without reappointment but without prejudice to an extension if exigency so requires. Said appointee shall be chosen from a list of three (3) nominees as recommended by a general assembly of senior citizens organizations in the municipality.

The Head of the OSCA shall be appointed to serve the interest of senior citizens and shall not be removed or replaced except for reasons of death or permanent disability or ineffective performance of his duties to the detriment of fellow senior citizens.

SECTION 5. HONORARIUM OF OSCA HEAD. Subject to availability of funds, the Head of the OSCA shall be entitled to receive an honorarium in an amount to be determined by the Office of the Municipal Mayor.

SECTION 6. SUPERVISION. The Head of the OSCA shall be assisted by the Municipal Social Welfare and Development Office, in coordination with the Social Welfare and Development Office.

The Office of the Mayor shall exercise supervision over the OSCA relative to their plans, activities and programs for senior citizens. The OSCA shall work together and establish linkages with accredited Civil Society Organizations (CSOs) and the barangays in their respective areas.

SECTION 7. FUNCTIONS. The OSCA shall have the following functions:

- (a) To plan, implement and monitor yearly work programs in pursuance of the objectives of this Act;
- (b) To draw up a list of available and required services which can be provided by the senior citizens;
- (c) To maintain and regularly update on a quarterly basis the list of senior citizens and to issue national individual identification cards, free of charge, which shall be valid anywhere in the country;
- (d) To serve as a general information and liaison center for senior citizens;
- (e) To monitor compliance of the provisions of Republic Act No. 9994 or the Expanded Senior Citizens Act of 2010 particularly the grant of special discounts and privileges to senior citizens;
- (f) To report to the mayor, any individual, establishments, business entity, institutions or agency found violating any provision of Republic Act No. 9994 or the Expanded Senior Citizens Act of 2010,' and
- (g) To assist the senior citizens in filing complaints or charges against any individual, establishments, business entity, institution, or agency refusing to comply with the privileges under Republic Act No. 9994 or the Expanded Senior Citizens Act of 2010 before the Department of Justice (DOJ), the Provincial Prosecutor's Office, the regional or the municipal trial court, or the municipal circuit trial court.

SECTION 8. REPEALING CLAUSE. All Ordinances or resolutions, local issuances or rules inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

SECTION 9. SEPARABILITY CLAUSE. If any provision of this Ordinance is declared invalid or unconstitutional, the remaining provision not affected thereby, shall continue to be in full force & effect.

SECTION 10. EFFECTIVITY CLAUSE. The Ordinance shall take effect immediately upon approval from the Honorable Sangguniang Panlalawigan of the Province of Leyte.
