BE IT ORDAINED by the Sangguniang Bayan of Inopacan, Leyte that;

SECTION 1. DEFINITION OF TERMS. As used in this Ordinance, the following terms shall mean:

- 1.1 Fee shall mean a payment made to the LGU in exchange for providing electricity and space;
- **1.2** Electricity shall mean a form of energy resulting from the existence of charged particles either statically or dynamically serve as current;
- 1.3 Rental shall mean an arrangement to pay an amount in exchange of providing LGU facility for a fee/tariff;
- 1.4 Recreational Facilities shall mean volleyball court and basketball court;

SECTION 2. SCOPE AND COVERAGE. This Ordinance shall cover all individuals willing to play basketball and volleyball games as well as using facilities of different occasions / or gatherings.

SECTION 3. IMPOSITION OF FEES. Persons who are willing to take part in any sports or use for different gatherings shall pay the following charges:

A. Electricity Fee

EVENTS	AMOUNT (PER HOUR)
1. Basketball	50.00 PHP
2. Volleyball	25.00 PHP
3. Others (birthday, wedding, rally, etc.)	100.00 PHP

B. Facility Rental

EVENTS	AMOUNT (without power)
Commercial displays/caravan sales/benefit dance/disco	500.00 PHP
2. Wedding/birthdays/anniversaries/reunions	300.00 PHP
3. Graduation/JS Prom/Acquaintance Party	300.00 PHP
4. Meetings	300.00 PHP
5. Religious/political rally	300.00 PHP

These gatherings exclude power consumption. Any activities that require electricity, recipients shall pay an additional charges as stipulated under Section 3.A of this Ordinance.

SECTION 4. Fees shall be paid to authorized agent assigned by the Municipal Treasurer's Office. Payment shall be made in accordance with the types of events. The Municipal Treasurer shall assign a collector in the premises.

SECTION 5. Penalties. The following penalties shall be imposed for non-payment of fees in Recreational facilities in violation of this Ordinance:

1 st Offense	Php 500.00
2 nd Offense	1,000.00
3 rd & succeeding Offense	1.500.00

SECTION 6. Compromised Penalty. The Municipal Treasurer is hereby authorized to enter into a compromise settlement as may be mutually agreed upon by both parties.

SECTION 7. REPEALING CLAUSE. All ordinances, resolutions, orders and/or rules and regulations inconsistent herewith are hereby repealed and modified accordingly.

SECTION 8. SEPARABILITY CLAUSE. If any section or provision of this Ordinance is declared void or unconstitutional, the remaining section or provision thereof shall not be affected by such declaration.

Section 9. EFFECTIVITY CLAUSE. This Ordinance shall take effect after its approval.

MINUTES OF THE PUBLIC HEARING OF THE PROPOSED MUNICIPAL ORDINANCE OF THE 15TH SANGGUNIANG BAYAN OF INOPACAN, LEYTE HELD ON AUGUST 12, 2024 AT THE SB SESSION HALL, NEW TOWN HALL, INOPACAN, LEYTE

PRESENT: (Please see attached Attendance Sheet, also attached are the lists of personalities invited)

The proposed Ordinance submitted for public hearing is entitled, "An Ordinance Imposing Fees in Recreational Facility Located at Reclamation Area in the Municipality of Inopacan, Province of Leyte".

The public hearing started at 2:30 in the afternoon with an opening prayer through computer audio and was immediately followed by the singing of the national anthem synchronized with the computer audio.


The Master of Ceremony (MC), Mr. Narcis Lean, SB Staff, after welcoming and thanked all the participants for their presence and taking part in the legislation process and mentioned the title of the proposed ordinance, acknowledged the Sangguniang Bayan Members present, namely: Honorable Andrew B. Dedal, Honorable Joel D. Bernales, Honorable Alfie Jian B. Yamson, Honorable Daria D. Malanguis, Honorable Diosdado P. Siao, Honorable Panfila I. Alonzo and Honorable Nathaniel Dave M. Katigbe. He as well acknowledged the Barangay Chairpersons and SK Chairpersons present, including those Barangay Kagawad representing its respective Punong Barangay, and the LGU Department Heads present. The MC encouraged everyone to raise their queries after the discussions of the proposed ordinance, and to introduce first before raising any question.

"An Ordinance Imposing Fees in Recreational Facility Located at Reclamation Area in the Municipality of Inopacan, Province of Leyte"

The MC gave the floor to the Author of the above-captioned Ordinance. Honorable Andrew B. Dedal, Author, as his introductory message, explained to all the participants that a public hearing is necessary since the proposed Ordinance involves fees and penalties. And by law, any collections of the same will be anchored to a legal basis, hence, the 15th Sangguniang Bayan has to enact an Ordinance for the purpose. Especially that it has been observed that the recreational facilities have serve its purpose and that the outcome/result is good, for the youth, among others. Considering the LGU's investment and to compensate with the maintaining expenses (electricity cost, among others), hence, this Ordinance is being proposed.

After confirming that each participant already had their copies of the proposed Ordinance, Honorable Dedal then discussed the entirety of the same, in details. Among others, in relation to Section 4, Honorable Dedal explained that the LGU is planning to install a *vendol*/vending machine for the payment of fees. He also presented the breakeven rates of both the basketball and volleyball courts, without the deductions yet of system loss, and the likes. As he also asked the rates of Brgy. Tinago Basketball Court, Honorable Alonzo replied that Php 100.00 per hour, considering the number of lights installed. Views and opinions were aired.

Honorable Dedal encouraged each participant to go through the copies provided and as he opens the floor the open forum to hear out the sentiments from the attendees, Honorable Lester D. Bisnar, SK Chairman of Brgy. Conalum, posed a query if the Ordinance is open for reservations. Honorable Dedal replied affirmatively.

Mr. Gilbert Miranda, the BPLO Designate raised his concerns about the switch control of the electricity. Honorable Dedal replied that currently, it is situated at the BFP building. However, the Mayor is planning to transfer the switch to Action Center which Mr. Miranda is in favor of it, so the Treasury Office would advise the incharge to switch on the electricity source upon agreed time, presenting the Official Receipt as the users' proof of payment, and for the in-charge as well to keep a record as to the end time of utilizing the facilities so they could monitor whenever an additional fee has to be paid (in cases of time usage extensions). Honorable Siao manifested that if ever the switch will be at the action center, there will be a tendency that the switch will be turned off after utilizing the paid hour and what if the game is not over yet (extended). Honorable Ramil M. Bague, Punong Barangay of Cabulisan, asked if an additional payment is required whenever the use of facilities exceed an hour, as paid. Honorable Dedal replied in affirmative. To this, Honorable Bague suggested to use the vendo machine. Views and opinions were aired.

Honorable Siao relayed the queries of some participants, if there would be exemptions whenever some barangays (having basketball tournament during fiesta) preferred to hold the same at the recreational facilities at the reclamation area, Honorable Dedal replied, no exemptions as tariff are presented in the proposed Ordinance.

As Honorable Yamson and Honorable Siao asked the participants if they are okay with the fees and penalties stipulated, there being no objections.

Since there being no other queries and questions, the public hearing ended at 3:07 in the afternoon, after the MC thanked all the participants for attending.
